Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to investigate the Administration of President Jovenel Moise(PHTK) and the current Kakistocracy operating as the government of Haiti; hold a National Conference/Referendum for a Cooperative-Union established by the people; establish a Haitian Constitution by the Haitian People and the election of a new government of the Republic of Haiti as per Operation Tabula-Rasa.

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are executing the mandate of said principle by demanding an end to the occupation and neo-colonization of the government of Haiti by WASHINGTON DC, UNITED STATES and the UNITED NATIONS thru CORE Group and BINUH. The Uni-Lateral Declaration on Behalf of Haiti dated October 17, 2018 exposed that WASHINGTON DISTRICT OF COLUMBIA is responsible for disenfranchising the People of the Republic of Haiti like they disenfranchised the descendants of the indigenous aboriginal American population which went thru chattel slavery (ADOS/FBA/"African-Americans") with the establishment of a gendarmerie in Haiti which they left in place after the 19-year US military occupation between 1915 and 1934. This US led Haitian gendarmerie, which answers directly to the US Secretary of State, is described as 'an army to fight the people' and was set up to replace the highly regarded Haitian National Army. Francois Duvalier (CIA) was trained by and emerged out of this gendarmerie to take power in Haiti and establish his regime once the occupation was over. Washington DC has dominated Haiti since this occupation via kakistocracies which work to undermine the sovereign independence of the Republic of Haiti on behalf of foreign interests. The UNITED STATES has also claimed all of Haiti's Natural Resources, which

are declared as strategic reserves of the United States of America, for itself thus relegating/delegating the Republic of Haiti as a resource colony of the UNITED STATES. **These Colorable Actions by the Ens Legis UNITED STATES in the Republic of Haiti are in violation of the Geneva Convention, Magne Carta, the Nuremberg Charter, International Law, The UN Declaration on the Rights of Indigenous Peoples, The UN Declaration of the Rights of the Child, the UN Universal Declaration of Human Rights, Tort Law, Gross Negligence. Haiti is a founding member of the United Nations; for every right there is a remedy, where there is no remedy, there is no right. The nature of Reparations to be made for the breach of UNSCR 940; UNSCR 1542; UNSCR 1892 and international obligations are in conformity with Article 36(2) of the Statute of the International Court of Justice.**

The patten of destabilization and sabotage of the Haitian government by the Clintons have been exposed over time thru their coercive destructive policies from the 1996 Farm Bill which destroyed Haiti's rice farming to the 1.3 million pigs killed due to exploitative policies of USAID (plus the deforestation of Haiti). But the full exploitative nature of their relationship with Haiti wasn't exposed until Hillary Clinton was made Secretary of State during the administration of President Barrack Obama. As a Smedley Butler US Marine and member of the Indigenous Army of Haiti I refuse to sit by and watch the genocide of my people. My investigation into the January 12th 2010 Haitian earthquake and disparity of 100,000 deaths reported by the US State Dept and 300,000 by the Republic of Haiti and the missing Interim Haiti Recovery Commission (IHRC) funds totaling 15 billion in relief aid resulted in a Uni-Lateral Declaration on Behalf of Haiti which exposed among other things:

#The United Nations Security Council Resolution 1892 issued on 13 October 2009 which made William J. Clinton UN Special Envoy to Haiti 6 months before the Haitian earthquake and Executor of the IHRC Funds. How did the United Nations know that the Republic of Haiti would need a Special Envoy for a major catastrophe 6 months before it happened?

#U.S. Southern Command SOUTHCOM was "coincidentally" in Haiti on January 11 2010 running Complex Command and Control Emergency Relief Drills, (one day before 7.0 Earthquake). DynCorp Int., which is part of the clandestine operating division of the CIA, was coordinating the efforts of SOUTHCOMM on these Relief Drills. On Monday, Jean Demay, Defense Information Systems Agency (DISA) technical manager for the agency's Transnational Information Sharing Cooperation Project (TISCP), happened to be at the headquarters of the U.S. Southern Command in Miami preparing for a test of the system in a scenario that involved providing relief to Haiti in the wake of a hurricane

#What's interesting this catastrophe and its' aftermath which happened to the First "Black" independent Republic within the Americas occurred under the watch of the first "black" US President Barack Obama who would go on to hold a press conference flanked

by former US presidents George Bush and Bill Clinton in which all types of promises were made and people across the world were told to send money in order to aid and rebuild Haiti. Due to the prestige of Haiti's now infamous revolution and the dire straits it's been held in since they collected record amounts of aid.

#On January 15 the UN Secretary General Ban Ki-Moon and Bill Clinton, the UN special envoy to Haiti, launched an appeal at a meeting with diplomats in New York for nearly \$1.5 billion in earthquake relief which was almost three times the world body's initial request, that never made it to Haiti.

#According to the U.S. State Department the IHRC is co-chaired by the Government of Haiti and the UN Special Envoy to Haiti but the Haitian Parliament was coerced and forced into voting to dissolve itself by the Clintons in order to make way for the IHRC. The Interim Haiti Recovery Commission (I.H.R.C.) was set up by UN Special Envoy William J Clinton in the aftermath of the Haitian Earthquake of January 12, 2010.

#The IHRC ended up operating as a pay to play unelected government, where political participation was based on money. According to Haiti Wiki-Leaks email of government messages a senior aide to Secretary of State Hillary Clinton was coordinating with a Clinton Foundation official to identify FOB's (Friends of Bill) in order to prioritize them for contracts in Haiti with the IHRC. This isn't the first time the Clintons have prioritized (Friends of Bill) in pay to play politics. During his tenure as Governor of Arkansas William J Clinton was implicated in a money laundering scheme associated with the Iran/Contra scandal. Arkansas legislators voted on a Bill creating the Arkansas Development Finance Authority (ADFA) to provide low interest bond loans to churches, schools and colleges. Instead ADFA, represented by the Rose Law Firm where Hillary Clinton worked as a lawyer and lobbyist, made low interest bond loans strictly to (Friends of Bill). The ADFA was at the center of financial dealings in which large amounts of money could be moved around easily and discreetly with no detection.

#William J. Clinton, the UN special envoy to Haiti stated to members of the Haitian government that they couldn't prosecute him for the misappropriated Relief Funds due to diplomatic unity. Diplomats are immune except in circumstances when in connection with any role they may play as executor or heir to an estate being distributed in the host country. Only sovereign nations can grant diplomatic immunity, as UN Special Envoy and Executor of the IHRC diplomatic immunity doesn't protect him from being prosecuted for the funds not distributed during Haiti Relief efforts. It is the duty of the UN, who made William J. Clinton special envoy to prosecute and return these misappropriated funds to the republic of Haiti. Diplomatic immunity is not intended to serve as a license for persons to flout the law; the UN must not ignore or condone the commission of crimes which violate International Law

#The United Nations falsely claims that 12.34 billion of the misappropriated IHRC funds has been earmarked for post-earthquake reconstruction thru 2020 and as of 2015 the US has allocated 4 billion and claims 3 billion has been spent in Haiti and the rest is

dedicated to longer term projects when the Republic of Haiti was supposed to receive those funds in 2010.

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to investigate and replace the current Kakistocracy operating within the government of Haiti. The Kakistocracy currently in place within the Haitian government operates on a three-tier system with the US/UN at the top, right below them is criminal Arab-Jew Levantine Class who are actually US citizens and operate as local subsidiaries of a foreign power, and the Haitian gendarmerie/Duvalierists/oligarchial class on the bottom. This Haitian gendarmerie, the US/UN, and the foreign criminal Arab-Jew Levantine Class are committing a slow genocide of the Haitian People and work in tandem in order to keep the People of the Republic of Haiti disenfranchised thru transitional governments and steal Haiti's Natural Resources. The Ens Legis WASHINGTON DC does the same thing to disenfranchise ADOS/FBA communities which are dominated by subsidized foreign owned businesses therefore The HAITI REFORMATION PROJECT demands an end to all their colorable activities within the Republic of Haiti until the arrival of the Independent Haiti Reconstruction Commission (IHRC):

The election of the administration of President Trump not only startled the status quo in WASHINGTON DC but it also made the oligarchical Arab-Jews class in Haiti uneasy. The Arab-Jew class of Haiti had a sweet life under the Obama Administration, but they knew President Donald J. Trump "sees things differently" due to the anti-war, anti-imperialism, anti-pedophilia, and anti-middle eastern terrorist stance of his administration. Since 2015, the Republic of Haiti has been on the US/UN list of states that finance international terrorists due to the activities of their criminal Arab-Jew oligarchical class. In an article by Kerlens Tilus, July 1 2017 titled "Les Nantis d'Haiti Sont Sur la Sellette"; "the Bigio Group makes over 700 million each year in Haiti; according to the IRS, the acting arm of the of the US Treasury Dept. that collects taxes, the Bigio Group made 1.3 billion in sales in 2010; because they're all American citizens the US government decided to investigate all Arabs and Jews residing in Haiti and the accused of tax evasion. Because they haven't been paying the difference of their US tax claims to the Haitian government, they owe more than 4 billion to the US tax authorities. A study by the Inter-American Development Bank and the CIA published in February 2013, showed that if the wealthy Arabs-Jew class really paid taxes in Haiti, the Republic of Haiti would have \$4 billion to invest in its budget; But when we calculate the remittances of this Arab-Jew class in big capitals of the world and the middle east, we realize that they transfer more than 3 billion dollars. The New York Times and the Washington Post has indexed them of "MRE" Most Repugnant Elite". What's interesting is that President Trump fully assisted Israel (which

is a settler colonial state) during his administration but failed to prosecute the Clintons or the criminal Arab-Jew class exploiting Haiti.

The US, UN, CORE Group, BINUH are at the top of the corporate mafia state in Haiti; right below them in this pyramid is the Arab-Jew class the US established in Haiti as a buffer class and empowered during the Duvalier regime. WASHINGTON DC began funding and utilizing these assets in the Middle East to counter Russia; as proxy "terrorists" in the "War on Terror"; then for Color Revolutions like Libya and the Arab Spring. In an article by Kerlens Tilus, July 1 2017 titled "Les Nantis d'Haiti Sont Sur la Sellette; "The vast majority of Arabs in Haiti are Syrian and Lebanese; We find some Palestinian families and some Jews who are also Arabs like the Bigio family and the Kedar family. They entered Haiti as a result of a war in which Westerners invaded the Sellette, "region of the Near East", prompting the Levantines to set sail between 1880 and 1920 by France, under the name of Great Lebanon. The French imposed their mandate in Syria also in 1920. Many Syrians and Lebanese took refuge in the US where they were naturalized and a good amount sent to Haiti because the US wanted to reduce "European influence in Haiti". In 1937 Haiti was responsible for saving 70 Jewish families, about 300 lives, during the Holocaust by issuing passports and visas to Jews escaping Nazi persecution; the two groups overlap due to the presence of Levantine Jews in Haiti (Boulos, Acra, Gebara, Apaid, Khawly) and established a foothold thru mercantilism on credit. The Bigio family entered Haiti in 1925 and in 60 years this Arab Jewish family eventually imposed its dominion over the whole country. According to scholar Michel Rolph-Trouillot; Haiti's economy had long been dominated by foreigners (mostly French and German) but after the US 1915 invasion and occupation, the US, particularly through earlier Syrian intermediaries, became the clear hegemonic force. For example, according to Haitian historian Charles Dupuy: President Elie Lescot was a mulatto whose administration consisted of and favored mulattoes and whites. Levantines were placed at the head of the new organizations created for the distribution of strategic products, especially, Syro-Lebanese, to whom, by his decree of Jan 11 1943, he opened the retail trade in Haiti: Levantine families Bouez, Silvera, Abitbol and Baboun made fortunes under his presidency.

The Haitian ruling class helped to facilitate this international dismantling of Haitian sovereignty during the Duvalier regime. President Francois Duvalier was a CIA asset who targeted the wealthy mulatto class of Haiti during his administration, destroying and forcing them to flee the country in order to replace them with this Arab-Jew Levantine class. Under President Francois Duvalier the wealthy Arab-Jew class officially entered politics when he founded the Haitiano-Arabe Club in 1960 and signed an esoteric pact with this class as straw men to do trade for the Duvalierists. This is when the wealthy Arab-Jew class began to have a certain hold in Haiti as they began to launder money to hide illicit activities for the Duvalier regime. The Arab-Jew class have always had the unconditional support of the US in Haiti, especially under the administration of Ronald Reagan so this backfired when they conspired against Jean Claude "Baby Doc" Duvalier thru a coup d'état and had him removed in order to avoid paying the millions of dollars they owed the Duvalier regime. Ever since then these gentlemen have been involved in and control illicit

activities from drug trafficking, arms trafficking, organ trafficking, money laundering to smuggling. They also align with the US government to overthrow any competent Haitian government which doesn't serve them. For instance, they participated in both coups against the duly elected government of President Jean Bertrand Aristede. The Arab-Jew class is used by WASHINGTON DC as a buffer class to disenfranchise the people of the Republic of Haiti the same way the US keeps black communities disenfranchised by subsidizing foreign owned businesses in their communities also.

During the administration of President Trump this Arab-Jew Mafia should have been arrested for tax evasion and narcotics trafficking besides other illicit activities like Rodolphe Jaar, Marc Antoine Accra, Clifford Brandt because they pose a terroristic threat to the U.S. The Arab-Jew oligarchical class in Haiti are American citizens according to the agreement that was signed between their ancestors and the American establishment. They're no more than US citizens who operate as local subsidiaries of a foreign power which is why the IRS is going after them for tax evasion. The entire Haitian government is in the hands of this foreign oligarchy whom control the system such as: Gilbert Bigio, Fritz Mevs, Marc and Antoine Accra, Reginald Boulos, Brandt family, Braun family, Apaid family, Deeb brothers. Haiti is an economic dictatorship controlled by this small group of Arab-Jew elite whom own all sea ports warehouse, big businesses, control 80-90% of wealth in country; live in gated homes and drive armored cars while 80% of Haitians live in poverty. In an article by Kerlens Tilus, July 1 2017 titled "Les Nantis d'Haiti Sont Sur la Sellette"; "I have a list of well-known MPs and senators, politicians and intellectuals who receive their salary each month from the hands of Arabs and Jews"; "This is how Haitian society works. Arabs and Jews commission middle-class intellectuals to organize civil society that works to the detriment of the national majority."; "Arabs and Jews are at the top of the pyramid are commissioned by the International Community, especially Americans to keep the country in dirt. Arabs and Jews in turn hired middle-class intellectuals and corrupt business-like politicians, and gave them a mission to subdue the people. Middle class politicians and intellectuals recruit bandits and militants at the level of the people to play macoutes-lavalas-tet kale-G-9". This is the reason for the constant insecurity in Haiti such as kidnapping and guns; a former "bandit" Arnel Joseph implicated Gracia Delva, Youri Latortue, and Reginald Boulos in a kidnapping and gun trafficking scandal in which they paid him to create insecurity. **As National Agent of the Republic of Haiti I call for a suspension of all government activities until the arrival of the LaFortune Haiti Reconstruction Commission to execute the mandate of the Haitian Diaspora and investigate the Arab-Jew class and private sector for tax evasion and illicit activities against the people.**

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to investigate and replace the current Kakistocracy

operating within the government of Haiti. The government of the Republic of Haiti has been illegitimate and in crisis ever since the Aftermath of the January 12, 2010 Earthquake when the transitional government of the Interim Haiti Recovery Commission (IHRC) positioned Michel Martelly for a legislative coup de tat after their 18-month lease of the Haitian government. Haiti Wiki-leaks exposed that Michel Martelly lost yet was still inserted into second round of run-off elections by WASHINGTON DC, CANADA, and OAS. His successor President Jovenel Moïse was put in power in 2016 by ex-president Michel Martelly (who ruled by decree) thru the Tet Kale political party (PHTK) via a fraudulent election which were endorsed by WASHINGTON DC and the UN. The HAITI REFORMATION PROJECT demands a suspension of all governmental activities of former President Jovenel Moïse whose mandate and administration terminated on February 7, 2021 until a transfer of power to the Independent Haiti Reconstruction Commission (IHRC) in order to execute the mandate of said principle the Republic of Haiti and Haitian Diaspora.

Right below the criminal Arab-Jew oligarchical class in the pyramid structure is the Haitian government which they've been in control of since the Duvalier regime and operates as a kakistocracy thru its politicians aka mob bosses in which 60 Haitians are assigned to each senator. **Jovenel Moïse was indicted for money laundering just days before he took the Oath as President of Haiti. He shouldn't have even been eligible to run for office due to this, yet he was granted immunity for 5 years and allowed to take office by the US Justice Department. The Haitian government and people paid for this election yet there was still massive fraud, and they had an unwanted candidate forced down their throats. President Moïse received 595,000 votes just 9.6 percent of registered Haitian voters in the 2016 election and a reliable Brazilian exit poll suggests that he didn't even win, coming in fourth, not first, with a low turnout of just 6 percent of the vote, yet it was reported he won with 90% of vote in the November 20, 2016 elections.** The Haitian parliament has been out of session since January 2020 because once their term expired the administration of President Jovenel Moïse failed to organize new elections. The government of President Moïse has been ruling by decree ever since and pushing to extend his term by a year to February 7, 2022. He is attempting to illegally rewrite the Haitian Constitution and has appointed former Supreme Court Justice Boniface Alexandre as head of this unconstitutional rewrite. What's interesting is Boniface Alexandre is a former transitional "President" who was appointed by WASHINGTON DC, FRANCE, AND CANADA (CORE Group) after their coup d'état of the government of Jean-Bertrand Aristide in 2004. He has also appointed Leon Charles as head of police who is a former military man who oversaw the police during the 17-month transitional government of Boniface Alexandre and has publicly referred to the "war" his police waged on Fanmi-Lavalas supporters on behalf of WASHINGTON DC/CORE Group. President Moïse has also and created a National Intelligence Agency that operates a la the Ton Fahmi Macoutes or Service d'Intelligence National created by the CIA after the fall of Duvalier regime. With a defunct parliamentary, President Jovenel Moïse is violating International Law by attempting to illegally extend his illegitimate 5-year mandate which is up on February 7th

2021 to February 7th, 2022. The Moise administration and UN backed G-9 have been implicated in the La Saline scandal where at least 71 people were murdered and death of Met Dorval besides other atrocities.

Washington DC/UN (CORE Group/BINUH) are pushing for this Kakistocracy operating as the government of Haiti in which several Haitian politicians have been implicated in kidnapping, gun trafficking, drug trafficking, the IHRC and Petrocaribe scandals to hold elections. **The “Opposition” to President Moise can’t just appoint a new “President” of Haiti without holding fair elections and must cease and desist until the arrival of the Independent Haiti Reconstruction Commission because neither side is working to fulfill the mandate of the Haitian people per Operation Tabula-Rasa.** The colorable activities of "the Opposition" in Haiti are funded by WASHINGTON DC, the Arab-Jew Mafia Elite, and corrupt politicians of the government of Haiti whom have been exposed for utilizing transitional governments to profit off of the genocide of the Haitian people. Haiti has had 8 provisional governments since departure of the Duvalier regime all funded by the Arab-Jew Mafia elite whom align with the US government to form a sort of economic dictatorship. In Haiti, this “civil society opposition” is bankrolled by the National Endowment for Democracy (NED) which works hand in glove with the CIA. This Democratic Platform is supported by the International Republican Institute (IRI), which is an arm of the National Endowment for Democracy (NED). The same Civic Organizations and political parties which form the Opposition to the government of Jovenel Moise are funded by the IRI and USAID and have been exposed for treason by working to undermine/destabilize the government of Haiti on behalf of foreign organizations during the administration of President Aristede. UNSCR 1542 exposed the fact that Washington D.C. supported the coup d’état of President Aristede thru Civil Society Organizations such as "Democratic Convergence" (DC) and the "Coalition of 184 Civic Institutions" funded by USAID and/or the International Republican Institute (IRI) which is the neo-colonial model used to destabilize governments whom refuse to adopt their neo- liberal policies. On 26 November the Haitian government proceeded with their 2000 presidential elections at the objections of the OAS over discrepancies of the May 21 elections. The opposition used the OAS discrepancy to justify boycotting the November 2000 presidential elections which they had little chance of winning. The fact that the OAS monitored yet refused to ratify parliamentary elections due to overwhelming victories by the Fanmi-Lavalas party. The US funded political civic organizations, the main opposition to President Aristede and the Fanmi-Lavalas party, utilized OAS resolutions 806 and 822 to cutoff any aide of the international community to Haiti from 2000-2004 valued at more than \$200 million dollars. These actions were supported by UN Secretary General Kofi Annan and Secretary General of the OAS Cesar Gaviria.

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT

are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to commence an investigation and prosecution for the misappropriation of IHRC and Petrocaribe funds. On May 31, 2019 Haiti's Superior Court of Auditors and Administrative Disputes published an audit of Petrocaribe which revealed that President Jovenel Moïse was endorsed by the Core Group and put in position as a successful businessman via fraudulent elections. It also revealed that ex-President Michel Martelly, during his administration, gave 27 million of Petrocaribe funds and a land grant of 1,000 acres to Jovenel Moise for Agritrans S.A.,. This audit exposed the government of Michel Marty for misappropriating a significant portion of the Petrocaribe funds with a total of 4.5 billion dollars missing from the program with no social programs established for the people. Between the IHRC and Petrocaribe scandals the Kakistocracy operating as the government of Haiti is complicit in embezzling well over 50 billion dollars in one of the poorest nations of the American hemisphere. The Independent Haiti Reconstruction Commission also requests the assistance of Venezuela and the administration of President Nicolas Maduro in the investigation of Petrocaribe and reconstruction of the Republic of Haiti.

Due to the embezzlement of the 14 billion in Haiti earthquake relief funds by the IHRC thru the Clinton Foundation; Petrocaribe became the most significant direct source of aide for Haiti which somewhat helped the nation recover from the "natural" disaster even though most of that money was embezzled by thru the government. More than 90% of the government of Haiti's budget came from the Petrocaribe agreement with Venezuela! Petrocaribe was a program created in 2004 under the sponsorship of Venezuelan President Hugo Chavez as part of his socialist Bolivarian Revolution. It allowed Haiti to fund social projects for the poor and control pump prices. The Petrocaribe program doubled Haiti's budget and the amount of funds available for social investments. Before the program the Haitian government's primary source of income were billions in remittances from the diaspora and \$325 million [USD] per year brought in thru tax revenues. The fact is Washington D.C. was so opposed to Haiti participating in the Petrocaribe program that President Rene Preval had to join in secret on August of 2007. A major factor which played into Washington DC's stance against Haiti participating in the Petrocaribe program was due to their oil conglomerates profiting off of supplying Haiti with oil. Hugo Chavez actively courted President Rene Preval to join the Petrocaribe program. In the case of Haiti, he often said of Petrocaribe and other aide given "It wasn't Haiti that had a debt with Venezuela, but just the opposite Venezuela had a debt with that nation". The debt he's referring to is the Bolivarian Revolution and the little-known fact that Haiti participated in the Spanish Wars for Independence which liberated South America from Spain. Petrocaribe was an act of international solidarity by Hugo Chavez who visited Haiti when it was implemented in 2007. The Petrocaribe program was barely operational for two years, when Haiti received its' own version of 9/11, and was hit with a 7.0 Earthquake on January 12, 2010 which killed over 300,000 people and left 1.5 million homeless. After helping him gain independence Simon Bolivar abolished slavery but refused to establish

diplomatic relations with Haiti on becoming of Greater Colombia; claiming that Haiti was "fomenting racial conflict". Since its' independence Haiti has helped liberate many nations but never had any true allies in its fight against imperialism.

Petrocaribe is a Social Revolutionary Program created by Hugo Chavez as part of the ALBA in order to break the shackles of imperialism which Washington DC has placed on the Americas during the post-colonial era. It doubled Haiti's budget and the amount of funds available for social investments and also allowed Haiti to fund social projects for the poor and control pump prices. The ALBA also began developing a plan of aide for Haiti and as it turns out, most of the financial support to help Haiti rebuild at this time came from the Petrocaribe program. The Bolivarian Alliance for the Americas (ALBA) was founded in 2004 by the Chavez administration as an alternative to the Free Trade Agreements being offered in the Americas by Washington D.C. It's an intergovernmental organization designed for the social, political, and economic integration of Latin America and the Caribbean. The ALBA created Telesur and the Petrocaribe program in 2005. According to Petroleos de Venezuela S.A. (PDVSA) official Rafael Ramirez the Petrocaribe program was designed to cut out the middleman "we're not talking about discounts; we're talking about financial facilities and direct deliveries of products, and infrastructure to the people". A report by the World Bank on itself in Haiti revealed "the outcome of the World Bank assistance program is rated unsatisfactory {if not highly so}, the institutional development impact, negligible, and the sustain of the few benefits that have accrued, unlikely." Once President Hugo Chavez withdrew Venezuela from the exploitative policies of the World Bank and IMF, the Bolivarian Alliance for the Americas established the ALBA Bank in 2008 with 1 billion in capital to serve as an alternative to the World Bank and IMF but without the debilitating loan conditions. The ALBA Bank also provides financial support for social projects, energy cooperatives, industrial and agricultural products. These social revolution programs were implemented by Chavez to make up for the failings of the Bolivarian Revolution which he viewed as incomplete and ongoing. During his presidential campaign Trump used Haiti as a talking point to attack Hillary Clinton but once elected the Trump administration-imposed sanctions on Venezuela limiting bank transactions and as a result making it difficult for the Bank of Haiti to make payments and the Petrocaribe program stopped in October 2017. President Moise also conspired with the administration of President Trump to discredit the administration of Venezuelan President Nicolas Maduro with the Lima Group by recognizing Juan Guaido as de facto President. **The exposure of the connection between the administrations of Michel Martelly/Jovenel Moise and the CORE Group for their exploitative/illegal use and misappropriation of Petrocaribe funds is a violation of the sovereignty of the Haitian People.**

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT

are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to establish a new Constitution by the Haitian people as per Operation Tabula-Rasa because the 1987 Constitution was never fully enforced.

The Ottawa Initiative on Haiti was a conference hosted by Canada that took place on January 31 to February 1 2003, at Meech Lake, Quebec (a federal government resort near Ottawa) to decide the future of Haiti's government, though no Haitian government officials were invited. The conference was attended by Canadian, French, U.S. and Latin American officials (CORE Group). This is apropos to the Berlin Conference of 1881 where European nations gathered in order to carve the wealth of Africa up for themselves. One of the most enthusiastically supported provisions of Haiti's newly adopted 1987 Constitution banned members of the former Duvalier regime from running for public office for 10 years. Article 291 of the 1987 Constitution, known as the Duvalier clause, provided that until 1997 the Electoral Council shall not certify any candidate who is "well known for having been by his excess zeal one of the architects of the dictatorship and of its maintenance," or who is "denounced by public outcry for having inflicted torture on political prisoners in connection with arrests and investigations or for having committed political assassination." Immediately after its adoption, the Constitution was suspended for 3 years amidst political instability as WASHINGTON DC and its international allies worked to undermine it. The Haitian government has been purposefully kept from properly functioning under it since its' ratification on November 29 1987 because this Constitution returns sovereignty back to the Republic of Haiti and retains its' Natural Resources for the people under a Cooperative-Union. Article 291 was never able to be fully enforced due to US funded efforts by members of the former Duvalier regime to keep the country destabilized as they were placed in positions of government before this mandate was up. Under the Ottawa Initiative, WASHINGTON DC, CANADA, and FRANCE (CORE Group) have been amending the 1987 Constitution of Haiti in order to steal the Natural Resources of Haiti. Due to the power granted to me as Attorney in Fact/Relative and Representative named herein by said principle the Diaspora of The Republic of Haiti, The Haiti Reconstruction Commission will address this Constitutional Crisis by forming a participatory committee of the Haitian People to create a Constitution thru National Referendum.

ARTICLE 36-5 of the Haitian Constitution, states: "The right to own property does not extend to the coasts, springs, rivers, water courses, mines and quarries. They are part of the State's public domain.", the current structure of Haiti's political system was set forth in the Constitution of Haiti on 29 March 1987

In 1970 Francois (Papa Doc) Duvalier, Haiti's President agreed to lease much of the island of La Tortue to a Texas businessman named Don Pierson. The contract gave Don Pierson's company a 99-year lease and specified it would develop the islands infrastructure for tourism. The project never got off the ground but came to light again when Carnival

Corporation signed a memorandum of understanding with Haiti for the same land which fell thru because due to this prior lease the ground wasn't the governments' to offer.

#Labadee is a port located on the northern coast Haiti which has been turned into a private resort leased to Royal Caribbean Cruises LTD for the exclusive use of passengers of its 3 cruise lines, until 2050, which is guarded by private security forces and fenced off from surrounding areas. During his presidency, Martelly attempted to sell the offshore island of La Gonaives to foreign capital in order to transform it into a tax haven for white collar criminals; and Ile-a-Vache aimed at turning it into a tourist destination. The Haitian government has no right to sell the sovereign land of the Republic of Haiti without the awareness of the people because it's owned by them under a cooperative union.

Article 36-5 of the 1987 Haitian Constitution, which protects Haiti from foreign mining companies, is being re-written in order to steal Natural Resources of Haiti. It seems all of the gold wasn't found in Haiti during Christopher Columbus time. The prospected value of Haiti's gold deposits is 40 billion dollars.

In May 2013, Alexandre Abrantes, the World Bank special envoy to Haiti announced that the "World Bank is supporting the Haitian government in improving the frameworks for mining, including legal provisions which are largely considered inadequate for current requirements," Daniel Trenton, (World Bank says it's helping Haiti draft mining legislation, The Gazette, May 17, 2013). Moreover, many also speculate that the state lands currently leased to foreigners could eventually be turned over to foreign mining interests to continue their now-stalled exploration in northern Haiti. Oxfam, the World Bank and the other fake philanthropic folks are involved in protecting the interests of the US and Haitian Duvalierists, that's why they want to re-write Haitian mining laws.

Haiti happens to be sitting on wealth of resources due to the shifting fault lines it is placed on produces oil and connects with Venezuela's oil which ends at the tip of Haiti's oil. Haiti's oil deposits are declared strategic reserves of the United States of America relegating Haiti as a resource colony the same way Europe does Africa for strategic resources which; is a violation Haitian sovereignty; International Law; and illegal because under the 1987 Constitution Haiti is a Cooperative Nation. The truth of the matter is Haiti's carbon black oil deposits are now worth \$120 billion US dollars. That makes the country of Haiti among the ONE percent wealthiest nations on earth with its oil resources. Haiti wants to work with Venezuela in order to make use of these carbon black deposits. Their prospected value of their gold deposits is 80 billion, Haiti also has vast untapped deposits of iridium (a little known and rare mineral that is vital for the construction of spacecraft and satellites), and these estimates don't include other mineral resources such as (copper, uranium, diamond, zirconium deposits). Ever since the UN development program discovered these resources in the 1970's, Washington DC has been covertly mining Haiti's iridium for its space program. Haiti's 1987 Constitution protects its Natural Resources as part of its public domain. Since the 1987 Constitution Haiti's Natural Resources have become part of its public domain. Haiti is a cooperative Nation therefore all of Haitian people own

these resources that is why The US government is killing as many Fanmi-Lavalas members as possible.

The grass roots organizations in Haiti have begun working on a new constitution for the Haitian people but the Kakistocracy currently in place in Haiti only wants a constitution which benefits the elite and foreigners. The foreign and elite class of Haiti paid 20 million dollars to put in a clause which absolves them of responsibility of the missing IHRC and Petrocaribe funds. This foreign Arab-Jewish class refuses to allow the Haitian diaspora from participating in the development of Haiti and is trying to bar the Haitian diaspora from having any rights and excluding them from the constitution.

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to investigate Sex Trafficking in the Republic of Haiti.

Haiti Wiki Leaks continued to expose the corruption of the Haitian government when they revealed evidence of sex trafficking in Haiti during the IHRC. NYPD Chief of Detectives, Robert Boyce, said that the Clinton emails contained evidence of sex crimes, child exploitation, money laundering, pay to play, etc. in Haiti. The IHRC was connected to child sex trafficking in Haiti on January 29, 2010 when Laura Silsby was caught and arrested for trying to kidnap 33 kids in Haiti. Silsby is the former director of "The New Life Children's Refuge" and the leader of a group of 10 U.S. Baptist missionaries who attempted to transport Haitian children without that government's approval, out of the earthquake ravaged nation. On November 13, 2016 Monica Peterson was found dead in Haiti under suspicious conditions. Oddly enough on November 14th, the Laboratory to combat Human Trafficking reported that Monica Peterson, investigating the Clinton's involvement in Haiti for the Human Trafficking Center mysteriously died the day before. She was working with her mentor Claude D'Estree, the executive director of the Human Trafficking Center at the University of Denver on her 100-page Master Thesis when she died by suicide from hanging in Haiti. She had just begun investigating the correlation regarding the Clinton Foundation's Caracol Industrial Park Complex and its connection to a Human Trafficking network when her life was cut short. Monica Peterson's Master Thesis predicated that the sweat shops in Caracol Industrial Park were being turned into sex shops thru a program for women to earn extra money by providing sex to construction workers for bonus pay (1000 beds Ekam housing). Due to the power granted to me as Agent in Fact of the Diaspora of the Republic of Haiti, the Haiti Reconstruction Commission is establishing a Human Rights division to investigate sex trafficking in Haiti and other atrocities committed by the Washington DC/UN against the Haitian people during their 26-year occupation by MINUSTUH.

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to investigate the Kakistocracy operating as the government of Haiti for involvement in Drug Trafficking.

While addressing the UN during his exile after the first coup d'état against him in 1991, in a dramatic move, President Aristide told the diplomats that the military Junta of Lt. General Cedras had to yield the power that was to end Haiti's role in the drug trade. The worst kept secret in the Marine Corps is that the US government is involved in the drug trade and uses the military as a cover for shipping and transporting drugs. Even at their Haiti transshipment point the, US blatantly uses Navy ships to transport their trade. Uni-lateral Declaration on Behalf of Haiti reveals that US has been using Haiti as a drug transshipment point. The "War on Drugs" waged on black communities from the mid 80's to late 90's is a diabolical yet genius scheme by Washington DC. The US government used the War on Drugs to criminalize "African American" community in the same way they use politics to criminalize the whole Fanmi Lavalas Party in Haiti by calling them bandits and thug. The genius of the War on Drugs is that it utilized the crack epidemic to criminalize and destroy black communities while Washington DC is the one distributing and profiting off of it globally. It was also a form of social control to keep African Americans from fighting their oppression under the US government; as addiction caused families to become dysfunctional and countless crack babies were produced. Washington DC also profits off of the incarceration of these black communities thru the War on Drugs. The US court system is connected to the cusip system which is attached to the stock market and US citizens are traded like stocks once they're arrested. Moreover, the expansion of the dollar denominated money supply by the Federal Reserve System, including the printing of billions of dollars of US dollar notes for the purposes of narco-transactions constitutes profit for the Federal Reserve and its constituent private banking institutions of which the most important is the New York Federal Reserve Bank. See (Jeffrey Steinberg, Dope, Inc. Is \$600 Billion and Growing, Executive Intelligence Review, 14 Dec 2001) Drug money is also invested in a number of financial instruments including hedge funds and stock market transactions. The major Wall Street and European banks and stock brokerage firms launder billions of dollars resulting from the trade in narcotics (Kerry Report).

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction

Commission (IHRC) in order to establish a new co-operative economic system within the Republic of Haiti.

#The administration of President Woodrow Wilson is known for dooming two nations during his administration; Americans with the Federal Reserve Act which established the Federal Reserve System, a central banking system in WASHINGTON DC privately owned by the international bankers (foreign interests); and the 1915 invasion of Haiti which allowed the international bankers to takeover Haiti also.

#Washington DC stole all of the gold from Haiti's Bank like the Freedmans Bank (Haiti's gold became Citibank), took over the Haitian economy, rewrote the Haitian Constitution, opened up land to foreign interests, and instituted Jim Crow policies which left Haiti in a state of arrested development we see today.

#investigate the misappropriation of Haitian remittance by the government which is approximately 4 million a year; remittances are the primary source of foreign exchange, equaling one-fifth (20%) of GDP but none of it is used in social programs for the people and goes into the pockets of the mafia government.

#The Republic of Haiti is a Cooperative-Union therefore the Independent Haiti Reconstruction Commission will work to establish a national cooperative banking system for the people and NESARA/GESARA system in Haiti.

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are demanding a suspension of all governmental activities until the execution of the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to establish a National Conference of the people for a National Referendum to address among other things:

#establish the Republic of Haiti as a Cooperative-Union, a participatory government in which the people own and control the budget of the government.

#Nationalize and Reorganize the Haitian National Military/Police in order to protect and develop The Republic of Haiti.

#address the forced migration of Haitians to South America, Caribbean Islands, Canada, UNITED STATES, Dominican Republic, etc. by the Haitian Mafia government and call for repatriation of Haitian diaspora.

#address policies of US which have made Haiti food insecure and dependent of food aid controlled by US.

Once this new system and government have been instituted in the Republic of Haiti and national elections held; as Attorney-In-Fact; National Agent of Haiti and chairman of the Independent Haiti Reconstruction Commission I will not run for any political office once our mission is complete and will turn over the new system of governance to the Haitian people.

Due to the power granted to me as Attorney-In-Fact, National Agent and Representative by said principle The Republic of Haiti and Haitian Diaspora, I, Marc Pierre and The HAITI REFORMATION PROJECT are executing the mandate of said principle with the formation of the Independent Haiti Reconstruction Commission (IHRC) in order to begin a study of reparations:

It seems the straw that broke the camel's back of the administration of President Jean B. Aristede was when he demanded reparations from France who along with US used their military to enforce payment of reparations for Haitian independence to the tune of 150 million francs or roughly 20 billion dollars today. What's ironic is that it was the Haitian Revolution and Independence of 1804 which stopped Napoleon's invasion of the American colonies and the Louisiana Purchase 80 million francs (500 million) which doubled the size of the American colonies. France's claim for indemnity was for all the slaves they lost, after Haitian independence, which they considered property. Reparations is defined as payments made by a defeated nation after a war to pay for damages or expenses it caused to another nation. France went on to colonize Africa after the Haitian Revolution but is still involved in the neo-colonization of Haiti thru CORE Group. According to the definition it was France who should have paid reparations to Haiti and this set a bad precedent because all Western nations went on to demand reparations as payment for independence of colonized peoples. Europeans began migrating to the USA by the millions due to a series of Homestead Acts referred to as "Laws of the Lands" beginning in the early 1800's. In the process of colonizing North America, the US Federal government used black labor to develop two billion acres of free land from New York to California for these European Migrants. The Haiti Reformation Project also demand Reparations on behalf of "African-Americans" due to the fact that Washington DC invaded Haiti to enforce reparations payments to France yet still haven't compensated #ADOS for chattel slavery. Chattel slavery is the "Original Sin" of the American colonies because it turned human beings into the private property of other human beings and was the basis of the American economy. There was a significant indigenous aboriginal population within North America when Europeans arrived to colonize land under the Doctrine of Discovery. In fact, the term Amer'ican is a noun that means native of Americas, which originally applied only to the aboriginals or copper-colored people found here by European colonizers, but is now applied only to the descendants of Europeans born in America. ADOS/FBA are the descendants of these indigenous aboriginal people of North America who were reclassified as negro, black, and African-American during the process of colonization and have been

domesticated to become alien to their land of inheritance. ADOS/FBA are a dilapidated people today due to the failure of their enslaved ancestors to defeat the system of institutionalized chattel slavery the American colonies placed over them. The institutionalized Jim Crow policies which the US has implemented to disenfranchise ADOS/FBA are the same policies they're using on the Republic of Haiti.

During my investigation into this topic, I discovered that the International Bank Cartel financed both sides of the Civil War and utilized the white supremacist ideology to overthrow Reconstruction and takeover the US after the Civil War. According to "Descent Into Slavery" By Des Griffin: "If that mischievous financial policy which had its origin in the North American Republic [i.e., honest Constitutionally authorized no debt money] should become indurated down to a fixture, then that government will furnish its own money without cost. It will pay off its debt and be without a debt [to the international bankers]. It will become prosperous beyond precedent in the history of the civilized governments of the world. The brains and wealth of all countries will go to North America. That government must be destroyed or it will destroy every monarchy on the globe." In fact, the Crown backed the Confederacy and poured into Mexico along with France and Spain; ready to enter the war if not for the intervention of Czar Alexander II and Russia who backed President Abraham Lincoln. The Democratic Party was founded by Andrew Jackson in 1825 on a pro-slavery platform and was known as the racist party. What's interesting is that President Andrew Jackson was intent on keeping international bankers and foreign interests from operating in the United States government because he feared the tyranny, they would cause the American people if they got control of the government. The Rothschild's lost in 1832 when President Jackson vetoed the move to renew the charter of the Bank of the United States which was controlled by international bankers. In 1862 and 1863 President Lincoln refused to pay the exorbitant rates of interest demanded by the Rothschilds and instead issued constitutionally authorized, interest free United States notes(greenbacks). Because of this act the Rothschilds and the International Banking Cartel plotted to get rid of him. It was the Achilles heel of white supremacy which was maintained thru slavery and the formation of the United States despite the Constitution which the International Bankers used to covertly takeover the U.S. The process of all Americans becoming private corporate chattel property of the "UNITED STATES" began with the assassination of President Abraham Lincoln on April 14, 1865, the Democrat party destruction of Reconstruction, lynching of Lincoln Republicans, the systematic denial of the indigenous aboriginal population to declare their nationality under their organic Republic or claim their true identity, and disenfranchisement of their rights as a sovereign people.

The Ens Legis Act of February 21, 1871 of the 41st Congress was the death nil to the organic Republic of America because that's when the International Bankers chartered a federal company entitled UNITED STATES i.e., US Inc. (a commercial agency originally designated as Washington D.C.) incorporated as a for profit commercial enterprise. The Ens Legis Act of 1871 not only formed a corporation called UNITED STATES which is owned by international bankers and foreign interests but it also established the District of

Columbia and banished the organic Constitution of the Republic of America. Anyone familiar with "legalese" knows that by switching just one word on any legal document makes a huge difference, the Ens Legis Act capitalized the title of Constitution; "THE CONSTITUTION OF THE UNITED STATES OF AMERICA" and changed the phrase from "for the people" to "of the people". The Ens Legis Act covertly turned the organic Republic of America into an incorporated version of UNITED STATES OF AMERICA for the government of the District of Columbia with a corporate CONSTITUTION and the people went from absolute inalienable rights guaranteed under the organic constitution to relative rights or privileges designated by a privately owned corporate institution. The Ens Legis Act of February 21, 1871 of the 41st Congress also created the "STRAWMAN" which is a legal fiction because their newly formed corporate nation of "UNITED STATES" needed corporate citizens. The "legalese" definition of; "Ens Legis L. Lat. A creature of the law; an artificial being, as contrasted with a natural person. Applied to corporations, considered as deriving their existence entirely from the law", Black's Law Dictionary, Fourth Edition 1951. Ens Legis is the precise legal description of the "STRAWMAN" AKA "ARTIFICIAL PERSON" i.e., "JOHN DOE" with ALL-CAPS denotes the TRADE NAME and actually represents intellectual property of the UNITED STATES Inc. which is de facto/bankrupt/subject/ink-on-paper/debtor/Privileges given from the state/ need for permits and licenses/property titles held or owned by the state/Admiralty law. The "STRAWMAN" is a legal term for a "front man," or nominal party to a transaction, transmitting utility, existing in name only, which allows the owner to accomplish some purpose not otherwise permitted. The "STRAWMAN" is fake person created with all caps, which represents an "ARTIFICIAL PERSON" that's designated as a minority. But with the Ens Legis Act of February 21, 1871 UNITED STATES citizens have been coerced by the government into believing/assuming "JOHN DOE" AKA "John Doe" are one and the same person. The deception of "John Doe" within the artificial sphere began with registration of "JOHN DOE" (trade name) via birth certificate and omitting to notify him of the newly created Ens Legis corporate franchise citizen; deceived into contracting as surety for the trade name concealing new status from victim but enforcing new obligations without benefit of explanation. The commercial courts use principle known as Idem Sonans (Latin for "sounding the same") which states that similar sounding names are just as valid in referring to a person to perpetuate this fraud. The people of the Republic of Haiti don't want to be corporate citizens of a corporate nation and want to maintain Haitian sovereignty under a Cooperative-Union.

The fact of matter is the defunct "UNITED STATES" Inc. has just re-incorporated and registered as "UNITED STATES OF AMERICA" LLC (Limited Liability Corporation) in Great Britain, and those who voted in the 2020 Presidential "election" have unknowingly been coerced by the Democratic Party into signed themselves over (once again) as "voluntary" chattel property. By participating and voting in the election they have in essence "picked up the options" to the "UNITED STATES OF AMERICA" thru the adhesion contracts of their "STRAWMAN". The American people have voluntarily submitted themselves to the dictates of the selected CEO of the Corporation for which their "STRAWMAN" "voted" for, and will assume all debts and liabilities applicable to their

Ens Legis "ALL-CAPS" "JOHN DOE" when demanded by the Corporation, its' CEO, and employees. There were actually two offices up for grabs; the President of the "UNITED STATES" Inc which just officially dissolved via chapter 7 bankruptcy on the 3rd of November 2020; and the President of the "UNITED STATES OF AMERICA" LLC which is currently in Chapter 11, so the entire election was a contest for the "presidency" of a corporation that is in bankruptcy and reorganization. However, neither of these entities are actually the organic sovereign government of the Republic of the United States of North America, nor in the Family of Nations because no corporation is sovereign. The US Presidential Election of 2020 was actually a coup against the American people to bring them under the umbrella of the "UNITED STATES OF AMERICA" LLC instead of the Republic of the United States; "President-elect" Biden and "VP-elect" Harris actually ran for a defunct office that went bankrupt on November 3 2020. Ever since the overthrow of Reconstruction "African Americans" have been disenfranchised political slaves of the Democrat party and were used as scapegoat or "STRAWMAN". This can be noted in Biden's campaign statement: "if u don't vote for me than you're not black". Coming out of the Civil War, The Republican Party was established in 1854 by the "black" indigenous Americans (who formed a large faction known as the Lincoln Republicans), white abolitionist with an anti-slavery platform, and the Reconstruction Era began! The Homestead Act of 1866 and the Civil Rights Act of 1866 (14th, 15th amendment) were supposed to rectify the situation by President Lincoln who also established the Freedmans Bureau (also known as the Bureau of Refugees, Freedmen and Abandoned Lands) as a way to enfranchise and undergird the indigenous population as the Homestead Acts had subsidized the European immigrant class. Under these bills the Freedman's bank was also established, which immediately amassed 72,000 accounts and raised 52 million. The indigenous aboriginal American population were also supposed to declare their nationality during Reconstruction when President Lincoln opened up the 13th amendment with 21 sections and nullified the 14th. Modern historians claim Reconstruction ended in 1877 but it actually ended when Abraham Lincoln was assassinated on April 14, 1865 by John Wilkes Booth, a member of Knights of the Golden Circle.

They were (3) business enterprises originally engaged as Federal Subcontractors with the indigenous aboriginal Confederations and Republic after the Civil War - one American, One British, and one Holy Roman Empire interest. These other two Federal subcontractors, the Brits, and the Papists reorganized following the Civil War and began operating as commercial corporations in the business of providing governmental services (a status they've been in ever since). The American Subcontractor has been paralyzed and rendered inoperable since Reconstruction with the assassination of President Abraham Lincoln on April 14, 1865. What's interesting is that the three Federal Subcontractors; American, British, Holy Roman Empire form the 3 city states of; Washington District of Columbia, London, England, The Vatican which control a large portion of the world today. The Ku Klux Klan (KKK) was founded in 1865 by Albert Pyke also a member of the Knights of the Golden Circle and southerners opposed to Reconstruction era policies which

established economic and political equality for black Americans. Once President Lincoln was assassinated, the KKK/KOG utilized the Democratic Party to destroy Reconstruction and infiltrate the original Black Republican Party which nullified the American Subcontractor because they're the true sovereigns. After this catastrophic event Vice President Andrew Johnson, Democrat, took office and sabotaged all efforts to empower indigenous "black" Confederate southerners. The indigenous aboriginal population was betrayed by Washington DC and President Andrew Johnson with the Southern Compromise after Lincoln's assassination. After the Southern Compromise of 1877, the Freedmen's Bureau Bill was vetoed, blacks were disenfranchised and the Republican Party infiltrated by racists; members of the Lincoln Republicans were lynched all over the country; and the "Jim Crow" Era began. The Freedman's Bureau, which had created the Freedman's Bank, got all of their gold stolen even though Frederick Douglas tried to save it.

The administration of President Woodrow Wilson is known for dooming two nations during his administration; USA with the Federal Reserve Act which established the Federal Reserve System, a central banking system in WASHINGTON DC owned by the international bankers (foreign interests); and Haiti with the 1915 invasion which allowed the international bankers to takeover Haiti also. The "UNITED STATES" was reluctant to invade Haiti after Haiti's independence of 1804, fearful of the destruction of their American colonial project, destruction of institutionalized slavery, liberation of their enslaved population, and territorial expansion of Haiti within the Americas. In fact, the "UNITED STATES" refused to recognize Haiti's independence until 1862 during the Civil War when they "abolished" slavery. The US utilized Haiti to project the perception that institutionalized slavery was over in America when they looked to legitimize themselves in the free world. Haiti defeated institutionalized slavery in 1804 but a neo-colonial version of it returned in 1915 with an invasion led by Major General Smedley Butler and occupation by Washington DC which lasted for 19 years. During this 19-year occupation of Haiti, Washington DC tried to destroy Haitian sovereignty and nullify any gains the same way they did to the Lincoln Republicans and their indigenous aboriginal population by destroying Reconstruction. War Is A Racket, the International Bankers whom had already taken over the US after the Civil War used Washington DC and the USMC to takeover Haiti's Bank and economy like they did to the US after the Civil War. Washington DC stole all of the gold from Haiti's Bank like the Freedmans Bank (Haiti's gold became Citibank), took over the Haitian economy, rewrote the Haitian Constitution, opened up land to foreign interests, and instituted Jim Crow policies which left Haiti in a state of arrested development we see today. The Roosevelt Corollary of the Monroe Doctrine, which allowed the use of force when Latin Nations failed to pay their debts to European and US banks and interests, was invoked for the 1915 invasion due to Haiti's default on Reparations payment to France. The threat under the Secret Treaty of Verona to suppress popular governments within the hemisphere of the Americas is the basis of Monroe Doctrine. The Holy Alliance looked to reestablish the sovereignty of Spain in the newly independent Republics of South and Central America and prevent the exercise of any measure of the right of self-government. The Monroe Doctrine left Washington DC as the last remaining

colonizing power within the Americas. The use of the Monroe Doctrine within the Americas has been hypocritical by Washington D.C. because it's been used by them to suppress popular movements and prevent the exercise of any measure of the right of self-government throughout the Americas. Even though Haiti won its independence, its fate became linked with the fate of African Americans when Haiti became a captured state of the U.S. in 1915. Haitian money was backed by gold before the US occupation but they raided the Haitian National Bank and sent all of the Gold to the New York Federal Reserve. This Haitian gold is what was used by its founders to form Citibank

The International community introduced COVID-19 to the world for the "Global Reset" the same way they introduced a cholera epidemic into Haiti which killed over 30,000 Haitians killed. The official narrative of the Coronavirus pandemic is that it originated from a from a "Wet Market" in Huanan, China where it was contracted and began spreading after people purchased and ate horseshoe bats contaminated with the Coronavirus. Agent-in-Fact/Relative; Representative; National Agent, for logistics and execution of the mandate of said principle The Republic of Haiti via the Independent Haiti Reconstruction Commission. Failure to do so will subject all said parties to Legal Action in order to enforce this document; attorney's fees and costs; triple damages; and publication of this document.
