UNILATERAL DECLARATION OF THE REPUBLIC OF HAITI ADDRESSED TO THE SECRETARY GENERAL OF THE UNITED NATIONS

FOR SUBMISSION TO THE INTERNATIONAL COURT OF JUSTICE CONCERNING UNITED NATIONS SECURITY COUNSEL RESOLUTION 940 UNILATERAL INTERVENTION "UPHOLD DEMOCRACY"; UNITED NATIONS SECURITY COUNSEL RESOLUTION 1542; UNITED NATIONS SECURITY COUNSEL RESOLUTION 1892

On behalf of the Government of the Republic of Haiti, which unilaterally accepted the jurisdiction of the court of international justice on 4 October 1921 and has been a UN member since 26 June 1945, the jurisdiction of the International Court of Justice is invoked in accordance with Article 36(1) concerning the subject matter of UNSCR 940; UNSCR 1542; and UNSCR 1892.

The Government of the Republic of Haiti recognizes as compulsory ipso facto and without special agreement, in relation to any other State accepting the same obligation, unconditionally, the jurisdiction of the international court of justice concerning: UNSCR 940; UNSCR 1542; UNSCR 1892: any question of international law concerning UNSCR 940; UNSCR 1542; UNSCR 1892: the existence of any fact which, if established, would constitute a breach of UNSCR 940; UNSCR 1542; UNSCR 1892 and international obligations: the nature of the reparation to be made for the breach of UNSCR 940; UNSCR 1542; UNSCR 1892 and international obligations in conformity with Article 36(2) of the Statute of that Court.

For the Record: The origin of the animosity which Washington D.C. has towards Haiti stems from the diametrically opposite Revolutions which birthed each nation. The American Revolution 1775 to 1783 was actually a counter revolution fought by the American colonies, established under the Doctrine of Discovery, in order to keep enslaving the indigenous population and confiscating their land. The abolishment of slavery in England and Scotland in June 1772 with Lord Mansfield Somersets Case infuriated American colonists who'd rather revolt against the crown than see "slaves" they considered to be property freed causing great losses in income. England and Haiti were both pressuring the American colonies to abolish Slavery and fought together against the American colonies during the American Revolution. It was the American victory and its' legalized slave trade which helped to spark the Haitian Revolution. The Haitian Revolution of 1791-1804 was actually in response to the American Revolution and struck a mighty blow to the American colonies; plus the institution of slavery which they were built upon. Despite the rhetoric of the American Constitution the execution of chattel slavery by the colonies begins from 1783 to 1854. The indigenous aboriginal autochneous American population who fell under the jurisdiction of this newly formed union were reclassified with common vernacular of the day such as negroe, black, West Indian, and coloured. They were coerced into joining or kidnapped, shipped, and utilized to build up the former American colonies and territories within the US until the Civil War without

compensation. The power dynamic at play between Washington DC and Haiti is the fact that Haiti defeated Spain, France, Britain, and Germany who were all supported monetarily by the American colonies but the US never openly declared war against Haiti out of fear of liberating their enslaved population. The United States spent the modern day equivalent of a billion dollars at that time to make sure their slaves didn't find out about the Haitian Revolution in 1804. Official U.S. documents stated at the time that no "black" person in the world must ever look up to Haiti today or future generations and see it as a symbol of pride for black people across the world because everyone is going to start to do what they did; kicking us out all across the Caribbean and Africa. They began a campaign to demonize Haiti to the world with a negative portrayal of its' religion, culture, and government. A policy which continues to this day.

The US failed to recognize Haiti's sovereignty until 1862 and waited until 1915 to invade Haiti and occupy it until 1934. The Haitian Army which was established during the 1915-1934 occupation of Haiti by USMC General Smedley Butler and the Marine Corps was actually a gendarmerie. This Haitian gendarmerie was left in place by Washington DC after its' occupation as 'an army to fight the people'. This US led Haitian gendarmerie was loyal to, and answered directly to the US Secretary of State, and was used to terrorize the Haitian population. Jean Claude Duvalier emerged out of this gendarmeier to take power in Haiti. This is the same gendarmerie President Aristede was all too ready to rid Haiti of and covertly being replaced with DynCorp Int. by Washington DC. According to Assistant Secretary of the Navy at the time Franklin Delano Roosevelt: "From 1804 to 1915 Haiti was a Sovereign State under a Republican form of Government. She won her independence from France in 1804. She was deprived of it in 1915 by the United States. Since then we have been in virtual control of her territory, our marines have been in military occupation of the country, and the former republic has been stripped by us of every vestige of her sovereignty."

UNSCR 940 issued on 31 July 1994 authorized the formation of a multinational force, under unified command and control, led by the US, to restore the first popularly elected president under free suffrage national elections in Haitian history President Jean Bertrand Aristede back to power and extend the mandate of the United Nations Mission in Haiti. Acting under Chapter VII of the UN charter the presence of this multinational force on sovereign Haitian soil was facilitated by the Governor's Island Agreement and Pact of New York. These were the negotiations between then deposed President Aristede and LT. Raoul Cedras, mediated by the O.A.S. and U.N., for the return of Aristede to power. One of the prerequisites for the return of President Jean Bertrand Aristide to power by Washington DC was the disbanding of the Forces Armées d'Haiti (FADH) which the exiled President Aristede readily accepted and replacing it with DynCorp International 1 of the 3 preeminent private mercenary corporations in the world. DynCorp Int is also a CIA proprietary organization, a business designed to provide a service wanted by the CIA which is secretly owned by the CIA .but disguised to appear in public as a private business. On July 4 1994 Lt. General Cedras signed the Governor Island Accord which would restore President Aristide to power by October 30 1994. The President of the United States at that time William J. Clinton framed UNSCR 940 unilateral intervention "Uphold Democracy" as a foreign policy victory, and a return to "Democracy" in Haiti. DynCorp Int was contracted to restructure the HNP into a paramilitary force and run the UN multi-national force and give technical support to the transitional government.

1. The unilateral intervention UNSCR 940 “Uphold Democracy” code name Dragon's Blood was actually a clandestine Incursion of Haiti by DynCorp Int, Washington DC to utilize it as a trans-national shipment point for narcotics hence considered to be an illegal action under the principles of International Law in lieu of the fact:

G. A major prerequisite of unilateral intervention UNSCR Resolution 940 Operation Uphold Democracy codename dragonsblood called for President Jean-Bertrand Aristide to dismantle the 7,000 member Forces Armées d’Haiti (FADH) and replace it with DynCorp Int. which was contracted to give "technical advice" to Haiti; restructure the Haitian National Police (HNP) into a paramilitary force; and coordinate UN forces. The U.S. National Security Act of 1947 established the Secretary of Defense and created the Department of the Air Force. It protected the Marine Corps as an independent service, under the Department of the Navy, prohibiting it from ever being absorbed into the Army. It also created the Central Intelligence Agency (CIA) with both a strategic analysis and an operative clandestine activities side. It drew a bright line between foreign and domestic intelligence and assigning these realms, in effect, to the CIA and the Federal Bureau of Investigation (FBI), respectively. The CIA was designed to be an independent, central agency with no policymaking role and no law enforcement powers. DynCorp Int. was also created with the National Security Act as a clandestine operating division of the CIA by the Dulles brothers. Since its inception during the “Cold War” DynCorp Int. has operated as a covert mafia with government backing. It comprises the “Black Budget” and was used for “Black Ops” by the Dulles brothers to overthrow governments and make money all over the world for US corporations; hence the CIA nickname “the Company”. The establishment of the fact that DynCorp Int. is a clandestine branch of the U.S. state department constitutes their role in Haiti as a breach of international law; violation of the Geneva Convention; Haiti's sovereignty; Principles of the Nuremberg Charter; etc.; etc...

According to the Kerry Committee Report: "since the days of “Papa Doc”, Francois Duvalier, Haiti’s government has' been notorious for its corruption. The Duvalier family and their associates profited enormously from the protection of many illegal enterprises, including narcotics trafficking" While Haiti was still under the Duvalier regime, the drug trade in Haiti was the province of members of the Ton Ton Macoutes (his corrupt military guard). A New York Times article dated June 4, 1986 US officials stated Ernst Bennett, father in law of President Jean Claude Duvalier, was a prominent figure in narcotics trafficking in Haiti and referred to as "the Godfather." "One official said he had been the "main local contact" for one of four or five rings of Colombian smugglers who were shipping cocaine through here to the US." Ernst Bennett fled Haiti after the fall of the Duvalier regime to whereabouts unknown. By 1985 the cocaine cartels began to seek transit points for the booming cocaine industry. A natural candidate was Haiti due to the direct transit route from the Colombian coast to Florida thru the Windward Passage

In 1987, Senator John Kerry as Chairman of the Subcommittee on Narcotics, Terrorism and International Operations of the Senate Foreign Affairs Committee was entrusted with a major investigation, which focused on the links between the CIA and the drug trade, including the laundering of drug money to finance armed insurgencies. A CIA cargo plane was shot down over Nicaragua in October 1986, quickly thrusting the Iran/Contra scandal into living rooms and courtrooms around the world. “The Kerry Committee Report” published in 1989 exposed collusion between the CIA and drug traffickers during the late 1980s’ Iran Contra hearings. While investigating the Iran/Contra scandal the Kerry Committee also developed detailed information on

drug trafficking by the Forces Armées d'Haiti which led to the indictment in Miami in 1988, of Lt. Col. Jean Paul.

According to the Kerry Committee Report: "Following the departure of Baby "Doc" Duvalier and the presidential elections of 1987, the Colombians took advantage of the complete breakdown of government institutions and began to move into the country in force. They focused their efforts on corrupting key military officers who were in a position to assure that there would be no interference with, their operations. According to DEA intelligence, the number of Colombian narcotics traffickers residing in Haiti has been growing daily and the narcotics organizations are now using Haiti as a base of operations, storage site and staging, area. In addition, these organizations are buying up legitimate businesses to serve as front companies for their smuggling operations. Once having, gained access to local commerce, they then focus on corrupting, public officials to protect their interests. The Subcommittee heard a detailed account of the process the Colombians used to establish themselves in Haiti from Osvaldo Quintana, a Cuban American who became involved in drug smuggling from Haiti to Miami. Quintana later testified about his experience before a Federal grand jury in Miami. He explained that the Colombians established a working relationship with Colonel Jean-Claude Paul by working through a Haitian named Cardozo. The Colombians agreed to pay Colonel Paul, the commander of the Dessalines Barracks, for protection and for the use of runway on his ranch for cocaine flights. Command of the Dessalines Barracks allowed Colonel Paul to play a pivotal role in Haitian politics because this force is the elite unit responsible for the protection of the Presidential Palace. Colonel Paul's influence was very much in evidence during the 1987 election, when much of the violence was attributed to soldiers, and security officials known as Ton tons Macoute acting under his direction." According to New York Times article July 23 1994 2 Haiti Leaders are focus of drug inquiry: A memo, from Deputy Assistant Attorney General Mark M. Richard, stated that "the U.S. Attorney's Office in Miami has established that the Haitian military have been closely involved in the facilitation of drug trafficking since the early 1980's." Federal investigators and lawyers familiar with the investigation said they had heard or read statements, given in recent weeks by two former Colombian cocaine cartel traffickers that described Lt. General Cedras as a participant in a 1987 cocaine deal. The witnesses described a fiesta in November 1987 thrown at the ranch of the cocaine kingpin Pablo Escobar outside Medellin, Colombia organized by a consortium of cartels to celebrate the cartels' successful opening of a new trade route, through Haiti into the United States. By November 1987, they said, the cartels had completed shipments of 30,000 kilograms, or about 66,000 pounds, of cocaine through Haiti. The cocaine was transshipped from the Haitian capital, Port-au-Prince, to Miami, mostly on commercial flights. Mr. Arroyave described arriving at the fiesta and noticing a number of black foreigners, an unusual sight at a gathering of members of the Colombian cartels. He said he was introduced to Michel Francois and Raoul Cedras, among other senior Haitian military officials. He said General Cedras spoke Spanish with a Dominican accent and served as interpreter for the other Haitians. Both witnesses said the Haitians at the party were paid \$10 million for their help in the transshipment of 30,000 kilograms of cocaine through Haiti. After the party ended the next night, the Haitians left on a plane owned by the cocaine traffickers, both witnesses said.

The Medellin Cartel was the most profitable cartel in Colombian history. By 1989 they had 20% of all US 100 dollar bills stored in Colombian banks. The Medellin Cartel revolutionized the cocaine trade and how it was transported. They also participated in bombings, smuggling, and

assassinations. The Infamous Pablo Escobar, head of the Medellin Cartel, made the Forbes List in 1989 as the 7th richest man in the world. At his height Pablo Escobar brought in 22 billion a year thru the Medellin Cartel. He once offered to pay Columbia's national debt of 10 billion dollars as a deal to prevent extradition to the US and reported net worth was 30 billion at time of death. At its' peak Medellin cartel smuggled 15 tons of coke every day and had direct control of 80% of the global cocaine market. The Medellin Cartel was implicated in the Iran/Contra scandal and was doing business with the Washington DC Banking Cartel thru clandestine efforts of the Company in the international illicit drug trade. In 1986 the CIA set up and provided funding for the National Intelligence Service (SIN) in Haiti under the guise of fighting narcotics. Yet, according to a U.S. embassy official cited by the New York Times, SIN "never produced drug intelligence" but rather used the \$500,000 to \$1 million they received annually from the United States "for political reasons, against whatever group they wanted to gather information on." A Haitian official concurred, saying SIN was "heavily involved in spying on so-called subversive groups; they were doing nothing but political repression; they targeted Fanmi-Lavalas supporters who were for change." It is evident that Sin which was established by the CIA was being dissuaded from fighting narcotics is due to the fact that the Company was involved in the Haitian drug trade already. According the Kerry Committee Report: "In 1987, the Colombian cartels established a major, and secure base of operations in Haiti, turning that country into another significant transit point for cocaine coming into the United States. The cartels bought protection from the upper ranks of the Haitian military which, in turn established a distribution network in the United States. This network is characterized by a high level of violence associated with its operations."

After the fall of Duvalier a military coup in 1989 brought Lieutenant General Prosper Avril to power. Under U.S. pressure Avril, the former finance chief under the 30-year Duvalier family dictatorship, fired 140 officers suspected of drug trafficking. According to a witness before Senator John Kerry's subcommittee, Lt. Gen. Avril was in fact a major player in Haiti's role as a transit point in the cocaine trade. In 1990 Jean Bertrand Aristide won the Haitian presidency thru grassroots organization of Fanmi-Lavalas, a genuine Poor Peoples Political movement. On September 30, 1991, a military cocaine-coup under the leadership of Lieutenant General Raoul Cedras, Commander-in-Chief of the military forces of Haiti Forces Armées d'Haiti (FADH), overthrew the government of President Jean-Bertrand Aristide. Members of the Forces Armées d'Haiti who participated in the September 30, 1991 Coup de Tat by Lt. General Cedras which overthrew President Aristide were on on the CIA's payroll, as part of an anti-drug intelligence unit set up by SIN in 1986. Many of them had their U.S. assets frozen, and are prevented from entering the US due to their role in human rights violations; torture; murder of political opponents.

The Front for the Advancement and Progress of Haiti (FRAPH), a part of the military junta of Lt Gen Raoul Cedras, was linked to USDIA and CIA. According to a 1996 UN Human Rights Commission report, FRAPH had been supported by the CIA. It was created/sponsored by a group of senior army officers on CIA payroll. Declassified records now make it clear that US state department agencies like the CIA/USDIA helped to create and fund the paramilitary group called FRAPH. Under the military dictatorship of Lt Gen Raoul Cedras, the narcotics trade was protected by the military Junta, which in turn was supported by the CIA. While addressing the UN during his exile, in a dramatic move, President Aristide told the diplomats that the military Junta of Lt. General Cedras had to yield the power that was to end Haiti's role in the drug trade. The cocaine trade financed by Colombia's Medellin Cartel had exploded in Haiti following the cocaine-coups

against him. President Aristide told the UN diplomats that each year Haiti is the transit point for nearly 50 tons of cocaine worth more than a billion dollars, providing Haiti's military rulers with \$200 million in profits. Jack Blum, who was Kerry's Special Counsel, points to the complicity of US officials in a 1996 statement to the US Senate Select Committee on Intelligence on Drug Trafficking and the Contra War: "In Haiti intelligence "sources" of ours in the Haitian military had turned their facilities over to the drug cartels. Instead of putting pressure on the rotten leadership of the military, we defended them. We held our noses and looked the other way as they and their criminal friends in the United States distributed cocaine in Miami, Philadelphia and New, York." "This unilateral intervention was under the guise, yet was not intended to "Uphold Democracy". On the contrary, it was carried out to prevent a popular insurrection against the military Junta of Lt. General Cedras and its neoliberal cohorts by Fanmi-Lavalas and its supporters for the return of the Aristide administration. The United States didn't even prosecute Lt. Gen. Raoul Cedras for the criminal acts conducted during his military junta. Instead they gave the Haitian military strongman a million dollar-plus "golden parachute" to resign and go into exile. During the coup and since, the US state department agency USAID sponsored "democracy enhancement" did its' job.

Ever since the earthquake of 2010 and theft of the Haitian Relief Funds there is a growing concern among the Haitian diaspora and the International community that Washington DC has not been actually providing humanitarian assistance or aid to Haiti. An international responsibility to protect Haiti's sovereignty exists not only because it was the Haitian revolution which helped to end the enslavement of humanity within the American hemisphere but also because of the indigenous origins of most of their ancestors. The unilateral intervention 'Uphold Democracy' entered Haiti on 19 September 1994 with a force of 6,000 United Nations troops and 15,000 US troops (only 120 of whom speak Creole, the language that most Haitians speak) at the cost of \$5 billion to the American taxpayer. The unilateral intervention ousted the military government and restored Aristide to power on Oct. 15, 1994. The Forces Armées d'Haiti (FADH) which consists of 7,000 men were disbanded and Washington DC contracted US military contractor DynCorp International which is part of the clandestine operating division of the CIA to provide "technical advice" in restructuring the Haitian National Police (HNP). UNSCR 940 "Uphold Democracy" code name Dragon's Blood was actually a clandestine incursion of Haiti. The Clinton/CIA/Haiti drug connection was a pathway for hard drugs and cocaine to enter the U.S. thru Haiti with the support of drug kingpin Pablo Escobar.

The US led unilateral intervention UNSCR 940 "Uphold Democracy" code name Dragon's Blood which returned President Aristide to power was actually a clandestine incursion by Washington DC to take over the cocaine trade, which the gendemiè they had established in 1915, was developing in Haiti. The pre requisite that Haiti dismantled the military was readily accepted by Aristide due to the terror they had waged on the Haitian people on behalf of Washington DC. The fact that DynCorp Int was contracted to replace this gendemiè and run Haiti not only violates International Law but also created a narco-state in Haiti. This is a grand scale version of the covert narcotics smuggling operation in Mena, Ark. which Governor William J Clinton and the Arkansas Development and Finance Authority (ADFA) were implicated in. With the Forces Armées d'Haiti (FADH) gone the Company took over the transshipment point. Pablo Escobar and the Medellin cartel continued to supply all the cocaine which came thru Haiti with early estimates of over \$20 million a month being trafficked while Washington DC turned a blind eye and exported death to

American youth. The crack epidemic in black communities on the east coast was fueled by the Haiti-Florida connection. Pablo Escobar would have wet dreams about the narco state the Clintons and the Company established in Haiti. The infamous Pablo Escobar ran for and was elected “as an alternate member of Colombia’s Congress” in 1982. He was forced to resign in 1984, after two years because he was accused of direct involvement in drug production and smuggling to the United States. The Reagan administration who wanted extradition for their "War on Drugs" pressured the Colombian president, Luis Carlos Galan, to prevent Escobar from sitting in the parliament. The hypocrisy of the "War on Drugs" is that at the same time Washington DC claimed to be fighting this war they were also profiting from it in a myriad of ways. This utilization of Haiti as a narco-state follows the pattern of colonization of the US state dept. in Haiti. for instance the jacked the banks...Haiti was under American military rule from 1915 to 1934. Major General Smedley D. Butler said he hunted the Haitians “like pigs” and made Haiti “a decent place for the National City Bank boys to collect revenue in.” American troops practiced “indiscriminate killing of natives” while the American press called Haitians “a horde of naked niggers” in need of “energetic Anglo-Saxon influence”....America rewrote Haiti’s laws so that Americans could buy up land. They sent 40% of Haiti’s income to American and French banks to pay back debts.

2. UNSCR 1542 issued on 30 April 2004 established The United Nations Stabilization Mission in Haiti (MINUSTAH) with a mandate to support the Transitional Government of Haiti with a military component of up to 6,700 U.N. soldiers. These actions taken by MINUSTAH under the guise of a Chapter VII mission are a violation of International Law in lieu of the fact:

A. On February 29, 2004, a multinational force led by the U.S., Canada, and France came to quell dissent in Haiti following a U.S.-backed regime change. U.S. marines apprehended President Aristide and flew him out of the country and into exile after a phone call from General Colin Powell telling him "it's over". President Jean-Bertrand Aristide is on record stating that he was “kidnapped” aboard a U.S. military plane, and dumped in the Central African Republic. This blatant forced removal of a sitting president by a foreign nation was illegal and a break with democratic order in Haiti. UNSCR 1542 failed to consider what role the US played funding and supporting the coup d’état of President Aristide. The U.S. state department funded the country’s anti-Aristide opposition of “Democratic Platform of Civil Society Organizations and Opposition Political Parties” which destabilized the Fanmi-Lavalas government. The Democratic Convergence (DC) and the Coalition of 184 Civic Institutions contain a laundry list of Haitian NGOs funded by USAID and/or the International Republican Institute (IRI). Both the “Démocratique Convergence” and the “Coalition of 184 Civic Institutions” have links to the FLRN (former FRAPH death squadron’s leader) Guy Philippe. The FLRN/FRAPH are Haitian paramilitary groups who receive funding from the Washington DC thru these “civic organizations”. Washington DC, Duvalierists and Haitian oligarchy utilize these “civic organizations” for the purpose of killing members of Fanmi-Lavalas and committing a coup d’état against President Aristide. Guy Philippe...connected to drug activities by dea.... and his “rebels” succeeded, with the help of U.S. Special Forces, in overthrowing President Aristide on Feb. 29, 2004. The game is low-intensity warfare, a mix of policies long familiar to observers of U.S. policy toward ‘undesirable’ regimes in Latin America and elsewhere. The mix includes disinformation campaigns in the media; pressure on international institutions and other governments to weaken

their support of the 'target' government; and overt and covert support for rightist opposition groups, including those prepared to attempt a violent overthrow.

B. There is a division of tasks between the CIA and the NED. While the CIA provides covert support to armed paramilitary rebel groups and death squadrons, the NED and its four constituent organizations finance "civilian" political parties like 'The Coalition of 184 Civic Institutions Organization' (G-184) and non-governmental organizations with a view to instituting American "democracy" around the World. America imperialism rules by means of banana republics which they control by means of kakistocracies around the world. Once a conflict was created DynCorp Int., which is part of the clandestine operating division of the CIA, was brought in thru the U.N. to train and turn the domestic police force into a terrorist organization; human trafficking; and organ harvesting. After exiling President Aristede to Africa, the U.S. went on to criminalize the whole Fanmi-Lavalas political party, the political base of president Aristede. The Fanmi-Lavalas Party developed from the grass roots Lavalas Movement which was founded by Jean-Bertrand Aristede. The term Lavalas means flood, the grass roots movement consisted of priests, students, peasant groups, union activists, and most sectors of Haitian society which were opposed to the Duvalierists and their Washington DC cohorts. The Lavalas Party is based on social democratic principles with an emphasis on investment in people, education, and health care as their priorities. They refused IMF austerity measures and seek a fair distribution of wealth and the use of Haiti's Natural resources in a way that's beneficial to Haitians. It was reported in the New York Times at the time that the terminology used in a cable sent by US officials briefing the coup government, both the U.S. Embassy and Haitian elite referred to the Lavalas resistance fighters as "bandits" or "gangs,". The terms "Bandits" and "Gangs" were often used as a code word for Fanmi-Lavalas supporters by US officials and Haitians on their payrolls. Yvonne Neptune, Jocelerme Privert, Father Gerard Jean-Juste, Annette Auguste, Rene Civil, Emmanuel Cantave, Maryse Narcisse, Lovinsky Pierre-Antoine, Wilson Mesilien, etc., were all prominent members of the Fanmi Lavalas Party who were targeted during the foreign occupation of Haiti.

C. Fanmi-Lavalas supporters literally became political prisoners in their own country under MINUSTUH. In a now infamous case, Minustah mounted an assault into Cité Soleil, Haiti's largest slum on July 6, 2005, at 3:00 A.M., 1,440 Brazilian and Jordanian soldiers sealed off Cité Soleil with 41 armored personnel carriers and attacked. Helicopters dropped grenades and U.N. troops entered the poor Cite Soleil neighborhood and fired more than 22,000 bullets indiscriminately; spraying houses with gunfire; killing and wounding many men, women and children; leaving untold dozens of civilian casualties. Cité Soleil residents told an October 2005 fact-finding delegation for the International Tribunal on Haiti that U.N. tanks whisked away many bodies, which were never returned. Human rights groups called the carnage a massacre. According to declassified cables sent that day from the U.S. Embassy in Port-au-Prince to the State Department, UN troops fired 22,000 shots for seven hours in a neighborhood where most people live in structures made of flimsy sheet metal. An untold amount of Haitians were killed by the time it was over, including a number of children. According to MINUSTUH the target of this raid was Dread Wilme a prominent Fanmi-Lavalas member who was helping to fight the illegal occupation of Haiti. MINUSTAH was complicit in the oppression of Haiti's poor majority with the Transitional Government and Haiti's Duvalier elite. On December 22, 2006, for example, Minustah troops staged another raid on Cité Soleil in which, according to the Associated Press, at

least five people were killed. Under the transitional government these murderous raids by DynCorp Int., MINUSTUH, and HNP on areas with Fanmi-Lavalas supporters became the norm. MINUSTUH also participated in fraud elections, replaced ballot boxes, gerry meandering, and raping of women. In principle, there is a distinction between personnel from the International United Nations Mission for the Stabilization of Haiti (MINUSTAH) and the men and women of Haitian law enforcement, because the latter presumably all reside in Haiti and are Haitian nationals who have never renounced their citizenship. In practice, however, the UN force and the DynCorp Int trained "Haitian National Police" force have become quite indistinguishable in behavior.

According to John Stockwell former CIA officer: "they don't meet the death squads on the streets where they're actually chopping up people or laying them down on the street and run trucks over their heads. Now they meet them besides the swimming pool of the villas and it's a sophisticated, civil kind of relationship". The U.S. media coverage of the MINUSTUH/HNP raids of Cite Soliel was inadequate in both quantity and in presenting a balanced description of events. As death squads and the police murdered Fanmi-Lavalas supporters and others, the international corporate media did not run one editorial condemning the rampant political repression and violence it had accused the Aristide administration of committing.

D. MINUSTAH was established by Security Council resolution 1542 of 30 April 2004 to support the Transitional Government of Haiti. The UN Office of Internal Oversight Services, according to an internal audit of UN Police operations in MINUSTAH; the overall results relating to the effective management of the UN police operations were initially assessed as partially satisfactory. However, due to the lack of progress by MINUSTUH towards enhancing the capacity of the Haitian National Police to conduct criminal investigations, the final results were assessed as unsatisfactory. Their final overall rating was unsatisfactory as of August 24, 2012. The HNP, MINUSTUH, and UN police were all being trained by DynCorp Int. in Haiti.

E. The UN dispatched MINUSTAH on a Chapter VII mission to Haiti which violates Chapter I Art. 2 of their charter and International Law. MINUSTUH's presence in Haiti is based on the proposition that violence in Haiti is a threat to the international community. Yet since Haiti's independence it's been vice versa. MINUSTUH's mandate has been renewed every year since its inception, despite the fact that Haiti has a much lower rate of violent crimes (8.2 per 100,000 people) than many of its Caribbean neighbors such as Jamaica, which does not have a U.N. mission (54.9), or Brazil heading up the U.N. mission (26.4). Haiti has the lowest crime rate of the Caribbean and it has been concluded that the Haitian situation is not "a threat or breach of the international peace". After the forced removal of President Aristide by the US military, MINUSTUH was sent in to quell the dissenting Fanmi-Lavalas party. The UNSCR 1542 failed to examine the role the US played in creating exigent circumstances for the removal of President Aristide. Why are the UN soldiers shooting to kill if it's on a Chapter VII mission in Haiti? The U.N. lacks legal jurisdiction over its peacekeeping force, and instead relies on member states to prosecute crimes by their own troops. It is a human rights violation for UN soldiers to target and kill Fanmi-Lavalas Party members indiscriminately because they are genuine poor peoples political movement. MINUSTUH's presence in Haiti is based on the proposition that violence in Haiti is a threat to the international community, yet since Haiti's independence it's been vice versa.

F. Saturday morning. After having assumed command of the UN military mission less than four months ago, the body of Brazilian officer Lt. Gen. Urano Teixeira da Matta Bacellar was found sprawled out on the balcony of the Hotel Montana, the apparent victim of a self-inflicted gunshot wound to the head. According to several sources in the Haitian press, Bacellar had participated in a tense meeting with the president of Haiti's Chamber of Commerce, Dr. Reginald Boulos, and Group 184 leader Andy Apaid the night before. Bacellar had been opposing US and Duvalierists Haitian Mafia, policy which was forcing him to murder Fanmi-Lavalas supporters. According to Reuters "The general had insisted that his job was to defend the Haitian constitution, but not to fight crime," the Independent of 9 January reported. On the night of September 21 2003 Amiot Metayer, one of the popular heroes of the resistance against both the Duvalier and Cedras dictatorships, was pumped full of bullets and thrown in a ditch. His murder apparently served the interests of those who would benefit from edging Haiti closer to the brink of outright civil war. The murder further destabilized Haiti as the opposition began spreading the rumor that President Aristide was behind the killing. Infiltrated, confused and demoralized, the population of Gonaives was initially manipulated into turning against Fanmi-Lavalas, the very movement they had sacrificed so much blood and so many lives to build.

G. The Western media continues to play a major role in the destabilization of Haiti. Their orchestrated negative portrayal of President Aristide and the criminalization of the Fanmi-Lavalas Party and false portrayal legitimize the repressive tactics and actions of the US in Haiti. Less overtly imperialistic under the U.N./US banner is the role DynCorp Int., who manages the U.S. Federal Bureau of Prisons, has played in the criminalization of the Fanmi-Lavalas Party. Under the transitional government of Haiti DynCorp Int. trained MINUSTAH and the HNP to combat the criminalized Fanmi-Lavalas members who fought the illegal occupation of Haiti. A majority of Fanmi-Lavalas members were imprisoned and DynCorp Int is in the process of building more jails in Haiti to profit off the suffering of the people. All Fanmi-Lavalas supporters became political prisoners in their own country under UNSCR 1542. Between 2004 and 2006 during foreign occupation by DynCorp Int. and MINUSTAH's multinational troops headed by Brazil; from 14,000 to 20,000 Haitians were slaughtered with total impunity. These were mostly FanmiLavalas supporters who opposed the illegal occupation and regime change. Not only is MINUSTAH directly responsible for the murder and killing of Fanmi-Lavalas political party members, but DynCorp Int. is also responsible for the training of the Haitian National Police (HNP) into a para- military force to kill Fanmi-Lavalas party members. DynCorp Int is in the process of building more jails in Haiti to profit off the suffering of the people.

H. 2008, US State Department Contract in Haiti and Liberia for \$7 million dollars illustrates DynCorp's involvement in the HNP. DynCorp provided training for at least 444 HNP officers. In 2013, DynCorp is awarded yet another contract in Haiti for training and providing support to police worth \$48.6 million dollars. The contract is issued by the US State Department through the Criminal Justice Program Support (CJPS) initiative. Haiti is one of the few countries where DynCorp Int. has contracts from the USG to train and support the Haitian National Police force (HNP) and is also a key player in providing international officers to serve in the U.N. Stabilization Mission in Haiti (MINUSTAH). In addition, DynCorp affiliates provide corrections advisors for training and support of prison workers. In keeping with their training by DynCorp Int. the HNP degenerated into a para-military force which targeted Fanmi-Lavalas members. More than 600

members of the HNP have been dismissed from the force for crimes that include rape, drug trafficking, and murder, the most recent purge being in June 2014.

4. The United Nations Security Council Resolution 1892 issued on 13 October 2009 which made William J. Clinton UN Special Envoy to Haiti 6 months before the Haitian earthquake and Executor of the IHRC Funds in lieu of:

A. Haiti received its' own version of 9/11 on January 12, 2010 when it was hit with a 7.0 Earthquake which killed over 300,000 people and left 1.5 million homeless. This tragic event would go on to propel Haiti back onto the world stage with the United States acting as its' benefactor; coming to the aid and rescue of Haiti. Then president Barack Obama would go on to hold a press conference flanked by former US presidents George Bush and Bill Clinton in which all types of promises were made and people across the world were told to send money in order aid and rebuild Haiti. Due to the prestige of Haiti's now infamous revolution and the dire straits it's been held in since they collected record amounts of aid. The whole world responded to the tune of 14 billion dollars which was raised for Haiti relief efforts over a period of 5 years. 3 years later the money would disappear and Haiti would be left standing all alone with nothing to show for all the pain and misery this tragic event caused. On January 15 the UN Secretary General Ban KiMoon and Bill Clinton, the UN special envoy to Haiti, launched an appeal at a meeting with diplomats in New York for nearly \$1.5 billion in earthquake relief which was almost three times the world body's initial request, that never made it to Haiti. How did the UN know Haiti would need a Special Envoy a major catastrophe 6 months before it happened?

WikiLeaks launched a searchable archive for over 30 thousand emails & email attachments sent to and from Hillary Clinton's private email server while she was Secretary of State. The 50,547 pages of documents span from 30 June 2010 to 12 August 2014. Approximately 7,570 of the documents were sent by Hillary Clinton. The emails were made available in the form of thousands of PDFs by the US State Department as a result of a Freedom of Information Act request. The final PDFs were made available on March 3, 2017. Wiki-leaks is important because it exposed the hypocrisy behind the humanitarian efforts of Washington DC in Haiti. A study of wiki-leaks shows that the aftermath of the Haitian earthquake was used as a pretext for the US and its' Western allies to profit off the misery of the Haitian people. The Interim Haiti Recovery Commission (I.H.R.C.) was set up by UN Special Envoy William J Clinton in the aftermath of the Haitian Earthquake of January 12, 2010. According to the U.S. State Department the IHRC is co-chaired by the Government of Haiti and the UN Special Envoy to Haiti but the Haitian Parliament was coerced and forced into voting to dissolve itself by the Clintons in order to make way for the IHRC. It was co-chaired instead by Clinton and Laurent Lamothe (a former Haitian prime minister embroiled in the Petrocaribe scandal) and allowed a group of rich donors to run the country for 18 months in a pay for play scheme. Slightly more than three months after the earthquake, on April 21, 2010 the IHRC was inaugurated. UNSCR 1892 mandated that all UN member states, international and nongovernmental organizations had to coordinate with the Interim Haiti Reconstruction Commission (IHRC) in order to access the Haitian Relief Funds but in practice this mandate was never followed and left the Haitian government completely out of the equation. As the reconstruction money poured in, the IHRC became increasingly arrogant and opaque. Haitian

ministers and elected officials were blocked from IHRC meetings because they were “not on the list.” In addition, they even gave themselves the power to grant titles which led to them taking land without compensating people. The IHRC displaced Haitian farmers off of nearly 600 acres (240 hectares) of land in order to construct what is now the Caracol Industrial Park, without compensation. The IHRC requested aid in the Name of Haiti yet never coordinated with the Haitian government at all. The IHRC is estimated to have collected \$5.3 billion over two years and \$9.9 billion over three years totaling to a whopping 14 billion after 5 years, without reconstructing much of anything.

The IHRC ended up operating as a pay to play unelected government, where political participation was based on money, 14 billion in Haitian Relief Funds never made it to the people, which is a sad referendum of how leaders of supposedly “progressive democratic parties” actually run countries. All major projects, those worth 10 million U.S. dollars or more, had to be approved by the IHRC Board of Directors. Breaking with the IHRC charter, William J Clinton and Max Bellerive gained the right of final approval over all major construction projects in Haiti. According to a leaked Wiki-leaks email of government messages a senior aide to Secretary of State Hillary Clinton was coordinating with a Clinton Foundation official to identify FOB’s (Friends of Bill) in order to prioritize them for contracts in Haiti with the IHRC. This isn’t the first time the Clintons have prioritized (Friends of Bill) in pay to play politics. During his tenure as Governor of Arkansas William J Clinton was implicated in a money laundering scheme associated with the Iran/Contra scandal. Arkansas legislators voted on a Bill creating the Arkansas Development Finance Authority (ADFA) to provide low interest bond loans to churches, schools and colleges. Instead ADFA, represented by the Rose Law Firm where Hillary Clinton worked as a lawyer and lobbyist, made low interest bond loans strictly to (Friends of Bill). The ADFA was at the center of financial dealings in which large amounts of money could be moved around easily and discreetly with no detection.

According to Clinton associate Larry Nichols who worked at ADFA a 100 million dollars a month came in thru Mena, Ark which was laundered by the ADFA; the ADFA was part of the Clinton Political machine and made loans for campaign contributions; ADFA dealt with bond structuring and applications; they moved money to Florida, Georgia, BCCI, City Corps in New York sent it overseas; Dan Lasater would get bonds, became broker and transfer money back to ADFA; they never sold any bonds; money left ADFA went into one of the banks for a specific bond loan and they would zero it out; every loan made at ADFA Governor Clinton signed off on; pay for play low interest bond loan went to Friends Of Bill (FOB); Governor Clinton used cover of state agency to launder money. Because ADFA was not subject to legislative oversight- being solely within the purview of the governor’s office- and because of the loose strictures upon the trustee bank, it also opened the gate for questionable, possibly illicit financial dealings.

As IRS man Bill Duncan explained, theoretically, bonds could be issued to provide a loan to a company involved in laundering drug profits. That loan represented clean money. The loan could in turn be paid back with drug profits, slowly over time and in small increments. In this way drug money could be successfully filtered into the legitimate financial system. If the company in question did nothing more with the loan than redeposit it into its bank account, then the company had lost nothing but it had gained clean money. Thus, in effect, ADFA could serve as a washing

machine – dirty money could be cleaned simply by passing through its system. Duncan suggested that it would also be possible for ADFA clients never to repay a loan and for the money simply to be circulated through the trustee's investment end of the arrangement. Bill Duncan and Russell Welch were targeted by Gov Clinton, who hampered their investigation into Mena, Ark and refused to prosecute. CIA agent Terry Reed, familiar with the commercial affairs of Mena, quit once he discovered drugs were involved in the operations being run and asserts that large sums of drug money were being laundered through leading Arkansas bond brokers, an allegation also being considered by a federal investigator just as his researches were abruptly terminated. Thru the Arkansas Development and Finance Authority (ADFA) the Clintons laundered money from the Mena, Ark operation. Hillary Clinton worked at the Rose Law Firm which was the lobbyist for ADFA. Every case that linked the Clintons to criminal activities were effectively shut down by various government agencies.

The 7.1 billion dollars that went missing from the Haitian Disaster Relief Funds was no accident. After decades of keeping the Haitian government despotic, there is no way the US would let the Haitian government receive that kind of aid. Special Envoy Bill Clinton utilized the IHRC to launder 7.1 billion of the Haitian Disaster Relief funds like he utilized the ADFA to launder drug money from Mena, Ark.. Eric Braverman was the CEO of the Clinton Foundation at the time of the Haitian earthquake and helped set up the IHRC with William J Clinton as a mechanism to funnel 7.1 billion of disaster relief funds thru USAID and the World Bank out of Haiti. Bob Zoellick was the president of the World Bank at the time, the same man involved in the Haiti 1985 Farm Bill. The US and Clintons have a long history of utilizing implicit coercive policies to destabilize Haiti. From the 1996 Farm Bill which destroyed Haiti's rice farming to the 1.3 million pigs killed due to destructive policies of USAID and OAS. Haiti Wiki-leaks helped reveal Washington DC for the frauds which they truly are. William J. Clinton, the UN special envoy to Haiti stated to members of the Haitian government that they couldn't prosecute him for the misappropriated Relief Funds due to diplomatic unity. Diplomats are immune except in circumstances when in connection with any role they may play as executor or heir to an estate being distributed in the host country. Only sovereign nations can grant diplomatic immunity, as UN Special Envoy and Executor of the IHRC diplomatic immunity doesn't protect him from being prosecuted for the funds not distributed during Haiti Relief efforts. It is the duty of the UN, who made William J. Clinton special envoy to prosecute and return these misappropriated funds to the republic of Haiti. Diplomatic immunity is not intended to serve as a license for persons to flout the law; the UN must not ignore or condone the commission of crimes which violate International Law.

The Clinton Foundation wasn't operating lawfully as a tax-exempt organization in Haiti. Wikileaks revealed that it was originally formed to build a presidential library for Bill Clinton. It began work in Haiti in 2003 but it didn't have clearance from NY authorities to operate internationally, which is why no official audit was conducted for several years. It failed to fill out its' 990's from 1998-2007 aggregating their government grants. Not authorized by the IRS to engage in activities such as fighting HIV/AIDS, disaster relief, and climate change internationally, which is more fruitful than fundraising. It hasn't complied with NY laws which clearly require the identity and amounts of all government grants (domestic and foreign) be reported. The Clinton

Foundation is a massive operating and solicitation fraud; in order to solicit in most states and nations it had to register making truthful declarations. The registration for the Clinton Foundation shows that it was raising money for a presidential library based in Little Rock, Ark.

B. Washington DC has authorized hundreds of billions of dollars to Haiti thru institutions like the International Monetary Fund and the World Bank since their 1915 occupation, yet has failed to raise the standard of living in Haiti one iota. The reason Washington DC is able to steal the 14 billion under the guise of Humanitarian assistance after a 7.1 Richter scale earthquake which killed 300,000 and left 1.5 million homeless is because they own Haiti already. Haiti's politicians, bankers and oligarchy control the Haitian government and economy as overseers for Washington DC. They're super rich, pay no taxes, and provide no sustainable investments beneficial to Haitian society. As long as they live well, they have their mansions, their yachts, their limousines, they go to New York to the UN and have their suites at the Waldorf-Astoria and that's all they care about. Forsaking the Haitian ideology after being purchased with fiat currency by the IMF/World Bank Haitian politician follow their lead pilfering government funds as the people suffer as in the Petrocaribe scandal. The inefficiency of the Haitian government is what allowed the earthquake in Haiti and the disastrous response to it. That's why SOUTHCOM was "coincidentally" in Haiti running Complex Command and Control Emergency Relief Drills before the earthquake.

The malfeasance of Washington DC; IHRC; US state department agencies; US NGOs; the United Nations; foreign church groups; and international banking institutions are exposed thru the lens of the available 307 wiki-leaks of U.S. government cables/emails on Haiti released on March 16, 2016. Scarcely a month into the reconstruction process, it was being described in a diplomatic cable as a 'gold rush' for government contractors and aid groups." On February 1, the US Ambassador to Haiti, Kenneth Merten, cheerfully titled a section of his situation report, "THE GOLD RUSH IS ON!". One of the most disastrous policies of the Duvalier era was their use of U.S. non-government organizations to fill in what their government could not or would not do for the Haitian people which had "elected them". Ever since their departure these US state funded NGO's Have basically been governing Haiti. leading to a what still exists today. It was these same NGO's, which have a heavy presence in Haiti till this day, who were so ineffective after the 2010 earthquake.

The IHRC mishandling of Haitian Relief Funds didn't happen because of UN Special Envoy William J Clinton alone. The IHRC was co-chaired by former Haitian prime minister Laurent Lamothe and besides the FOB; the Haitian bourgeoisie; corrupt Haitian politicians benefitted from IHRC contracts also. Ever since the Duvalier Regime the politicians in Haiti have been funded by Washington DC and become addicted to the international welfare of United Nations funding. 98% of the Haiti Disaster Relief Funds raised stayed within the IHRC and never reached the people. WikiLeaks revelation of a Clinton official statement that Haiti is "open for business" was a veiled term for foreign companies to exploit Haiti. The vast majority of Washington DC contracts went to NGO's and American firms operating in Haiti. At least 500,000 Haitians are still living in relief camps as a new five star hotel Marriott hotel was constructed for foreigners funded by the IHRC. Almost no cash ever went to or was intended to go to Haitians or the Haitian government to assist the people. The Center for Economic and Policy Research (CEPR) analyzed the \$1.15 billion pledged after the January 2010 quake to Haiti and found that the "vast majority" of the money it

could follow went straight to U.S. companies or organizations, more than half in the Washington area alone.” The economic elites made billions upon billions before the \$9 billion the US “bighearted humanitarians” would add to their coffers from laundering earthquake relief dollars largely back to US groups. During the Duvalier regime the Medellin Cartel began using Haiti as transshipment point for cocaine. Even Pablo Escobar built social infrastructure for the people of Columbia where 10% of people own 90% of the land. Washington DC and the Haitian government have made billions thru the utilization of Haiti as a transshipment point for cocaine while they kept the Haitian population in a state of misery.

C. Wiki Leaks continued to expose corruption when they revealed evidence of sex trafficking in Haiti which is why Haitian people were vying for their release. NYPD Chief of Detectives, Robert Boyce, said the Clinton emails contained evidence of sex crimes, child exploitation, money laundering, pay to play, etc. in Haiti. The IHRC was connected to child sex trafficking in Haiti on January 29, 2010 when Laura Silsby was caught and arrested for trying to kidnap 33 kids in Haiti. Silsby is the former director of “The New Life Children’s Refuge” and the leader of a group of 10 U.S. Baptist missionaries who attempted to transport Haitian children without that government’s approval, out of the earthquake ravaged nation. She was eventually convicted and released for time served due to the influence of Hillary Clinton. Declassified WikiLeaks of government emails revealed that Clinton staffer Huma Abedin was “constantly forwarding emails to Hillary Clinton” about Laura Silsby’s situation. The lawyer who pretended to defend her in court was Jorge Puello who is wanted by police in at least four countries in connection with charges of sex trafficking of girls and women; making counterfeit documents; and violating parole. These child sex traffickers are connected to (NPH) Friends of Haiti who run 760 orphanages in Haiti thru Max Maccoby who is on the Board of Directors. Ezilio Danto former Fanmi-Lavalas lawyer prosecuted the project Pierre-Toussaint and its founder Douglas Perlitz for sexually abusing boys in their care. There is evidence of child sex trafficking started thru US stated dept. funded NGO’s and orphanages in Haiti.

5. UNSCR 940 issued on 31 July 1994 is responsible for the incursion of DynCorp Int. into Haiti and providing technical and logistical support to HAARP and SOUTHCOM on January 12, 2010 in Haiti in lieu of:

President Hugo Chavez of Venezuela cited a report from Russia’s Northern Fleet which stated that the US used the High Frequency Active Aurora Research Program (HAARP) to cause the earthquake which struck Haiti on January 12, 2010 killed 300,000. According to the report, the U.S. Navy made a "mistake" with a secret “earthquake weapon” and the result was the Haitian earthquake. The Russians report believes the intended target was Iran. “Though Russian Northern Fleets’ report was not confirmed by official sources, the comments of President Hugo Chavez attracted special attention in some US and Russian media outlets including Fox news and Russia Today,” states Pragmatic Witness blog. The Russian Report also stated that Moscow has also been accused of possessing and utilizing such weapons. The High Frequency Active Aurora Research Program (HAARP) is a U.S. government atmospheric research facility in Alaska. The program is based on an invention and research of world renowned scientist Nikola Tesla.

What makes the allegations of President Chavez valid is that U.S. Southern Command SOUTHCOM was "coincidentally" in Haiti on January 11 2010 running Complex Command and Control Emergency Relief Drills, (one day before 7.0 Earthquake). DynCorp Int., which is part of the clandestine operating division of the CIA, was coordinating the efforts of SOUTHCOM on these Relief Drills. On Monday, Jean Demay, Defense Information Systems Agency (DISA) technical manager for the agency's Transnational Information Sharing Cooperation Project (TISCP), happened to be at the headquarters of the U.S. Southern Command in Miami preparing for a test of the system in a scenario that involved providing relief to Haiti in the wake of a hurricane. Coincidentally after the 7.1 earthquake hit Haiti on Tuesday, Jean Demay said SOUTHCOM decided to go live with the system. On Wednesday, DISA opened up its All Partners Access Network (APAN), supported by the TISCP, to any organization supporting Haiti relief efforts. SOUTHCOM assumed control of the Haiti's largest commercial airport, yet most planes with humanitarian assistance from; CARICOM; the Caribbean Community; Médecins Sans Frontières; Brazil; France; Italy; and even the U.S. Red Cross; trying to land were turned away by them. According to the report, it is "more than likely" that the U.S. Navy had "full knowledge" of the catastrophic damage that testing HAARP's earthquake capabilities could potentially have on Haiti and had pre-positioned its Deputy Commander of the Southern Command, General P.K. Keen, on the island to oversee aid work if needed. The U.S. killed well over a million Iraqis in their "War on Terror", why not 300,000 Haitians. The U.S. Southern Command began its work of "humanitarian invasion" by sending at least 10,000 soldiers and contractors, to control Haitian territory, rather than the UN, after the devastating "experimental earthquake." Since the earthquake the country's largest commercial airport has resembled a military base, with more than 100 armed forces and UN flights passing through each day. The U.S. has clearly exploited the earthquake to send the military to the stricken island nation. They brazenly occupied Haiti without consulting the UN or the OAS (Organization of American States). This isn't the first time, the precedent was set on Bikini Island, Washington DC has used a Weapon of Mass Destruction on an unsuspecting public. Haiti didn't gain its independence to be reduce to being Guinea Pigs for Washington DC. During my service in the USMC, I was trained on the use of WMD's and non-violent weapons, and believe they're utilizing HAARP to intimidate the Haitian population into submission, not only was it used on January 12, 2010 but also; October 6, 2018; October 17, 2018 to keep the people from overthrowing their oppressive government. ,

The Russian Northern Fleet Report indicates that the earthquake which devastated Haiti was clearly the result of HAARP as a test by the U.S. Navy of the earthquake capabilities of this weapon of mass destruction. HAARP may have been utilized by Washington DC covertly to create Hurricane Katrina; Hurricane Matthew; Hurricane Maria. The report drew up a diagram of linear succession in relation to earthquakes reported to have occurred by chance to the same depth in Venezuela and Honduras. It can be observed that there is a correlation between seismic activity and the ionosphere, through the control of Radio Frequencies Induced by force fields, which is a HAARP feature. The HAARP project can also create anomalies in the climate causing floods, droughts and hurricanes and may have also been the cause of Hurricane Mathew. Since the end of the decade of the 70's in the last century, the U.S. "advanced a lot" in the state of its earthquake weapons and, according to these reports they now use equipment with; Pulse, Plasma and Tesla Electromagnetic and Sonic technology; together with longitudinal EM wave interferometers (LWI) technology; also known as "Tesla howitzers" to create "shock wave bombs". LWI waves can effortlessly pass through the

ocean and earth. Experts claim LWI waves can in fact pass through the earth and emerge on the other side. Leading-edge scientists are describing global weather as not only air pressure and thermal systems, but also as an electrical system. The United States and Russia have possessed this technology for decades. HAARP is actually based on the research and invention of Nikolai Tesla called the "Tesla Coil". All of Nikolai Teslas's inventions and research were confiscated by the C.I.A. after his death. Tesla would rather the US have his inventions because he didn't want the Nazis (who were after them) to get their hands on his inventions and research to weaponize them but the US did that anyway. An interesting fact is that Tesla invented a machine which could provide free Wi-Fi electricity to the world. It's a dire state of civilization when a government won't develop an invention which could give free energy to the world but develops one which a weapon of mass destruction.

7. The United Nations Security Council Resolution 1892 is responsible for the IHRC-Clinton fraudulent election and return to power of the Duvalier Party in Haiti and use of Petrocaribe money to purchase a narcotics transshipment point in lieu of:

In June 1985, the Haitian legislature unanimously adopted a new law requiring that every political party must recognize President-for-Life Jean-Claude Duvalier as the supreme arbiter of the nation, outlawing the Christian Democrats, and granting the government the right to suspend the rights of any party without reasons. The law, which was ratified by a majority of 99.98%, impressed his handlers in Washington D.C.. It was "an encouraging step forward," the US Ambassador informed his guests at a July 4, 1985 celebration. The Reagan Administration certified to Congress that "democratic development" was progressing, so that military and economic aid could continue to flow into Haiti and mainly into the pockets of Baby Doc and his entourage. This is why the public claims of the U.S. government and media that the Haitian government is corrupt ring hollow because it is the kakistocracy which it puts in place; supports; and uses to exploit nations under the guise of democracy. It is actually the American government which is as corrupt today as it was when its colonies first established itself on American soil. The American "Founding Fathers" were actually land speculators figuring out how to steal land from the indigenous American population. America has continued its pattern of colonization thru the Doctrine of Discovery with policies like the Monroe Doctrine which has had a disastrous effect on the Americas.

The Reagan Administration also informed Congress that the human rights situation was improving under Duvalier, the man who just declared himself President-for-Life. The Duvalier regime was just a continuation of kakistocracies established in Haiti by the U.S. since their 1915 military occupation of the island but it was one of the most brutal. The U.S. backed Duvalier government is estimated to have murdered between 20,000 and 50,000 Haitians during the time period of 1957-1971. Duvalier created a private military force called the Ton Ton Macoutes whose sole purpose was to get rid the country of all opposition and terrorize the Haitian people. The Ton Ton Macouts swelled to 15,000 by the mid 80's and helped Duvalier rule by means of constant repressive violence. . The self-proclaimed leaders of the Free World supporting imperialistic despotic regimes globally thru "democracy". The Democrat-controlled House Foreign Affairs Committee had given its approval in advance, calling on the Administration "to maintain friendly relations with Duvalier's non-Communist government." Despite what the average American

citizen believes Washington DC is always willing to provide "aid" to a government suppressing a population fighting for authentic representation of the people.

The excuse Washington DC used is that they were fearful of Haiti falling under the influence of communism after their successful liberation and revolution of Cuba by Fidel Castro and Che Guevara on July 26, 1959. What's interesting is the fact that they were willing to look the other way when Cuba Meyer Lansky was trying to turn it into a gambling and narco state under Cuban president Batista. Batista left Cuba with 300 million n left for Dominican....François Papa Doc Duvalier learned everything he knew from Washington, dc because he was trained by their military schools. While poverty among his people remained the most widespread of any country in the Western Hemisphere. Jean-Claude Duvalier allegedly stole the equivalent of 1.7% to 4.5% of Haitian GDP for every year he was in power. The only other two other kleptocrats to come as close a percentage of GDP were Ferdinand Marcos (Philippines) and Sani Abacha (Nigeria).

In Haiti the Duvalier dictatorships left a terrible legacy: 1% of the population owns 48% of the wealth of the country; the illiteracy rate is about 60%; he waged a war on educated Haitians, an estimated 80% of Haitians employed in professional fields fled Haiti under this oppressive regime headed by a terrorist. The ramifications of this fleeing to technology and research, education and health care cannot be over-estimated. Many poor Haitians attempted to leave the country, overcrowding boats that transported them to the United States. The US refused them entry and refugee status which is ironic because they were fleeing turmoil in Haiti which was created by the US. It is the normal pattern of US colonial policy towards Haiti and other nations of color. In the public arena they smile and tout of bringing democracy to "save" or "civilize" nations of color; subliminally referring to them as savages, while exploiting these nations in a myriad of ways. During his campaign against President Bush, President Clinton criticized his inhumane policy of not accepting Haitian refugees (whom he referred to as the boat people), yet during his administration he did the same thing. It's ironic that Haiti who brought freedom to a colonized world is now being colonized by a democratized world. A lot of smart and true Haitians were force to flee leaving a void which was filled by corrupt Haitians on the US payroll ready do the bidding of their employers in keeping the nation from progressing. The reason for this US policy towards Haiti is due to the fact that most of the revolts in the US during institutional of slavery were started by Haitians.

After the fall of the Duvalier regime, the Haitian State became politically and economically dominated by a small mulatto elite (approximately 5%), former members of the Duvalier Party, and the military gyndemiè left in place since the 1915 U.S. occupation. Whereas the politically marginalized majority of black peoples (approximately 95%) began to form the foundation of what would later to become known as the Fanmi-Lavalas Party. A rural priest in a small church, Father Jean-Bertrand Aristide, said that "we're glad Duvalier is gone" but "what we now have is Duvalierism without Duvalier." The phrase "Duvalierism without Duvalier" is a popular phrase in Haiti and represents the policy the US has been pushing in Haiti since the overthrow of this evil dictator. Many of the problems faced by Haiti today can be traced back to the monstrous policies of the Duvalier regimes. One of the most disastrous was their use of U.S. non-government organizations to fill in what their government could not or would not do for the Haitian people who had "elected them"; leading to a heavy presence that still exists today. These state dept. funded NGO's formed a network which actually ran Haiti and was so ineffective after the 2010 earthquake.

"Duvalierism without Duvalier" was in effect when the IHRC-Clintons elected Michel Martelly. The IHRC was to hand over governance to the Parliament and a newly elected president when their 18 months were done. It seems that the Clintons were determined to handpick the winner. The wiki-leaks of secret government cables reveal that Hillary Clinton chose Michel Martelly for a legislative coup de tat after the IHRC was done exploiting Haiti. When Michel Martelly lost in the first round of elections, Hillary Clinton had him replace candidate Jude Celestine on the ballot in order for him to make it to the second round. The evidence is overwhelming that the OAS, with the complicity of Secretary of State Hillary Clinton and her chief of staff Cheryl Mills, changed the votes in 2010 to place Michel Martelly into the runoff. According to leaked wiki-leaks government emails, after the Nov. 28 first round, the U.S. government revoked and eventually returned visas of President Préval loyalists, as part of its pressure tactics to get him to replace his party's candidate, Jude Célestin, from the runoff in favor of singer Michel Martelly. Secretary of State Hillary Clinton flew to Port-au-Prince in January 2011 to pressure Préval to supplant Célestin with Martelly. That was when Préval understood he had no way out and capitulated to the change Clinton wanted and replaced his candidate with Michel Martelly on the ballot. As usual, Préval complied, although the CEP members, constitutionally the "final arbiter" of any Haitian election, never validated the US altered election results. After a second-round contest with exceptionally low turnout, Martelly was named the winner over Manigat. The Haitian government eventually requested that a mission from the Organization of American States (OAS) come to Haiti to analyze the results. The mission, despite not conducting a recount or any statistical test, recommended replacing Célestin in the runoff with Michel Martelly.

Pressure began building on the Haitian government to accept the recommendations. Government officials had their U.S. visas revoked and U.S. Ambassador to the U.N. Susan Rice (Boule) even went so far as to threaten to cut aid, even though the country was still recovering from the devastating earthquake earlier in the year. Secretary of State Clinton "pressured then-President René Préval with the loss of U.S. and international aid unless the election results were changed to fit the OAS's recommendation," which was, in fact, her recommendation. This was how former President Michel Martelly came to power. He was declared the winner of the second round in March 2011, with a record low voter turnout of 22 per cent, less than half the previous 2006 elections. The presidency of Michel Martelly marked the return of the Duvalier Party to power in Haiti. Due to the lack of CEP validation these elections were deemed fraudulent. It wasn't even clear if Martelly should have been allowed to run due to his citizenship status.

The reason the Clintons wanted Michel "Sweet Micky" Martelly elected so badly was because he was a former member of the Duvalier regime and they wanted a return of the Duvalier Party to Haiti. Michel Martelly is a popular musician who shared the nickname "Sweet Mickey" with the late army lieutenant colonel, police chief, and Fort Bragg graduate, Joseph Michel "Sweet Mickey" Francois, a subsequently indicted drug smuggler and one of the main authors of the bloody first U.S.-backed regime change (Sept. 30, 1991) that overthrew President Jean-Bertrand Aristide. He was also an associate of Guy Phillippe leader of the para-military group which overthrew Aristide on Feb. 29, 2004 and convicted drug trafficker. "We have been on the wrong road for the past 25 years" Martelly declared after being elected, placing Haiti's wrong turn, in his opinion, at about the time of the U.S. backed Duvalier dictatorship's fall and the emergence of the democratic nationalist

movement that became known as Lavalas. The Duvalierists revile Fanmi Lavalas cause they refuse to be US puppets. The most notable feature of the Haitian Constitution of 1987 was Article 291 which prohibited Duvalierists from seeking public office for the next ten years. But that Article has never been fully implemented due to the role the US state dept. plays in Haiti.

During his tenure as president Michel Martelly continued the policies of "Duvalierism without Duvalier". He basically turned the Haitian Treasury over to the U.S.. He also started a remittance fee program which was designed to exploit Haitian diaspora. The central bank of Haiti began charging 1.50 for each wire transfer and 5 cents per min on phone calls to the country. This remittance program went into effect in June 2011 and the money has been accumulating since then with no accountability. President Michel Martelly also pilfered the Petrocaribe program with his administration having nothing to show for it. Petrocaribe was a program created in 2004 by under the sponsorship of Venezuelan President Hugo Chavez. Under the current PetroCaribe terms, Haiti pays up front 40% to 70% of the value of the petroleum products it imports from Venezuela such as asphalt, 91 and 95 octane gas, heavy fuel oil (mazout), diesel and kerosene with the remaining 60% to 30% paid over 25 years, with a two year grace period, at an annual interest rate of 1%.

President Jovenel Moïse was put in power in 2017 by ex-president Michel Martelly via a fraudulent election thru his Tet Kale party, endorsed by the US/UN/NGO occupational forces, establishing a Narco-State in Haiti. The election of Moises Jean, a friend of Martelly and member of the Duvalier Haitian Tèt Kale Party, is not valid because the election was filled with fraud. What makes this situation worse is the fact that the Haitian government paid for this election yet there was still massive fraud, and they had an unwanted candidate forced down their throats. A reliable Brazilian exit poll suggests that Moise Jean didn't win, coming in fourth, not first, with just 6 percent of the vote, yet it was reported he won with 90% of vote in the November 20 elections. This was done because the US backed transitional government doesn't want a Fanmi-Lavalas led administration. He is a macoute-bourgeois and has been recently accused of laundering drug money for the Clintons in Haiti, which is why he had to address DEA charges before taking office.

Protests erupted in Haiti on July 6, 2018 when fuel prices were raised by 50% as part of a plan endorsed by the IMF to modernize the economy. President Jovenel Moïse was forced to fly out of the country to get instructions from Washington DC. The government canceled the scheduled increase amid nationwide protests that left several people dead and prompted airlines to cancel flights. In the aftermath, Haiti's Prime Minister Jack Guy Lafontaine and his cabinet were forced to resign. Haitians, angry over years of unchecked corruption and lack of development, began asking where the Petrocaribe money went and are still protesting to this day. Following the 2010 Haitian earthquake, Venezuela forgave 295 million in debt Haiti had accrued since joining the program in 2006. In terms of numbers, Petrocaribe doubled Haiti's budget and funds available for investments, although they are loans. Today, the debt in this account is at \$3.4 billion [USD] after just 5 years. In a nation which had before only brought in tax revenues of \$325 million [USD] per year, where \$3.4 billion has disappeared to is a common concern of political observers. A Haitian Senate Committee report determined 1.7 billion of no-bid contracts given by the government between 2008-2016 which all used Petrocaribe money. Money was paid out yet no projects were completed. All of this augurs woe for Cuban and Venezuelan projects in Haiti, and possibly for the Petrocaribe agreement, despite its tremendous and evident contribution to the Haitian people's welfare.

Jovenel Moïse was indicted for money laundering just days before he took the oath as president of Haiti, yet he was granted immunity for 5 years and allowed to take office by the US justice department. It is just the continuation of a permanent kakistocracy which Washington DC has placed on Haiti. Jovenel Moïse's major asset is a banana plantation and export business called Agritrans S.A., which was launched in 2013 through a loan of \$27 million and grant of 1,000 acres from the President Michel Martelly administration, out of the National Treasury. This transaction was made possible by the Petrocaribe agreement whose funds were used to build this banana plantation. Moïse, a known drug trafficker uses this banana plantation, which has an airstrip, as a front for a transshipment point for narcotics reminiscent of Mena, Ark.. President Jovenel Moïse is guilty of illegally using Petrocaribe funds to purchase his banana plantation and expand his illicit drug empire in Haiti. He was kept in power for the utilization of Haiti as a covert drug transshipment point the Clintons and Washington DC. Mena, Arkansas was as a large scale clandestine drug smuggling operation connected to the Iran-Contra hearings. The president of the Haitian senate accused the Clintons of drug running and fraud after IHRC debacle. Washington DC has created a narco state in Haiti which is worse than Cuba before Fidel Castro cleaned it up. The Duvalier/Tet Kale party is full of drug dealers and the Clintons are using them to build their nacre state. Under the Clinton-Martelly led presidency Haiti became influenced directly by wellconnected drug dealers. The Parliament is heavily ruled by active gun and drug traffickers. The legal system is the hands of gangsters and the wealthy but repugnant billionaires of the Caribbean. Guy Philippe, Hervey Four and, Your Latitude, Joseph Lambert, Senator Willet Joseph is all participants of the Haitian government and connected to drug activities within Haiti and US by the DEA but never fully prosecuted. Washington DC's utilization of Haiti as a trans-shipment point has turned it into a country where illicit drug activities dominate the economy, define political choices and determine the fate of foreign interventions.

The Washington DC Banking Cartel, which plays a behind the scenes role in the formulation of US foreign policy, thru Council of Foreign Relations(CFLR) has a vested interest in retaining Haiti as a transshipment point. The installment of a reliable "narco-democracy" in Haiti effectively protects their transshipment routes. The U.S. backed thug parliament and Duvalier/Tet Kale regime geared towards the protection of this multibillion dollar narcotics transshipment trade through Haiti, from production sites in Colombia, Peru and Bolivia. Michel Martelly during a preinauguration meeting with Colombia's Foreign Minister, stated it's their development plan he will emulate, referring to the cocoa they're known for. It is estimated that Haiti is now responsible for 14 percent of all the cocaine entering the United States, representing billions of dollars of revenue for the C.I.A. and US financial institutions which launder vast amounts of dirty money. The global trade in narcotics is estimated to be worth in the order of 500 billion dollars. In the early 1990's a white house report documented more than 250 tons of coke were smuggled into the US through Florida in a year, primarily from Haiti, while 100 tons flowed thru the southwest border. By the end of the decade 200 tons came thru both boundaries and in subsequent years the amount of cocaine coming thru Haiti fell, accounting for less than 10% smuggled into the US.

According to biographer Roger Morris William J Clinton worked as CIA asset posing as a Rhodes Scholar in England as part of Operation Chaos. While William J. Clinton was governor an airstrip in Mena, Arkansas became popular during the Iran/Contra scandal. It was utilized by USMC Lt Col Oliver North, during the Reagan presidency, for a large scale clandestine drug smuggling operation for the CIA. According to CIA agent Terry Reed author of "Compromised-Clinton,

Bush and the CIA" stated he was approached by MC Lt Col North to work on the Mena Project in the fight against communism. CIA Agent Terry Reed was brought on to train Nicaraguan soldiers to pilot small planes for the Contras fight against communism. He also worked with Felix Rodriguez who was the Contra link between the CIA and VP Bush's office. Reed worked with Barry Seal on the project who piloted planes on flights thru Mena, Ark for the CIA. Barry Seal's first contact with the CIA came in the 1960s while he served as a pilot for the US Army's Special Forces division. In 1982 CIA asset Barry Seal under pressure from Louisiana cops relocates his drug smuggling operation to Mena, Ark. By 1986 journalists Evans-Pritchard described Arkansas as a "major point for the transshipment of drugs" and "perilously close to becoming a 'narco-republic' a sort of mini Columbia within the borders of US...there is an epidemic of cocaine contaminating the political establishment from top to bottom...with parties (attended by Gov Clinton) at which cocaine is served like hors d'oeuvres and sex was rampant".

Retired DEA agent Celerino "Cele" Castillo testified in 1998 before The House Permanent Select Committee on Intelligence connecting the Reagan administration to illegal narcotrafficking of cocaine yet no grand jury ever heard any evidence of narcotrafficking and the statute of limitations has expired. He had years of experience in fighting drug trafficking in Central and South America, Castillo was familiar with the operations at Ilopango; he was stationed El Salvador in 1985 and reported the use of the airfield to fly illegal drugs into the US. Castillo took off the gloves and named George H. W. Bush as the "kingpin" for the narcotrafficking of cocaine into the US. Castillo wrote that the Boland Amendments curtailed funding to the Contras and the Vice President George H. W. Bush "entered into an agreement with the Columbian drug cartels to exchange guns for drugs. The proceeds of the drug sales in turn were used to secretly fund the Contras." Former Head of the CIA Vice President George Bush played a major role behind the scenes of the Iran/Contra scandal. After the Boland amendment forbid direct funding of Contras, VP Bush and CIA Head William Casey began using the CIA for secret foreign policy. Lt Col North establishing Mena, Ark to help fund the Contras fight against communism was actually a cover for drug smuggling. Operation Pegasus was connected to Vice President Bush who was responsible for Drug Interdiction Operations during the Reagan administration and Iran/Contra. Key Bush staffer Felix Rodriguez was involved in the Iran/Contra air supply effort and approached the Medellin cartel to get them to make a donation to Contras during the Boland amendment for access to transshipment point. CIA clandestine case officer Robert Steele stated on record that Manuel Noriega was told by CIA head Bill Casey that he could have a free run of drugs into America provided he support the Contras from Panama. Clandestine Operation Watch Tower was a series of missions involving US Army 10th and 7th Special Forces. It operated out of Panama and involved the placement of US Army Green Berets inside the Colombian border to plant radar beacons so that low level flights could successfully navigate undetected and land in military airfields to off load cocaine.

According to CIA agent Terry Reed Clandestine Operation Project Enterprise utilized Machinery International was a front corporation at Mena, Ark. Front corporations like Machinery International are utilized by the CIA during covert operations to provide cover for clandestine activities. Machinery International was supposedly making weapons for Contra fighters to fight communism but instead of the Contras the weapons went to the Medellin cartel. The Arkansas National Guard Armory had most component parts within its inventory from which to build guns. The CIA enlisted a clandestine group of manufacturing companies to build critical gun parts which by law create a paper trail from manufacturer to end user. As per CIA instructions no serial

numbers were stamped into parts and no documentation created to leave a trail producing untraceable weapons for the Medellin cartel. Pablo Escobar told his son that he worked with the Company to finance a war against communism and the CIA got a wonderful deal. He did not make money alone but with US agencies which allowed him access to that kind of money. According to his son he had direct relations with the CIA and was just a cog in the international drug trafficking network. When it no longer served them, they killed him. Terry Reed discovered cocaine at Mena, Ark, got cold feet, and went to Felix Rodriguez and quit the operation. Mena, Ark is still operating as a drug transshipment point to this day.

The Attorney General of Louisiana stated to US Attorney General Ed Meese that narcotics trafficker Barry Seal has smuggled 3-5 billion worth of cocaine into the US. Clandestine CIA pilot Barry Seal covertly transported weapons and narcotics for the CIA and Medellin Cartel thru Mena, Ark. He would depart Mena, Ark with a C133 cargo plane capable of 60,000 pounds and cache of untraceable weapons to staging areas in central America and return with loads of cocaine for sale in US. As part of Operation Amadeus CIA pilots flew small aircraft loaded with cocaine into local airports throughout New Mexico under CIA protection. CIA agent Terry Reed asserts that the clandestine CIA operation at Mena, Ark was moved to New Mexico after attracting media attention over the Iran/Contra scandal. Clandestine Operation Amadeus involved military flights of C130's carrying 2-3000 kilos of cocaine per load from South America into the US thru military bases and return flights with cache of weapons. CIA operative Barry Seal wasn't the only pilot trafficking cocaine and drugs under clandestine operation Amadeus. Long time CIA pilot Robert Tosh Plumlee, reported that 50 pilots were involved in this covert operation. He also stated on record that he flew thousands of pounds of cocaine, street value in the billions of dollars, for CIA proprietary airlines on C-130 aircraft into El Toro and Homestead AFB and then flew back with cache of weapons. Plumlee reported that aircrafts had to have transponder codes issued by the US government to cross the Mexican border into US. Gene Wheaton, retired Army Warrant Officer and criminal investigator, provided the tail numbers of 62 military aircraft used in this illegal covert op to US DOJ. They testified to USDOJ but their testimony was never discussed in the Iran/Contra hearings. According to the Kerry Committee Report: "three months before his assassination Barry Seal described in sworn testimony to federal and state investigators a nexus of airstrips, front corporations, "legitimate" Arkansas companies and banks participating in the shipment of drugs and laundering of drug profits. His interrogators IRS agent Bill Duncan and Russell Welch of the Arkansas State Police had hoped to get Seal to gradually detail the bigger picture and were frustrated in their efforts when Seal, then under a drug conviction in Louisiana, was returned to that state for sentencing"

According to the Kerry Committee Report: "Barry Seal and the Cartel Barry Adler Seal, a former narcotics smuggler, was utilized as an undercover agent by the DEA in a highly sensitive operation being run against the Colombian cocaine cartels and officials of the Sandinista regime in Managua. Based upon intelligence the DEA had received, an interest had been expressed by some members of the Sandinista Directorate in providing a base of operations in Nicaragua for the cartels. U.S. law enforcement officials had hoped to entrap both members of the cartels and Sandinista officials in a drug sting being run by Seal. However, the operation was disclosed prematurely by an administration official who leaked to the press evidence supposedly collected by Seal in an effort to influence a pending Congressional vote on Contra aid. Law enforcement officials were furious

that their undercover operation was revealed and agents' lives jeopardized because one individual in the U.S. government-Lt. Col. Oliver North decided to play politics with the issue. Associates of Seal, who operated aircraft service businesses at the Mena, Arkansas airport, were also the targets of grand jury probes into narcotics trafficking. Despite the availability of evidence sufficient for an indictment on money laundering charges and over the strong protests of State and federal law enforcement officials, the cases were dropped. 2 The apparent reason was that the prosecution might have revealed national security information, even though all of the crimes which were the focus of the investigation occurred before Seal became a federal informant"

DEA agent and former Marine Enrique Kiki Camarena was following the money trail of cocaine trafficking into the US when he was kidnapped, tortured and murdered in Mexico in February 1985. In October 2013, the Borderland Beat reported that Camarena was murdered on orders of the CIA because he had discovered the connection of drug trafficking and its profits to support the "counterrevolution" (the Contras). The motive for the murder was to prevent him from blowing the whistle on narcotrafficking of cocaine into the US to fund the Contra War in Nicaragua, according to El Diario de Coahuila and Proceso, the two Mexican newspapers who first broke the story. Cash confiscated at Mena, Ark have been traced to the DEA; it seems the DEA funded the Mena operation with cash seized from the illegal drug trade. An aspect of Operation Amadeus during Iran/Contra was the sale of working Lockheed C-130's and P-3's from the Air Force boneyard in Phoenix, AZ and the Air Museum in MCAS El Toro, Ca to CIA proprietary contractors for use by CIA pilots. USMC Colonel Sabow was Assistant Chief of Staff, 3rd Marine Aircraft Wing when he unwittingly discovered operation Amadeus, a clandestine operation flying weapons and supplies to the Contras on CIA proprietary airlines. MC Colonel James Sabow was found dead in the backyard of his home at MCAS El Toro, CA in 1991. His brother Dr David Sabow, who later proved otherwise, was informed that he had committed suicide 30 min after his body was discovered. Marine Corps Colonel James Sabow discovered C130's flying north from Nicaragua landing at MCAS El Toro with 3000 kilos of cocaine landing in the middle of the night. He and his staff decided to use undercover methods to find out how the drugs were getting there. According to Col Sabow's wife during a 65 minute telephone call to Deputy Commandant General John K. Davis the night before he was murdered stated that he just learned that CIA proprietary C130 aircraft were flying cocaine into the base; this illegal activity must stop and if the Corps filed formal charges of misuse of government aircraft, he would press for a court martial and blow the whistle on illegal narcotrafficking. Colonel Sabow didn't know until the day before his murder that the C-130's were bringing cocaine into the US from Central America. USMC Colonel Sabow's death was staged as a suicide by the NIS with knowledge of senior Marine Corps and Department of Defense officials. Their motive was to prevent USMC Colonel James Sabow from blowing whistle on use of MCAS El Toro to supply the CIA with propriety C-130's flying cocaine into the base for distribution in California.

Operation Amadeus was the main cocaine supply channel of the west coast and CIA informant Oscar Danilo Blandon during Iran/Contra. It went on to fuel one of the worst drug epidemics in US history on the west coast. In 1996 San Jose Mercury News Reporter, Gary Webb published the Dark Alliance lengthy in depth series which exposed the connection between the CIA and violent Los Angeles drug gangs. He began revealing the hypocrisy of the "War on Drugs" after investigating the Oscar Danilo Blandon-Freeway Rick Ross connection. According to Gary Webb there exists a 1982 agreement between US Attorney general William French Smith and CIA head

William Casey that drug trafficking cases involving CIA agents wouldn't be reported to the Justice department from 1982-95. The Sandanista's was a populist uprising in Nicaragua which the Reagan administration authorized 19 million to fund the Contras against. The Iran/Contra scandal revealed that the CIA authorized FDN leaders to sell coke in California in order to fund their insurgency. During the 80's the US set up and supported despotic anti-communist regimes globally to profit off of drug trafficking. The Oscar Danilo Blandon-Freeway Rick Ross connection fueled the west coast crack epidemic. This drug network opened up a direct link between Colombian cartels and black neighborhoods in LA. Freeway Rick Ross was the major supplier of Crips and bloods during the genesis of the crack cocaine epidemic in black ghettos from mid 80's to late 90's. This was the first network to switch from powder to crack cocaine which opened up markets and multiplied profits. They franchised rock houses as their crack distribution spread; networks only appeared in black neighborhoods.

The War on Drugs, as most policies of Washington D.C., is Orwellian in nature. An aide of the President Nixon administration is on record saying the "War on Drugs was actually war on black people". In October 1986 President Reagan signed the Anti-Drug Abuse Act of 1986, which appropriated \$1.7 billion to fight the "War on Drugs". This bill also created mandatory minimum penalties for drug offenses. In 1987 the homicide rate in the US began increasing by 5% each year, peaking in 1991 when crack cocaine was developing in urban centers. President Bush assigned William Bennett as drug czar in 1989 and announced the 'consequences' and 'confrontations' strategy. He also increased federal spending on the War on Drugs to the tune of 12 billion dollars spent on fighter planes, submarines, and military hardware. In 1989 Secretary of Defense Dick Cheney allocated 450 million to go after drug smuggling in the Caribbean and South America.

The 1994 Violent Crime Control and Law Enforcement Act also known as the "Clinton Crime Bill" continued the decimation of "African American" communities and was the culmination of the "War on Drugs". It was infamously introduced with Hillary Clinton referring to juvenile black offenders as super predators and was the largest crime control bill in US history with 30 billion in spending. At the time of its' passing the US Sentencing Commission had already noted that punitive criminal control and prison policies disproportionately affected communities of color. The Clinton Crime Bill introduced 3 strikes mandatory life sentences for repeat offenders; money for 100,000 new police officers; 9.7 bn in fund for prisons; provided 8.7 billion to states for prison construction in truth in sentencing guidelines; doubled federal prison pop. Along with sentencing guidelines like the Rockefeller drug laws it accelerated mass incarceration and promoted significant racial disparities in the prison population because of the differences in sentencing for crack and powdered cocaine. Possession of crack, which was cheaper and ubiquitous, resulted in a harsher sentencing for lower income communities. The Clinton Crime Bill also criminalized minorities during the War on Drugs. The media do not set their own investigative agendas independently but operate as part of the political establishment. In May 1995 the U.S. Sentencing Commission released a report that acknowledged the racial disparities of prison sentencing for cocaine versus crack. The commission suggests reducing the discrepancy, but Congress overrode its' recommendation for the first time in history.

The "War on Drugs" waged on black communities from the mid 80's to late 90's is a diabolical yet genius scheme by Washington DC. The US government used the War on Drugs to criminalize "African American" community in the same way they use politics to criminalize the whole FanmiLavalas Party in Haiti by calling them bandits and thugs. Like the Duvalier class in Haiti,

the Boule class in the US assisted; ignored or failed to respond to what Washington DC did during the crack era. LAPD officer Michael Ruppert stated that he witnessed CIA involvement in flooding LA with drugs and exposed CIA operations Amadues, Pegasus, and Watchtower when he confronted CIA director John Deutch on C-span during a townhall meeting on CIA involvement in drug trafficking after the release of the Dark Alliance expose by Gary Webb. Congresswoman Maxine Waters (boule) and the Congressional Black Caucus did nothing with their findings than hold committee hearings with no repercussions. I grew up in the crack era and was regretful when I discovered the Gary Webb series about the Iran/Contra scandal. The genius of the War on Drugs is that it utilized the crack epidemic to criminalize and destroy black communities while Washington DC is the one distributing and profiting off of it globally. It was also a form of social control as addiction caused families to become dysfunctional and countless crack babies were produced. Washington DC also profits off of the incarceration of these black communities thru the War on Drugs. The US court system is connected to the cusip system which is attached to the stock market and US citizens are traded like stocks once they're arrested. It is a continualization of the utilization of "black" people as property for profit started by the "former" American colonies and continued under the 13th amendment.

The US incarcerates a higher percentage of its citizens than any other country in world. DynCorp Int runs the US federal prison system and the CCA has a minimum capacity requirement clause in its contracts. The military industrial complex also benefits from the War on Drugs as an excuse for their budget and purchase of military goods is justified. The CIA uses the drug trade to finance their black ops which are used to shut down socialist countries like Haiti globally and set up narcostates by establishing kakistocracies.

The murders of teenagers Kevin Ives and Don Henry who were killed in Saline county and left on railroad tracks to be run over by a train is linked to Mena, Ark. Their murders are covered up and deaths ruled as suicide. This lead to students at University of Arkansas forming the Arkansas Committee to look into Mena, Ark allegations of drugs, money laundering, and Arkansas politics. They gathered thousands of signatures and went directly to Governor Clinton demanding he lead an investigation into Mena, Ark to no avail. In 1989 a US Senate Subcommittee calls the available evidence on Mena, Ark sufficient for an indictment on money laundering charges but the Feds shut down the 5 yr. probe of Mena, Ark and interfere with the local investigation. State police are taken off the case; Clinton refuses to prosecute or fund the investigation. Roger Clinton during a cocaine sting states "got to get some for my brother. He's got a nose like a vacuum cleaner". President William J Clinton fired 80% of the staff of the Office of National Drug Control at the White House once elected. He also fired 355 members of the DEA; eliminated 14.6 million from the coast guard's drug interdiction budget; slashed the DOD anti-drug budget by 300 billion; drug treatment and prevention budget by 230 million; terminated the money laundering section of the justice department's criminal division. Under his administration US Attorney Janet Reno refuses to prosecute any narcotics cases involving the CIA. On May 1, 1995 President Clinton shut down radar tracking of drug shipments from Columbia and Peru which according to US intelligence officials allowed an estimated 1000 plane loads of cocaine and heroin to enter the US freely. The book Cocaine Politics; Drugs, Armies and the CIA in Central America by Peter Dale Scott details the Iran/Contra connection between secret teams and covert operations during the Reagan era. It reveals that global drug trafficking has been reinforced and increased by right wing US

interventions in other parts of the world since WW2. NAFTA has contributed significantly to the illicit drug trade. The most notable component of NAFTA targeted the communal land sharing system, Ejido, established under Art 27 of the 1917 Mexican Constitution. In 1991 NAFTA negotiations the constitutional right to ejidos was eliminated; the state removed subsidies to farmers; and eliminated government price regulations for the poor. Neoliberal programs privatized the economy and excluded South Mexico from benefits. Inequality has contributed to success of Mexican cartel cause NAFTA created a network of disenfranchised farmers and willing to pursue profit in the illicit economy. NAFTA has contributed to the widening of the development gap between Mexico and North America. Resulted in cheap American labor and pinned the Mexican economy to the US market. At the time President Clinton ordered his cabinet not to speak about how NAFTA would also benefit the drug trade. According to Phil Jordan DEA "for the godfathers of the drug trade in Columbia and Mexico this was a deal made in narco heaven".

According to Eduardo Valle Espinoza former advocate of Attorney General Mexico: Mexico is a Narco Democracy where drug trafficking has permeated all political structures and has corrupted federal, state, and local officials. It has deformed the economy. It is a cancer that has generated financial and political dependence which instead of producing goods, has created serious problems ultimately affecting honest businessmen. The AG's office is unable to eradicate drug trafficking because government structures at all levels are corrupted. America is actually a Kakistocracy operating under the guise of democracy....In September 1995 Washington DC newsletter Strategic Investments article noted that Latin American drug cartels have stretched their tentacles much deeper into our lives than most people believe. It's possible they are calling the shots at all levels of government.

According to the Kerry Report: Contra cocaine traffickers took advantage of the US anticommunist sentiment which existed in Central America and they undoubtedly used it for drug trafficking.

- On October 5, 1988, the Subcommittee received sworn testimony from the Miami prosecutor handling the Neutrality and gun running cases that he had been advised that some officials in the Justice Department had met in 1986 to discuss how "to undermine" Senator Kerry's attempts to have hearings regarding the allegations.
- As DEA officials testified last July before the House Judiciary Subcommittee on Crime, Lt. Col. Oliver North suggested to the DEA in June 1985 that \$1.5 million in drug money carried aboard a plane piloted by DEA informant Barry Seal and generated in a sting of the Medellin Cartel and Sandinista officials, be provided to the Contras. 25 While the suggestion was rejected by the DEA, the fact that it was made highlights the potential appeal of drug profits for persons engaged in covert activity
- There is also evidence on the record that U.S. officials involved in assisting the Contras knew that drug smugglers were exploiting the clandestine infrastructure established to support the war and that Contras were receiving assistance derived from' drug trafficking. Instead of reporting these individuals to the appropriate law enforcement agencies, it appears that some officials may have turned a blind eye to these activities.
- Misrepresenting oneself as a U.S. government official is normally not considered to be a major crime. However, during the course of this investigation, the Subcommittee found

that many individuals who became involved in gun running, Neutrality Act violations and even supporting narcotics trafficking did so because "they were told that their actions were either on the behalf of, or sanctioned by, the U.S. government."

- Upon reviewing the matter with staff of the Iran/Contra Committees, the Subcommittee learned that neither the Iran/Contra Committees nor the White House had had access to uncensored North Notebooks. Instead, North or his attorney had deleted portions of the Notebooks which they considered to be outside the jurisdiction of the Iran/Contra Committees. In all, 1,269 of the pages of the Notebooks were censored to some extent by North or his attorneys prior to being delivered to the Iran/Contra Committees, with 155 pages blacked out completely
- The Subcommittee has received allegations that heroin dealers used the war in Afghanistan as cover for their operations. There are reports of guns for drugs exchanges and significant drug related corruption. The 1988 International Drug Control Strategy Report prepared by the State Department, obliquely acknowledged the problem, stating "individual Resistance elements, reportedly engage in , opium production and trafficking as a source of income to provide staples for populations under their control and to fund weapons purchases." Further it has been alleged that weapons for the resistance were diverted to the international arms market.
- In reviewing this, testimony, members of, the Subcommittee subsequently drafted, moneylaundering legislation which was incorporated into the Omnibus Drug Bill of 1988 and enacted into law in October, 1988
- To function, the criminal organizations which 'control the drug business must have access to commercial banks -willing to take large amounts of U.S. currency anonymously. Moreover, they must be able to keep secret the identity of the beneficial owners of the secret accounts. Restricting these - two essential requirements for successful money; laundering activities, even imperfectly, is the most important action the United States government can take in challenging seriously the operations of the large traffickers America has been waging a covert War of Terror on Haiti while claiming to be helping it openly. The War on Terror is similar to the War on Drugs in that it is part of the US Military Industrial Complex war for profit strategy. Washington DC claims to be fighting a War on Terror while funding it in order to maintain the Military Industrial Complex. The CIA have worked with Afghanistan's Mujahedeen since 1979 when president Jimmy Carter signed off on a covert war against Russia to combat the Soviet invasion of Afghanistan from 1979-80. opium sales were used to fund this covert op with the Mujahedeen who would later become Al-Qaeda and Taliban. In July 2000 Taliban leader Mulla Mohammed Omar declared growing opium poppies un-Islamic and began collaborating with the UN to eradicate heroin production in Afghanistan. This resulted in one of the world's most successful anti-drug campaigns with a 99% reduction in opium poppy grown in Taliban areas which is 3/4 of the world's heroin supply. In September 2000 the Taliban sent a delegation to the UN headquarters in NY to trade upon the country's continuing drug prohibition in a bid for diplomatic recognition instead UN imposed sanctions for protecting "Osama bin Laden". The US provided them humanitarian aid to the tune of 43 million and Colin Powell stated "the ban on poppy cultivation is a decision by the Taliban that we

welcome "but "their support for terrorism; violation of internationally recognized human rights standards; especially their treatment of women and girls". In the aftermath of the 9/11 attacks, which was also a highly sophisticated clandestine operation, the US began bombing Afghanistan on October 2001. The CIA shipped 70 million in cash into the country to mobilize its old cold war coalition of tribal warlords to fight the Taliban. With the support of British forces they launched an invasion spear headed by these local warlords and the Taliban regime collapsed. Opium production began again with the US occupation of 2001. More land is now used for opium production in Afghanistan than is used for cocoa cultivation in Latin America and supplies more than 90% of the heroin worldwide. Afghanistan's unique ecology converged with American military technology to transform this remote, landlocked nation into the world's first true narco-state. DynCorp Int is 1 of 3 preeminent private mercenary corporations in the world and is the dominant entity for training security forces in the middle east. They also manage police and court system in US occupied Iraq. DynCorp Int is also a CIA proprietary organization, a business designed to provide a service wanted by the CIA which is secretly owned by the CIA but disguised to appear in public as an independent private business.

Washington DC outsourced opium control to British allies and police training to German allies. A 2004 CIA intelligence report revealed that the revival of the drug trade in Afghanistan was fueling a resurgence of the Taliban. DynCorp Int was then contracted to train special teams of Afghanistan soldiers to eradicate drugs to no avail. In a 2007 New York Times article US Secretary of Defense Donald Rumsfeld "dismissed growing signs that drug money was being funneled by the Taliban, while the CIA and the military turned a blind eye to drug-related activities by prominent warlords". The UN Afghanistan Opium Survey of 2007 found that the country's then record opium harvest of approximately 8,2000 tons provided 93% of worlds illicit heroin supply. They also stated Taliban guerrillas have started to extract from the drug economy resources for arms, logistics, and militia pay for their insurgency. A New York Times article in February 2016 reported that the Afghanistan government offices have become directly involved in the opium trade and behave just like the Taliban.

The worst kept secret in the Marine Corps is that the US government is involved in the drug trade and uses the military as a cover for shipping and transporting drugs. Even at their Haiti transshipment point the, US blatantly uses Navy ships to transport their trade. The death of NFL star and patriot Pat Tillman occurred under suspicious conditions on April 22, 2004. He is quoted stating on record in Afghanistan "the War on Terror is a sham, we're just here to guard drugs for the CIA and bankers, the American people need to be told." Two days later he was "suicided" with 3 shots to the head at close range from a NATO rifle. Tillman was an avid war critic and all evidence of the circumstances of his death; body armor; uniform; personal journal were destroyed. Pat Tillman died of friendly fire yet was still awarded the Silver Star, which led to an investigation. If a soldier guarding the opium poppy fields in Afghanistan complained publicly about it were usually suicided. The Taliban destroyed all the opium poppy fields because it was corrupting their country and their youth. This caused the Washington DC cartel to lose 300 million a month in drug money; the invasion was to make Afghanistan start producing it again. The CIA are the biggest covert drug distributors in the world and fund all black operations with it.

After 9/11, and the passage of the PATRIOT Act, the restraints on the FBI that were in place since the revelation of COINTELPRO by a Secret Citizens Council were loosened and the FBI's mission

formally shifted to domestic intelligence again. The division among intelligence agencies was also loosened after 9/11 for the exchange of information. The FBI now had access to the National Security Agency's data retrievals, and proceeded to investigate organizations simply because they opposed the war in Iraq. Among the FBI's targets were the Catholic Worker and the American Friends Service Committee. The development of Internet Social Networks has made domestic surveillance easier for the intelligence gathering agencies. In the War on Terror the Bureau now spends an inordinate amount of time and resources paying or otherwise bribing criminals into becoming paid informers, and using them to goad and entrap young, poor, and sometimes mentally handicapped Muslim men into carrying out terrorist attacks they would neither have the wherewithal nor intention of otherwise committing. Since 2014, at least eighty-eight people have been arrested on charges of supporting ISIS, many of which had little or no connection to the terrorist group. That doesn't even count those arrested on more generic terrorism charges, typically in plots the FBI themselves have created. This is a continuation of methods the FBI pioneered during the COINTELPRO years, when the Bureau regularly paid provocateurs to infiltrate student protesters and urge violence but worse because the foreign and domestic capabilities are combined.

The Gulf of Tompkins incident which started Vietnam War was connected to the CIA. Vietnam was a for profit war fought by Washington DC and the Military Industrial Complex. According to the Christian Science Monitor report the CIA was cognizant if not party to the extensive movement of opium shipments; gave special clearance and monitored flights southward out of the country. This way also caused 30,000 US servicemen in Vietnam to become addicted to heroin. In 1975 the NYPD arrested the managers of a small branch of Chemical Bank for laundering money for the Paul Lucas heroin mob. Lucas was a small time operator supplied by returning Vietnam veterans. He retailed a few million a year in heavily cut heroin and laundered the money thru the Chemical Bank branch. Lucas's mob filled the entire vault with money and laundered 3million a year thru branch. Anti-drug senator Lyndon Larouche commissioned the Executive Intelligence Review to investigate the international drug trade which resulted in the book Dope Inc by Jeffrey Steinberg. It was the first book to reveal that the illegal drug cartel was becoming the world's biggest business. The first chapter was entitled "the Book That Drove Henry Kissinger Crazy." The kingpins of the Washington DC cartel former CIA head Bush, Kissinger, anti-defamation league of B'nai B'rith launched a years long effort to silence the authors. Senator Larouche was railroaded on trumped up "conspiracy charges" in 1988 and jailed within days of president Bush's inauguration in 1989. Henry Kissinger risked federal criminal prosecution for persisting that the DOJ and FBI indict Senator Larouche. The Bretton Woods agreement was established in 1944 by president Franklin D Roosevelt as a system of regulated fixed exchange rates for the international banking system. ...It was developed in 1944 at UN Monetary and Financial Conference held in Bretton Woods, it also created the International Monetary Fund (IMF). During the President Nixon administration, Henry Kissinger instigated the abolishment of the Bretton Woods and Glass Steagal Act. This allowed for the markets to participate in international financing, money laundering and highly leveraged unregulated speculation which led to the 2008 economic collapse. This action gave the Washington DC banking cartel total access to the international financial system.

The FED not only manipulates the markets to their benefit they also benefit from being subsidized by the Washington DC when projects fail in the name of protecting the people. Penn Central Railroad and Lockheed Corporation were bailed out in 1970. Commonwealth Bank of Detroit was bailed in 1972; New York City in 1975; Chrysler in 1978; First Pennsylvania Bank in 1980; Continental Illinois in 1982; and Operation Bail-Out of 2008. The Washington DC Banking Cartel doesn't only use the US treasury to create fiat currency. The illicit drug market plays an instrumental role in funding Wall St. where it's treated like commodity. The Washington DC Banking Cartel operates against the public interest. According to Michael Kenney's "power principal"; the survival of an illicit organization is dependent upon the accumulation of and access to power, notably political power. The US accounts for more than 40% of total cocaine consumption, with the value of retail dope on American streets at 200 billion a year. That amount of money is hard to hide from the eyes of the tax and drug enforcement authorities; the dope trade should stand out like thumb. According to the UN Office on Drugs and Crime report in 2009, Antonio Acosta exposed that "drug money became main source of liquidity for banks after 2008 implosion of the financial system" stated "panic in the banking system has completely dried out credit", "it was drug money that floated banks during the financial crisis". He produced evidence that cartel money was the only liquid investment capital available during the crisis of 08. The drug game is run from top down and Washington DC and their Banking Cartel are at the top. The Company makes it money thru clandestine drug trafficking, smuggling and distribution while the money is laundered thru the FED. The UN Office on Drugs and Crime estimates that the North American market for cocaine alone totals approximately 35 billion. US financial institutions found to be involved in the international drug trade are JP Morgan Chase; Bank of America; Western Union; Wachovia all were convicted of laundering drug money. On March 7, 2010 a subcommittee investigation revealed HSBC was heavily invested in money laundering to the tune of 378.4 billion. Jacob-Rothschild's banking cartel banks laundered trillions dollars a year thru this system allowing total integration of a legitimate system with elements of dope.

The Federal Reserve System requires that the banks hold no less than 10% of their deposits in reserve. The banks create money thru loaning out the remaining 90% reserve thru fractional banking. Whenever a bank receives a deposit or gives out a loan a new sum of money is created. With the flexible fiat currency they're able to earn perpetual interest on nothing. Central banks are the supreme and preferred instrument of usury. The Washington DC Banking Cartel makes interest on any loan of their flexible fiat currency. Washington DC uses the Federal Reserve to launder money thru the fractional reserve banking system. A bank's reserves consists of US currency plus balances in Federal Reserve accounts, paper currency on hand and balances in FED accounts are interchangeable. The expansion of the dollar denominated money supply by the Federal Reserve System, including the printing of billions of dollars of US dollar notes for the purposes of narcotransactions constitutes profit for the Washington DC Banking Cartel and its constituent private banking institutions in the form of interest. According to Jeffrey Steinberg author of Dope, Inc. estimated at \$600 Billion and Growing, Executive Intelligence Review, as of 14 Dec 2001. Yields on dollar denominated bonds issued outside of the US by foreign entities or within the US by foreign corporations and governments are higher. Drug money is also invested in a number of financial instruments including hedge funds and stock market transactions complete with offshore centers structured for laundering currency of the international narcotics trade. The major Wall

Street and European banks and stock brokerage firms launder billions of dollars resulting from the trade in narcotics. Wall St., New York is the actual capital of the Federal Reserve Banking System. Executive Intelligence Review also revealed the fact that the British Monarchy with the crown of the City of London is a state within a state like Vatican City-State in Italy, the City of London is also known as a state within a state; like the District of Columbia D.C. in Washington is a state within a state; they're all corporate city-states.

3. UNSCR 940 issued on 31 July 1994 is responsible for the incursion of DynCorp Int. and presence of cholera in Haiti in lieu of:

A. On December 1, 2016 UN Secretary General apologized for the role the UN played in the October 2010 outbreak of cholera in Haiti following the 7.0 Earthquake. DynCorp Int. is actually responsible for the cholera epidemic in Haiti because they contracted the Nepalese soldiers accused of causing the cholera outbreak. The same Nepalese soldiers were also implicated in death of Gerard Jean-Gilles a 16 year old boy who ran errands for them. The spreading cholera outbreak has killed at least 9,300 people, mostly Haitian kids and babies, and infected 800,000 adults and spread like a pandemic to the Dominican Republic and Cuba. Extensive evidence shows that the deadly strain of Vibrio cholera was introduced as a result of reckless sanitation management on a peacekeeping base where untreated human waste from the Nepalese soldiers deployed from a cholera-endemic country leaked into Haiti's principal river system. Genetic testing of the strain in Haiti determined it to be a "perfect match" to the strain active in the troop-contributing country from which the peacekeepers hail from. MINUSTAH's introduction of cholera to Haiti occurred at a time of growing popular discontent with the Mission for its perceived lack of accountability to the population and immunity from legal prosecution for acts of sexual violence, excessive use of force. The weak capacity of the Haitian government to prosecute the human rights violations of Haitians in general has created a structural vulnerability that exposes Haitians to further Human rights violations by external actors. Haiti never had cholera in its whole history before it was introduced by DynCorp Int which is part of the clandestine operating division of the CIA. This follows the pattern of destruction being waged in Haiti by Washington DC under the guise of assistance. DynCorp Int was given a 322 million contract to develop, produce, test, and store FDA licensed vaccines from the DoD. DynCorp Int. has all vaccine contracts for the Center for Disease Control (CDC). They have also been linked to the American Pharmaceutical Industry.

Dyncorp Int has conducted unsuspecting microbiology experiments on populations such as: Ebola virus, Zika virus, and the Tuskegee Experiment. DynCorp Int has also been supervising the forced vaccination of kids by UNICEF has been going on at Mirebalais hospital. UN officials have stated, on the record that children have gone missing from hospitals in Haiti since the devastating Jan 12 earthquake. DynCorp Int. is known for an amalgamation of sex, child, and human trafficking. Fanmim-Lavalas lawyer Ezilio Danto has stated on record that Haitian parents told her that kids, sick from cholera, who went to Mirebalais Hospital for treatment were disappearing never to be seen again. The kids who died from cholera were placed in DynCorp Int. body bags and staff wouldn't let parents have or identify the bodies of their children. The cholera epidemic has provided DynCorp Int. with cover for organ harvesting the 2,000 victims of the cholera epidemic. MINISTUH soldiers keep guard on the state of the art Mirebalais Hospital, which has a helipad

raising fears of child trafficking, and was constructed in Northern Haiti far away from the south where the Earthquake happened and victims remain homeless.

The United Nations Security Council Resolution 1892 issued on 13 October 2009 is responsible for the IHRC/Clinton Foundation creation of Caracol Industrial Park Complex in lieu of:

In The Aftermath Of The Haitian Earthquake, The U.S. State Department and The IHRC promoted the creation of an Industrial Park in Caracol, Haiti. “ The Caracol Industrial Park” was financed and built with “\$400 Million Of Global Aid”. CIP is a mixed use light manufacturing facility that began operating in 2012 in the commune of Caracol. Hundreds of smallholder farmers were coaxed into giving up more than 600 acres of land for the caracol complex, yet nearly 95 percent of that land remains unused. Instead, the Clinton Foundation, IHRC, and State Department created what a Wall Street Journal writer called “a mishmash of low quality, poorly thought-out development experiments and half-finished projects.”

The Haitian farmers that cultivated the nearly 600 acres (240 hectares) of land that is now the Caracol Industrial Park are throwing their hands in the air. Two years after their land was taken to build the park, promises have not been kept and they feel the compensation they received was dishonest. “An ABC News investigation has found that after opening its factory in the Haitian industrial park, built with \$400 million of global aid, the Korean firm became a Clinton Foundation donor and its owner invested in a startup company owned by Hillary Clinton’s former chief of staff Cheryl Mills. Wal-Mart has given \$1 Million To \$5 Million, And Gap Has Given \$100,000 To \$250,000 To The Foundation.” The Caracol Industrial Park is yet another example of multiple failed policies under the U.S. humanitarian invasion/occupation. A 2013 investigation by the Government Accountability Office found that most money for the recovery was not being dispersed, and that the projects that were being worked on were plagued by delays and cost overruns. Many Clinton projects were extravagant public relations affairs that quickly fizzled.

The Clinton Foundation wasn’t operating lawfully as a tax-exempt organization in Haiti. Wikileaks revealed that it was originally formed to build a presidential library for bill Clinton. It began work in Haiti in 2003 but it didn’t have clearance from NY authorities to operate internationally, which is why no official audit was conducted for several years. It failed to file 990’s from 98- 07 aggregating their government grants. The Clinton Foundation is not authorized by the IRS to engage in activities such as fighting HIV/AIDS, disaster relief, and climate change internationally, which is more fruitful fundraising. It hasn’t complied with NY laws which clearly require the identity and amounts of all gov’t grants (domestic and foreign) be reported. It’s a massive operating and solicitation fraud cause in order to solicit in most states and nations it had to register making truthful declarations. The registration for Clinton Foundation shows that it was raising money for a presidential library based in Little Rock, Ark. The sweatshop that they built at Caracol, which is in the extreme north of the country, away from where the earthquake hit Haiti in 2010, was supposed to employ 60,000 people. They have actually employed 5,000 people,

paying them 60 cents an hour, using a South Korean company who is very friendly and close to Mr. Ban Ki-moon (former Secretary General of UN and FOB).

There have been more than 1000 reported deaths in Caracol Industrial Park. The sweat shops are being turned into sex shops thru a program for women to earn extra money by providing sex to construction workers for bonus pay(1000 beds Ekam housing). They're paid for the sex thru Digicell phones which also offer micro-loans to workers to purchase sewing machines, these microloans charge 195% interest. Haitian women are coerced into buying sewing machines with micro loans with 195% interest rates and once they go into debt they are either; forced into prostitution; their kids forced to work all day or into prostitution; selling their kids to child traffickers; or giving up kidneys in order to pay off debt. Carlos Slim and the owner of Digi-Cell also run the same operation in India. Haitian women have described Digi cell men walking into their houses and soliciting their daughters for sex. They can't do anything to stop it and are obliged to accept whatever these foreigners offer in order survive. On November 13, 2016 Monica Peterson was found dead in Haiti under suspicious conditions. Oddly enough on November 14th, the Laboratory to combat Human Trafficking reported that Monica Peterson, investigating the Clinton's involvement in Haiti for the Human Trafficking Center mysteriously died the day before. She was working with her mentor Claude D'Estree, the executive director of the Human Trafficking Center at the University of Denver on her 100 page Master Thesis when she died by suicide from hanging in Haiti. She had just begun investigating the correlation regarding the Clinton Foundation's Caracol Industrial Park Complex and its connection to a Human Trafficking network when her life was cut short. Peterson had been highly critical of the Clinton Foundation writing on her blog: Tony Rodham and "a company that barely exists" got a "sweetheart gold mine concession in Haiti" that "royally cheated" the state of Haiti"; in a letter to her friend Peterson had uncovered "Two huge trafficking scandals; and a social displacement scandal with billions in unaccounted Earthquake aid" leading directly back to the Clintons." NYPD Chief of Detectives, Robert Boyce, said the Clinton emails contained evidence of sex crimes, child exploitation, money laundering, pay to play, etc...

6. UNSCR 940 issued on 31 July 1994 is responsible for the clandestine incursion of DynCorp Int. and introduction of sex, child, and human trafficking in Haiti in lieu of:

According to a UN report about the unintended effects of United Nations Intervention: preceding the deployment of MINUSTAH in Haiti, the NGO community made no attempt to publicize, research or assist victims of a global sex trafficking industry, suggesting that such networks were absent in Haiti prior to the arrival of the UN. This report also demonstrates that prior to the introduction of UN forces, there was an absence of global human trafficking networks in Kosovo, Haiti and Sierra Leone. After the introduction of UN forces, human trafficking networks grew in all three cases. DynCorp Int is responsible for training both MINISTUH and the HNP in Haiti whose behavior degenerated after said training. DynCorp Int is involved in child sex trafficking according to the Racketeer Influenced Corrupt Organization Act (RICO) lawsuit filed in Texas on behalf of the former DynCorp aircraft mechanic Ben Johnston. Earlier that year Ben Johnston, a DynCorp aircraft mechanic for Apache and Blackhawk helicopters in Kosovo, filed a lawsuit against his employer. The suit alleged that that in the latter part of 1999 Johnson "learned that

employees and supervisors from DynCorp were engaging in perverse, illegal and inhumane behavior and were purchasing illegal weapons; women; forged; passports; participating in other immoral acts.” Johnston witnessed coworkers and supervisors literally buying and selling women for their own personal enjoyment, and employees would brag about the various ages and talents of the individual slaves they acquired.

DynCorp Int is known around the world for human sex trafficking and organ harvesting. In 2004 Rep Cynthia McKinney questioned Secretary of Defense Donald Rumsfeld about DynCorp Int. getting government contracts when they were caught sex trafficking; she also asked about 2.3 trillion missing from US Treasury, Black Budget, because they needed to balance the budget, now up to 6.7 trillion missing. DynCorp Int is ubiquitous within Washington DC they manage; the congressional telephone system; computerized bookkeeping for a dozen federal agencies; as well as presiding over the loss or theft of trillions of federal dollars; DoD; HUD. The financial data process for US government accounting system is done by DynCorp Int and Lockheed Martin. They lost 17 bill in 1998; 59 bill in 99; in 2001 the pentagon could not account for 1.1 trillion for the fiscal year 2000; and they could not account for 2.3 trillion after 9/11. DynCorp International was involved in a sex slavery scandal in Bosnia in 1999 when its' employees were accused of buying and selling of girls as young as 12 by a former employee. According to Ben Johnston who filed a RICO lawsuit against DynCorp after he was fired ostensibly for reporting human rights abuses by their employees in Bosnia. In a 2002 report titled “DynCorp,” Johnston was quoted: “None of the girls were from Bosnia... They were imported in by DynCorp and the Serbian mafia. These guys would say ‘I gotta go to Serbia this weekend to pick up three girls.’... “DynCorps leadership was 100 percent in bed with the mafia over there.”

Johnston’s RICO lawsuit was not the only instance of wrongdoing to come out of DynCorp’s U.N. peace keeping contract in Bosnia. In 1999, Kathryn Bolkovac went to Bosnia as part of a UN mission. She discovered terrible wrongdoing - and refused to stay silent about it. She tells Nisha Lilia Diu her incredible story, now the subject of a film starring Rachel Weisz. According to the Guardian: “Kathryn Bolkovac, from Nebraska, was sacked by DynCorp of Virginia, to which peacekeeping police work in Bosnia had been outsourced...” “She signed up with DynCorp, providing American personnel for the UN...” Bolkovac’s story was later fictionalized into the film *Whistleblower*, starring Rachel Weisz. Ben Johnston eventually settled out of court, while Bolkovac won her case against DynCorp. Salon reported: “both Johnston and his attorney said they viewed the settlement as a victory and as a vindication after two years of fighting the company.” The New York Times related Bolkovac’s victory: “A British tribunal has ruled that a former member of the UN police force in Bosnia was unfairly fired after she reported to her superiors that colleagues in the police force used women and children as sex slaves in connivance with Balkan traffickers.” The Telegraph also reported: “The tribunal stated, ‘It is hard to imagine a case in which a firm has behaved in a more callous manner.’” In the aftermath of Bosnia, the United States demanded heightened immunity for Americans serving as UN peacekeepers, as opposed to increased accountability. DynCorp continued to receive contracts.

The UN was implicated in further sex abuse scandals in nations where peace keepers operate with immunity. In 2012 Reuters reported: “Two U.N. peacekeepers from Pakistan have been sentenced to a year in prison for raping a 14-year-old Haitian boy... Several peacekeepers have been accused

of rape, in addition to the Pakistanis, in cases that have fueled public protests and demands that members of the U.N. force be stripped of their immunity and face trial in Haitian courts.” U.N. Peace Keepers were also reported to have been caught on video raping an eighteen year old Haitian youth. Yet besides all of this DynCorp Int continues to get contracted by the US state department. DynCorp International announced that the U.S. Department of State Bureau of International Narcotics and Law Enforcement Affairs (INL) have awarded the company with a \$48.6 million contract. The purpose of the contract is to “recruit and support up to 100 UNPOL and 10 U.N. Corrections Advisors. DynCorp Int will also provide logistics support to the Haitian National Police (HNP) Academy and each academy class. In addition, DynCorp Int will supply five highlevel French and Haitian Creole speaking subject matter experts to advise senior HNP officials.”

An article by the Guardian reveals the shame peacekeepers cast on the UN: “Embarrassment caused by the misconduct of UN forces [in] Haiti, Sierra Leone, Bosnia, Cambodia, East Timor and the Democratic Republic of the Congo(DRC) ... [troops] ... were regularly having sex with girls aged as young as 12, sometimes in the mission’s administrative buildings.” The situation in Haiti became so serious that BBC reported Sri Lanka had:”promised to look into allegations that 108 of its UN peacekeepers in Haiti paid for sex, in some cases with underage girls ...more than 700 peacekeepers in Ivory Coast were suspended...” Yet DynCorp was once again contracted to provide troops for the UN in Haiti during this period. DynCorp Int is known around the world for human sex trafficking and organ harvesting. In 2004 Rep Cynthia McKinney questioned Secretary of Defense Donald Rumsfeld about DynCorp Int. getting government contracts when they were caught sex trafficking; she also asked about 2.3 trillion missing from US Treasury, Black Budget, because they needed to balance the budget, now up to 6.7 trillion missing. DynCorp International was involved in sex scandal slavery in Bosnia in 1999. "its employees accused of rape and the buying and selling of girls as young as 12. She tells Nisha Lilia Diu her incredible story, now the subject of a film starring Rachel Weisz.

An April 17 Post story on problems with DynCorp in Afghanistan focused on a suspected drug overdose death, breakdown in internal controls within the company, and actions the USG and the firm were taking. The other issue that surfaced at the time was a colossal error in judgment by one of the contractors' employees in hiring an adolescent boy dancer for some sort of event. Wiki leaks revealed that DynCorp allowed its' employees to hire a 15 year old boy dancer to do tribal dances at a party on the training site for the same event where the boy was sexually abused. The Obama administration hired DynCorp at a tax payer price of 48 million dollars to train 110 advisors and to “provide logistics” support to the Haitian Police.

10. The utilization of DynCorp Int, which is part of the clandestine operating division of the CIA, for the covert occupation of Haiti and clandestine marginalization of their population for a drug transit point by Washington DC under UNSCR 940 is analogous to their clandestine occupation of the Americas and marginalization of their indigenous population under COINTELPRO:

In 1950 a Congress hysterical about the “Communist threat” passed the Internal Security Act (the McCarran Act) which called for the registration of Communist organizations and their members, and also allowed the arrest and indefinite detention of persons engaged in Communist activity during a national emergency. Under director Hoover it was secretly expanded by the FBI to cover anti-war activists and many other organizations. COINTELPRO was discovered in March, 1971, when secret files were removed from an FBI office and released to news media. According to the FBI website they began, COINTELPRO short for Counterintelligence Program in 1956 to disrupt the activities of the Communist Party of the United States. In the 1960's, it was expanded to include a number of other domestic groups, such as the Ku Klux Klan, the Socialist Workers Party, and the

Black Panther Party. All COINTELPRO operations were ended in 1971. Although limited in scope (about two-tenths of one percent of the FBI's workload over a 15-year period), COINTELPRO was later rightfully criticized by Congress and the American people for abridging first amendment rights and for other reasons. The CIA began operation Mockingbird in early 1950's which utilized the media as a cover for the global elite.

After Cambodia was invaded on April 30, 1970 peace activists became frustrated that even massive demonstrations had been unable to slow down or much less stop the war. William Davidon, a physics professor at Haverford College, a fixture of antiwar protests in Philadelphia became aware of widespread fears within various peace groups that the FBI was infiltrating. It was in this atmosphere that he decided “to answer the question was the FBI suppressing dissent?” In late 1970 he formed a secret Citizens Committee to Investigate the FBI with seven other anti-war activists. They cased out and broke into the unprotected offices of the FBI in Media, Pennsylvania on March 8, 1971, the night of the Muhammed Ali vs Joe Frazier heavyweight match. They made off with all the files hoping they would find evidence of the FBI's systematic spying on Americans and had no idea what they had in their hands would expose much more.

The secret Citizens Committee to Investigate the FBI analyzed the files, copied them, and sent packets to the media. They would soon discover:

- Two memos in the stolen files headed “COINTELPRO” and “SI.” and had no idea what these meant but these document that would have the biggest impact on reining in the F.B.I.'s domestic spying activities
- that there were two FBI's the public, and the secret, and that the latter used deceptions, disinformation, and violence as tools to harass, damage, and silence people whose political opinions the director opposed.
- The FBI was engaged in “blackmail, burglary and agents and informers were ordered to spy on the private lives, including sexual activities, of the nation's highest officials.”
- The FBI's files included massive amounts of data, much of it supplied by untrained informers. Hundreds of thousands of Americans were targeted or enlisted as informers even members of various Ku Klux Klan groups. There was an agreement with 16,700 American Legion Posts, utilizing 100,880 members, to spy on their own communities.
- A damning document from the cache, a 1970 memorandum offered a glimpse into Hoover's obsession with snuffing out dissent; “It will enhance the paranoia endemic in these circles and will further serve to get the point across there is an F.B.I. agent behind

every mailbox,” the message from F.B.I. headquarters said. Another document, signed by Hoover himself, revealed widespread F.B.I. surveillance of black student groups on college campuses.

COINTELPRO targeted segments of the population perceived as a threat to "national security" for widespread surveillance, disruption, neutralization, and eventually destruction. Operations were initiated against various organizations, including the Puerto Rican Independence Movement, the New Left, the American Indian Movement, the Socialist Workers Party (SWP), the Communist Party, Moorish Science Temple of America, Liberation News Service (LNS), Unitarian Society of Cleveland, Puerto Rican Nationalist Party, Black Panther Party (BPP), Southern Christian Leadership Conference (SCLC), Muslim Mosque Inc., Student Non-Violent Coordinating Committee (SNCC), Black Nationalist Hate Groups. In 1964, after the murders of three white civil rights volunteers at the beginning of “Freedom Summer,” President Johnson and Attorney General Robert F. Kennedy ordered FBI head J Edgar Hoover to add “white hate groups” (KKK) to COINTELPRO. FBI operations weren't limited to organizations but also targeted groups such as members of unions, pacifist groups, anarchists, racial justice groups and individuals like: Adam Clayton Powell, Phillip A. Randolph, Elijah Muhammed, Malcolm X, Martin Luther King, Paul Robeson etc. etc.

The secret Citizens Committee to Investigate the FBI continued to release batches of files to the media and the information began to have an impact. On June 13, 1971 the New York Times published the first installation of the Pentagon Papers adding a new exposé of illegal governmental actions. On December 22, 1974, Seymour Hersh of the Times revealed that the CIA in violation of its charter that forbade domestic intelligence had files on thousands of U.S. anti-war activists. The Director of CIA Richard Helms denied it under oath but when Congress investigated a year later it turned out that; the CIA had data on more than 300,000 people; a thousand organizations; with thousands on watch lists to have their mail opened. The FBI sent Mark Felt to Media to investigate the burglary of their office who became the Deep Throat informer in the Watergate case.

In January 1975, the U.S. Senate established a Select Committee to Study Governmental Operations with Respect to Intelligence Activities with Senator Frank Church of Idaho serving as chairman. The Church Committee held hearings that shed considerable light on illegal operations, abuses, and led to greater congressional oversight of the F.B.I. and other American intelligence agencies. Its impact in exposing the truth was limited in scope because it only required the FBI to provide heavily redacted documents and millions of pages of documents remain unreleased. The Church Committee’s final report about the domestic surveillance was blunt: Many of the techniques used would be intolerable in a democratic society even if all of the targets had been involved in violent activity, but COINTELPRO went far beyond that. It was a secret war against those citizens it considers threats to the established order. The Bureau conducted a sophisticated vigilante operation aimed squarely at preventing the exercise of First Amendment rights of speech and association, on the theory that preventing the growth of dangerous groups and the propagation of dangerous ideas would protect the national security and deter violence. Too many people have been spied upon by too many government agencies, and too much information has been collected. COINTELPRO existed for years on an ‘ad hoc’ basis before the formal programs were instituted, and more significantly, COINTELPRO-type activities may continue today under the rubric of ‘investigation.’

Freedom of Information requests, five years of lawsuits lodged against the FBI by the BPP and the SWP, dogged reportage, Congressional hearings and statements by agents who came forward to confess their counterintelligence activities would reveal the meanings of COINTELPRO and SI through the Freedom of Information Act. The mysterious "SI" stood for Security Index which in 1971 was a secret listing of more than 26,000 people who were to be arrested and imprisoned without any form of hearing in the event of a national emergency. FBI director Hoover had begun a similar list under another name as early as 1924. The McCarran act was revoked in 1971, but the SI continued under another label until it was "officially" abolished. The Church Committee's findings and its recommendations to reform the FBI were attacked from within by the FBI and outside by conservatives. The Church Committee led to the creation of the Foreign Intelligence Surveillance Court though it did not roll back government surveillance. Only the strengthening of the Freedom of Information Act after 1974 had a serious impact. Officials at the highest levels of government were aware of COINTELPRO and approved its continuation. To control the damage and reestablish government legitimacy in the wake of Vietnam and Watergate, Congress and the courts compelled the FBI to reveal part of what it had done and to promise it would not do it again. The FBI domestic spying activities were seriously scaled back due to the efforts of the Secret Citizens Council to Investigate the FBI in the 60's.

COINTELPRO made the state a struggle between the public and clandestine agencies for control of formal institutions of democracy. The Secret Citizens Committee exposed the reality that the American people were operating in an undemocratic system that wasn't working in the best interest of a majority of the population. The clandestine intelligence apparatus Washington DC used to covertly colonize the indigenous aboriginal population of North America created an inherent tension between hierarchical core centralized elitist dynamic and a need to legitimize itself once discovered. This created a discourse in humanitarianism and operating for the public good which was basically rhetoric on the side of clandestine intelligence agencies because they were neither reformed nor punished for their illegal actions. The revelation of COINTELPRO by the secret citizens committee and the fact that its primary focus was spying on black citizens was a shock to Americans. After the founding of the American colonies an intelligence unit became part of the continental army in 1775. Intelligence activities targeted the indigenous aboriginal population the colonies found in the Americas due to the internal slave trade. All intelligence operations done on the indigenous aboriginal population were supposedly "shut down" at the end of Civil War in 1865. The tragedies that occurred after the Civil War changed the path of America and its move away from institutionalized slavery. The whole system of US corporate government utilizing citizens as a commodity evolved out of the American colonial mercantilism of chattel slavery which considered the POW/slave to be a nonperson and insured human property. The failure of the Haitian Revolution was that it failed to liberate the indigenous aboriginal populations of the Americas. Even though Haiti won its independence their fate was still tied to the failure of the indigenous aboriginal to rid themselves of the American colonies operating under the Doctrine of Discovery. The Doctrine of Discover was expanded under Manifest Destiny and the Monroe Doctrine. Even though Haiti defeated the institutionalized slavery in 1804 on July 28, 1915 a new form returned to its shores.

After the success of Haitian Revolution, Haiti tried to end the institution of slavery in the Americas and was viewed as a threat by . Haiti helped liberate South America with Simon Bolivar yet he

reneged on his promise of the bourgeoisie class to free the slave. Haiti also sent Denmark Vesey to end slavery in America but his attempt was stopped by what would later develop into the Boule class. The Haitian Revolution was actually a failure because the mission of Jean Jacques Dessalines was to free all slaves within the American hemisphere. Haiti never attacked America directly but the majority of the slave revolts were started by Haitians or those inspired by its successful revolution.

Washington DC dominated Haiti during a 19 year US military occupation from 1915 to 1934 led by USMC Major General Smedley D. Butler. The Duvalier class in Haiti emerged out of the gyndamire which was installed during the 1915 occupation by Washington DC. The government/Duvalier class in power in Haiti, which is on the Washington DC payroll, is very similar to the Boule class in the US. The Boule is a secret permanent overclass within the "AfricanAmerican" class created by Washington DC to "manage" "black" Americans. A major difference between the Duvalier class in Haiti and the Boule class in the US is that the former is openly ruthless towards the population while the latter covertly works to keep their black masses disenfranchised. Another difference between the classes is the government/Duvalier class form a kakistocracy in Haiti while the Boule works within the infrastructure. The Boule class in America may not be as openly ruthless as the Duvalier class in Haiti but they're more diabolical. The Boule and Duvalier class also work together to control the elections and government in Haiti. The Boule and Duvalier worked together in Haiti during the disastrous humanitarian efforts after the earthquake of 2010 and established the IHRC. It was the Boule president Barrack Obama who used his influence to convince the Haitian government turn over their power to IHRC. Both classes receive their perspectives, objectives, and directives from Washington DC..

The centralized government of the US has always been trying to rid the American continent of the indigenous aboriginal civilizations due to the Doctrine of Discovery. The truth about the TransAtlantic Slave Trade is that it actually happened in reverse. American colonization society formed in 1816 and established a colony in Liberia, Africa for colonized black Americans to be sent to. In January 1817 the first free black convention was held in Philadelphia to strongly oppose the American Colonization Society and released the official statement: "we are not Africans, we are free Americans, we demand our rights as American citizens, we do not want to be sent out of this country." The beginning of the Abolitionist Movement was actually unpopular because they not only wanted to free slaves and make them equal citizens; they demanded "negroes" must be recognized as Americans and given their full rights as Americans.

Despite all the discrimination and prejudice the communities of indigenous aboriginal population still prospered because they worked together. Once the American government realized the indigenous aboriginal population was still prospering due to the silver rights movement they decided to go into business with a certain demographic. Instead of silver rights they purposed the Civil Rights act of 1875 for the indigenous population which was about Indians. This was the beginning of the Boule once the racist white Americans who hijacked the government after the Civil War became afraid of elite "negroes" uplifting others so they separated them. The Boule were also the first agents of what would develop into the Counter Intelligent Program (COINTELPRO). The US government is good at social engineering, spying and population control because it had time to perfect it's tyranny on the indigenous population.

The Boule motto is they're gonna save black people but they're actually gettin a lot of negroes killed thru their ignorance of the overall exploitation of "black" people. The black "secret society" known as the Boule' aka Sigma Pi Phi Fraternity, Incorporated, was founded on May 15, 1904 in Philadelphia, Pennsylvania. Unbeknownst to many the Boule is the 1st black fraternity in America and was started before the 1st black "college" frat, Alpha Phi Alpha Fraternity, Incorporated, which wasn't founded until December 4, 1906. They wanted to create an organization modeled after the tenants of the Skull and Bones of Yale which they couldn't partake of cause they were black. They're also responsible for the creation of the "divine" 9 black fraternities and sororities beginning in 1906 with Alpha Phi Alpha. All collegiate BGLO's fall under their umbrella and is where most of their members are recruited from. Boule sounds french but is derived from ancient greek lower house and means advisor to the king. The first Social Engineering program conducted by the DC intelligence was the creation of the "African-American". After the Civil War during the Reconstruction Era history was changed in order to continue the denationalization of the indigenous aboriginal population. There is a major misconception that HBCU's (Historically Black Colleges & Universities) were independantly started by prosperous "African-Americans". These institutions were in fact founded by the American bourgouise class who benefitted from institutionalized slavery such as the Rockefellers and Julius Rosenwald. The elite class created and financed HBCU's and used the Boule as a front. They used the Boule' to staff these institutions of "Higher Learning" and indoctrinate "African Americans" into the black studies program. This is the continuation of mind control tactics, which would later develop into MK Ultra, Washington DC Intelligence agencies had been using on the indigenous aboriginal population they found in the Americas in order to take their land. The black studies program and pan-africanism are false paradigms created for the indoctrination of African Americans to Africa.

The Boule class were responsible for keeping the indigenous aboriginal American population brainwashed and complaint while the colonies established a white powered infrastructure around them. Avid Pan-Africanist Steve Cokley was the first man to expose the boule to black America. He accidentally became aware of the Boule due to an article written on July 18, 1990 by the LA Times. According to Cokley "we find in the same period, as the founding of the Boule', the founding of the 4 black male (Alpha Phi Alpha, Kappa Alpha Psi, Omega Psi Phi, and Phi Beta Sigma) and 4 black female (Alpha Kappa Alpha, Delta Sigma Theta, Zeta Phi Beta, and Sigma Gamma Rho) college-based fraternities and sororities; We also find the founding of the NAACP and Urban League." "It was neccessary to institute a group of blacks who had a vested interest in protecting the white power infrastructure"

The main ideology at play among negroes at the time came from Booker T. Washington who started the Tuskegee Institute and was targeted by the Boule. His Racial Accomadation Theory of proffessed black folks should drop their buckets where they were at and nation build in America. There was a pluarility of black towns n communities prospering at the time networking among each other. There werealso a variety of black grassroots organizations at the time following him. Washington DC was known for policies which marginalized negroes and the majority of the indiginious didn't want to associate with the US. Due to Jim Crow and systematic apartheid negroes stuck together and the dollar circulated within their communities 100 times before it left.

The US elite which had made their money off of institutionalized slavery was looking to exploit them for more wealth so they started pushing integration.

WEB Dubois was the first to coin the terms "African-American" and "talented tenth" which the Boule is supposedly composed of. He was also the first "African-American" to get a PHD from Harvard and authored the Souls of Black Folk. Known as the father of the Pan-African movement in America, he called for a return to Africa based on the Out of Africa Theory by Melville. He also created the Niagra Movement to oppose Booker T Washington and fight for Civil Rights. After the Springfield, Illinois riots WEB Dubois formed the NAACP out of the Niagra Movement on February 12, 1909, with Jewish NYC liberals Mary White Ovington, William English Walling, Henry Moskowitz, Oswald Garrison Villard, Moorfield Storey and Joel Spingarn (liberal Jews) as a Civil Rights and Legal organization. The NAACP developed out of the Niagra Movement which was created to combat Booker T. Washington. The NAACP was the first interracial organization to fight racism with Dubois serving as the only African-American executive. The NAACP is part of the is analogous to the black lives matter movement which was started and funded by George Soros. This is how the elite infrastructure within the US control "black" people by creating and funding black institutions in order to maintain control of the "black" infrastructure.

The NAACP is actually part of COINTELPRO and was organized to represent a form of nationally centralized black leadership. It is presented as an organization to advance justice for African American oppression but is actually utilized to spy and sabotage their efforts. The NAACP was the first organization to orchestrate the Civil Rights Movement and have participated in socially engineering black people since they were denationalized. The name of the organization; National Association for the Advancement of Coloured People automatically denationalizes members because coloured people have no nation. The founders of the NAACP were actually spies working for Washington DC to monitor and infiltrate "African-American" communities. WEB Dubois was actually a prominent Boule member and the founding member of the NYC chapter. Members of Boule pose as Freedom Fighters or Civil Rights Activists on the surface yet are actually spies for Washington DC and operating for personal gain. The NAACP headquarters is located in Baltimore, Maryland and each member of the Boule must take a lifetime membership, but the building isn't owned by any members. The co-founders of the NAACP were actually Jewish spies.

Joel Spingarn who was very influential in the founding of the NAACP and Boule was actually a Jewish spy. He was a descendant of one of the elite families who benefitted from the institution of slavery. Joel Spingarn was commissioned in the US Army and served as a Major during WWI. He was hired in May 1918 by the Military Intelligence Division (MID) from 1918-42 and ran "a small unit of undercover agents" looking for proof of subversion among black community. The MID opened 100,000 pieces of mail a week and monitored negro publications. The Military Information Division (MID) was the first military intelligence branch of the US Department of War 1885-1903. It was repurposed in 1942 into the Military Intelligence Service which consists of an Administrative group, Intelligence group, Counter Intelligence group, Operations group. According to the Memphis Commercial Appeal documents revealed that Joel Spingarn remained NAACP chairman during his tenure at MID. He used the post to obtain critical information for MID, list of 32,000 members, and launch a vicious attack against the UNIA.

The Secretary of War Newton D Baker (CFR), under president Woodrow Wilson's from 1916 to 1921, ordered Lt Col Ralph Van Deman, Army Spy Network, which dates back to May 3, 1911. to set up a Black Intelligence unit to monitor 'Negro Unrest'. Lt Ralph Van Deman, known as the father of American military intelligence and inductee in the Military Intelligence Hall of Fame, is the one who hired "jewish" spy Joel Spingarn to "watch" (spy) the Afrikan community. Joel Spingarn then created the NAACP long with WEB Dubois. The Boule are secret gate keepers for the elite Washington DC power infrastructure and their job is to spy, pacify, guide and manage black folks. The NAACP initiated the Anti-Lynching Bill in 1919 but Washington DC didn't pass the Bill until 1959, almost 40 years later. Reason being Washington DC actually batard the passage of the Anti-Lynching Bill with the NAACP for intelligence on the black community.

Washington DC maintains a clandestine control of their "African-American" population utilizing the Boule' and the NAACP. According to the archive, Federal Surveillance of Afro-Americans (1917-1925), Washington D.C.'s General Intelligence Division (anti-radical division) aka The Bureau of Investigation (B.O.I.) which was renamed the Federal Bureau of Investigation) in 1935 was a precursor to COINTELPRO. In 1924 J. Edgar Hoover, special assistant of the Attorney General, was made head of the scandal ridden BOI division. He begins coordinating clandestine activities within "African-American" communities in what devoloped into the COINTELPRO operation. Boule members such as Phillip A Randolph or Thurgood Marshall were part of Hoover's spy network. Steve Cokely exposed the direct link between the U.S. government, the Boule' and the NAACP. He is the one who pointed out the fact that each member of the Boule must take a lifetime membership to the NAACP. According to him "anywhere there are prominent black professionals, chances are they're in the boule; 70%-75% of all black male lawyers are members of the secret society....virtually every black mayor, congressman, banker or millionaire in America are members of the boule". All of the members of the CBC are Boule.

In 1988 Steve Cokley was forced to resign as an aide to Chicago Mayor Eugene Sawyer. He was targeted by the Anti-Defamation League for "anti-semmetic" statements he made at a Louis Farrakhan rally. Many "black" leaders have been attacked and lost their position because of this accusation by the Anti-Defamation League. Khalid Muhammed was expelled from the Nation of Islam for the same reason. The American bourgouise and Washington DC utilize their Intelligence Agencies to compramise the "African-American" class in every which way. The Jesuits and the Jews are also utilized to subjugate the black communities. They created the The Anti-Defamation League (ADL) and Southern Poverty Law Center (SPLC) to use Anti-Semitism as a rallying force and to gain power within US. The ADL and SPLC were created to ensure that an organization would be in place where only jewish groups and interests would be protected. The zionists are a movement for the reestablishment, development, and protection of a jewish nation in what is now Israel. It was established as a political organization in 1897 under Theodore Herzl. The colonization of the Middle East by Israel is the continuation of the policy of Doctrine of Discovery practiced by Washington DC. What's ironic is that the ADL, SPLC and the NAACP were all created and financed by the same people. The genius of this scheme is that the NAACP is used as front to spy and subjugate the black community, while the ADL use anti-semitism to cover themselves and get rid of any "black" leaders they want.

In 1917 Lt. Col. Ralph VonDemon, Army Spy Network, set up a negro spy network under direct orders from U.S. Secretary of War Newton D. Baker; the former "progressive" democratic Mayor

of Cleveland, Ohio from 1912-1915. This spy unit was dominated by BOULÉ members, because the Army had to recruit Negroes who they felt could be trusted. Newton D Baker's assistant was Emmit J Scott(Boule) who served as Special Adviser of "Black" Affairs and was the highest ranking "African American" in president Woodrow Wilson's administration. Emmit J Scott functioned as part of this unit and worked very closely with jewish spy, co-founder of the NAACP, Joel Spingarn. Scott also worked with Booker T Washington on the Tuskegee Institute and was used to spy on him. He used his position, charm, and intelligence to persuade many Negroes to join the Armed forces go to war for Washington DC during WWI. He did this at a time when lynching picnics were still a regular feature of oppression within the US. He was later rewarded for his actions by being made a Grand Sire Archon within the BOULÉ in 1941. He also served as Commissioner to Liberia under the Taft administration. Avid Pan-Africanist and Phi Beta Sigma alumni Robert R. Moton (BOULÉ) was the one who got Emmit J Scott his position with Newton D Baker. They were both associates who worked with Booker T. Wahington on the Tuskegee Inst.. Robert R. Moton was made principal of the Tuskegee Inst after the death of Booker T. Wahington in 1915. He was responsible for bringing the U.S. Army to the Tuskegee Inst. and the Tuskegee Expirement. In fact Moton was the one who stopped Washington DC from having white doctors inject the syphillis and used Boule doctors instead. He also covered up his Investigation of the Great Mississippi Flood, when "African-Americans" were imprisoned on the levee and forced to work at gunpoint, for Herbert Hoover.

According to Federal Surveillance of Afro-Americans(1917-1925), in a memorandum dated 11 October 1919, J. Edgar Hoover, special assistant to the Attorney General and head of the General Intelligence Division (or "anti-radical division") of The Bureau of Investigation, wrote to Special Agent Ridgely regarding Marcus Garvey: "Unfortunately, however, he (Garvey) has not as yet violated any federal law whereby he could be proceeded against on the grounds of being an undesirable alien, from the point of view of deportation." Sometime around November 1919, the BOI began an investigation into the activities of Garvey and the UNIA. Toward this end, the BOI hired James Edward Amos, Arthur Lowell Brent, Thomas Leon Jefferson, James Wormley Jones, and Earl E. Titus as its first five African-American agents. The Boule were also the first agents of what developed into the Counter Intelligent Program (COINTELPRO). They were recruited by the Bureau Of Investigation (BOI) to spy on the UNIA for J Edgar Hoover.

Marcus Garvey originally started The UNIA as a vocational school modeled after Booker T Washington and the Tuskegee Inst.. Garvey decided to turn the UNIA into a black nation building program with a membership goal of 400,000,000. It's motto was 1 God, 1 Aim, 1 Destiny. He opened his first chapter of unia in harlem on september 1917. Garvey called established black leaders weak and self serving...Garvey toured the country and established UNIA branches all over the US gaining pledges to support his nation building program. Anyone could join and he used the red/black/ green flag to represent a black nation in the making. By 1919 the UNIA had ballooned into 30 branches globally and 2 million members worldwide without the help of television or radio. Garvey noticed that blacks contributed 220 million in liberty bonds to the war effort of WWI so he started investment funds to open black businesses which were financed thru purchase of stock. He tried to start separate economy of black owned businesses. The UNIA employed 1000 people in harlem and the publication the Negro World was also the most popular black newspaper in in the world. The same year Garvey began publishing and distributiong the Negro World , a meeting was held on Aug 17 in washington dc. The premire boule editors of

black newspapers such as The Amsterdam News, the Chicago Defender, The Pittsburgh Courier, The Baltimore were in attendance and masonic orders were given to not discuss Marcus Garvey or his movement in their papers to disway followers.

Marcus Garvey's ideology was to create a black powered infrastructure to compete with the white one. He is on record stating "If the oil of Afrika is good for Rockefeller's interest; if iron is good for Carnegie trust; then these minerals are good for us. Why should we allow wall street and the capitalist group of america and other countries exploit our country when they refuse to give us a fair chance in the countries of our adoption? Why should not Afrika give to the world its black Rockefeller, Rothschild, and Henry Ford?" The reason Washington DC was so dangerous was because he was member of Prince Hall masonry. Garvey broke away and formed the UNIA as a fraternal order which he modeled after a masonic order with revised ideals needed for selfpersavation. He mixed his knowledge of masonry with political ideals and significant benevolence for the secret evolution of the fraternal idea from its early craft stage into a potent political vehicle, based on the organization of secret revolutionary brotherhoods.

Garvey and the ideals of the UNIA clashed with other African American leaders because it was profitting of the "back to Africa" movement at the time. He was a target of WEB Dubois because his organization followed the tenets of Booker T Washington. WEB Dubois (Boule) called Garvey a gorilla and monkey in order to Tarzanine his movement. Garvey criticized the NAACP and many black leaders asserting they only sought assimuilation into white society. The true reason for Marcus Garvey's strong stance and formation of UNIA was international black economic independence. He realized after being exploited for their wealth, labor and denationalized by Washington DC the successful acquisition of wealth by the Boule class within the system was only there to highlight that endemic Institutional Racism which blocks "African-American" advancement collectively does not exist. Because of jewish control over the black dollar and jewish merchandise ubiquitous in all black neighborhoods of major northern cities and a network of stores throughout the south like Neiman-Marcus, Sears-Roebuck, Zales, Rich's. Garvey was not only attacked by the Boulefor but also for anti-semitism for simply wanting to establish an economic foundation for black progress.

This COINTELPRO program is designed to eliminate the next "Black Messiah" who would emancipate the mentally enslaved African. The Messiahnic force refers to Marcus Garvey who is the prototype J Edgar Hoover repurposed COINTELPRO to target. W.E.B. Dubois has stated on record that "the Boule was created to keep the black professional away from the types of Marcus Garvey". According to Steve Cokely "the importance to steal the black professional away from Marcus Garvey because an Afrocentric organization that articulated and captured the black professional would give no safe haven in the black community, to the Boule' the remaking of the house negro was necessary to build a group of negroes who had an investment in protecting the white system as produced by having stolen this land. This is post reconstruction. Taking away the articulate negro, now desiring to replace them with organized institutions to keep them away from self improvement." The Boulé were ordered to destroy Garvey's organisation by any means, because its success would have set the precedent that Africans could take control of their land and mineral wealth with a focus on using their resources for themselves worldwide. WEB Dubois along with other NAACP members organized the "Garvey Must Go" campaign. The Boule colluded with the US government to sabotage his Black Star Line and start the Harlem Renaissance to oppose the UNIA presence in harlem.

Washington DC feared Marcus Garvey's influence on "negro" veterans returning after WWI with high expectations looking for change. The US government feared his appeal to disgruntled blacks. Marcus Garvey rejected what he saw occurring in the US militantly and Washington DC didn't want "African-Americans" to have militant demand for inclusion or rejection of policies. As an acting agent on behalf of the 'Boule', NAACP, and BOI, Robert R. Moton attended several Garvey meetings and reported his ideas to the United States Government. Marcus Garvey knew that in Liberia there were massive trees that drip sap. This sap is the main element used to make tires for automobiles. The Rubber Industry was just beginning to boom and Garvey saw this as an opportune time for the UNIA to have a stake in the global economy using a natural resource from Africa. In one of his lectures on the 'Boule', Steve Cokely stated Robert Moton was given \$5million by the U.S. Government and instructed to counter Garvey; offering \$5 per acre over his \$1 per acre bid. This inevitably blocked Garvey's deal as he was underhandedly outbid by Moton. In 1926, Firestone opened up its rubber factory base in Liberia which gave them a lease of 100 years. Firestone/Bridgestone made the \$5million paid on the land well within the first 5 years of operation and wouldn't have gotten this deal without Robert R. Moton spying and interceding on Marcus Garvey!

The UNIA was full of black agents working for the 'Boule' or the BOI to sabotage the efforts of Marcus Garvey. For instance the man hired to inspect the ship for the Black Star Line was an informant for J Edgar Hoover and deceived him about the condition of the ship. The captain made him pay 6 times its value for kickbacks and he was misled by his handlers in this important purchase. Although initial efforts by the BOI were to find grounds upon which to deport Garvey as "an undesirable alien", a charge of mail fraud was brought against Garvey in connection with stock sales of the Black Star Line after the U.S. Post Office and the Attorney General joined the investigation. Attorney General Palmer created a Special Division of the Justice Department that worked with the General Intelligence Division to shut down Garvey and his organization. Marcus Garvey was indicted in 1923 for mail fraud charges connected to the Black Star Line and convicted in 1925. He spent 2 years in federal prison and was pardoned and deported by President Calvin Coolidge in 1927. Upon his imprisonment COINTELPRO destroyed his movement and started the Harlem Renaissance to counter it.

All of this early spying on the "African-American" community is what developed into the COINTELPRO program. WEB DuBois was also the first "African-American" to write for the Round Table Group's offspring, the Council on Foreign Relations, magazine Foreign Affairs. Foreign Affairs published a series of articles in 1925 by DuBois. In 1921 the CFLR is founded, by Paul Warburg, to direct Washington DC foreign policy. The black intellectuals of the 'Boule' class helped to indoctrinate the black masses into fighting for integration without reparations. WEB DuBois, one of the founders of the NAACP, which was also started, owned and operated by the Round Table Group. All these organizations were working under strict dictation from the Round Table Group. America is a land of Secrets, the Round Table Group is a secret society started by Cecil B Rhodes and Lord Nathan Rothschild in the late 1800s. Secret Societies formed from the bourgeoisie which profited of the institution of slavery run America. This elite class developed the infrastructure of Washington DC to their benefit. The Trilateral Commission and Board of Council of Foreign Relations (CFR) which dictate US foreign policy were also started by Cecil Rhodes and Lord Rothschild. Most members of the US government belong to a secret society in some type of way. The 13 elite families rule Masonic lodges whose branches are fraternal orders

and sororities. Control by the Masonic secret societies is maintained systematically using the 10 Areas of People Activity: Economics, Education, Entertainment, Labor, Law, Politics, Sex, Religion, War, and, Health. The fact is that most of the materially successful African Americans in the USA and African Diaspora have pledged their allegiance to the Boule Masonic Lodges. Steve Cokely stated that the reason Secret Societies are so dangerous is because members are initiated and take oaths to organizations whom they're more loyal to than their own families which is dangerous for the community. President John F. Kennedy warned about the CIA and secret societies also. The CIA came up with term conspiracy theory to discredit investigations into the Kennedy assassination. A free people can't have true government with members of secret societies in them because they have hidden agendas.

Three generations of Kings were targeted for political neutralization by Yarborough and his successor J Edgar Hoover. MLK's father and grandfather were both shotgun priests and targeted for surveillance by Washington DC under COINTELPRO because they fought for negro rights. Martin Luther King was actually part of the Boule class which led the fight for integration during the Civil Rights Era. The majority of "negroes" at the time didn't want to integrate into the US. The Boule class are more dangerous and diabolical than they seem. Washington DC intelligence and the Boule class used MLK to lead the indiginious aboriginal population into the Civil Rights Movement. The Civil Rights Era tricked the indiginious aboriginal population into giving up their birthrights with "Civil-Rights" and integrating into 'white society". The Freemasonry organization started by Albert Pike, the KKK established the White Citizens Council for States Rights and Racial Integrity 1954 in Delta, Mississippi. The councils purpose was to preserve white political power and combat the Civil Rights Movement and integration. Members consisted of bankers, politicians, business owners soon joined the council and chapters spread accross the state and South. The White Citizens Council punished people who supported integration or black voting rights by foreclosing mortgages, firing workers, refusing loans to farmers and practiced gerrymeandering among other things. They also used their influence to push thru laws that would ensure continued white domination. The Civil Rights Act was enacted on July 2, 1964.

During the march on washington, Martin Luther King stated in the "I Have A Dream" speech "that black people are exiled on their own land". This is a perplexing riddle for those who don't understand the true patterns of colonization within the Americas. The first dictionary published in America in 1828 by Webster term describes the term Amer'ican as a noun that means native of Americas, which originally applied only to the aboriginals or copper-colored people found here by European colonizers, but now applied to the descendents of Europeans born in America. Their descendants reclassified as negro, black, African-American have become domesticated to become alien to their land of inheritance. It was a melanated indiginious aboriginal autochneous population Christopher Colon encountered and tried to subjugate on the island of Hispianola under the Doctrine of Discovery. Europeans used the status "white" to steal and assume the identity of the tru indiginious aboriginal American autochneous population which washington dc denationalized with the terms Indian, 1492 ; negro,1832; black,1965 ; negro,1900 ; colored,1950 ; Afro-American, 1970. It wasn't until the Reconstruction Era when history was reconstructed and the indoctrination of "negroes" with the fallacy that they were all from Africa. The American Boule class actually work with washington DC to keep "African-Americans" miseducated about their true origin. Alex Haley (Boule) is responsible for the movie Roots which worked to imprint

the slave narrative into the minds of black people in the 1980's. He also wrote the the Autobiography of Malcolm X. Alex Haley presented the story of Kunta Kinte and Roots as authentic yet it was later found out that he plagiarized the whole story from the African by Harold Colander, a white author! A major job of the Boule class is to push the narrative that "AfricanAmericans" are from Africa. This tactic was one of the first form of mind controls performed on the indiginious aboriginal population by the intelligence agencies of Washington DC.

The secret Citizens Committee to Investigate the FBI COINTELPRO files revealed: the overall impression in directives written by Hoover, other headquarters officials, and local FBI officials was that the FBI thought of black Americans as falling into two categories black people who should be spied on and black people who should spy on other black people for the FBI.”; it was required that agents recruit paid informers in black ghettos; not long after MLK's I Have a Dream speech, the assistant to the FBI director wrote: We must mark [King] now, if we have not before, as the most dangerous Negro in the future of this Nation, it may be unrealistic to limit (our actions against King) to legalistic proofs that would stand up in court or before Congressional Committees; Malcom X could've been one, a memo noted, had he not been assassinated (something the FBI privately took credit for, after having exacerbated a factional split in the Nation of Islam), as could Martin Luther King, should he abandon his obedience to white liberal doctrines of nonviolence and embrace black nationalism; An effective coalition of black nationalist groups which, by the FBI's definition, included virtually every civil rights organization might be the first step toward a real 'Mau Mau' in America, the beginning of a true black revolution, it read, referring to the 1950s anticolonial rebellion in British Kenya.

Martin Luther King walked off of the Boule reservation in 1966 once he realized integration was a mistake. During one of his last speeches MLK stated that "the American negro was integrating into a burning house". MLK saw the hypocrisy of Washington, DC and their continued exploitation of "black" people. The main purpose of integration was to harness the black dollar. It destroyed the network of black bussiness in which the dollar circulated 100times! The creation of Free Trade Agreements would allow foriegners to operate in black neighborhoods for profit. Black Americans integrated into "white" schools and european history with no political or economic base. Integration was the final death nil for black Americans because it was a continualization of the colonial process which the American colonies had enacted on the indiginious aboriginal population; as MLK said black people were still in exile on their own land. The job of the Boule is to brainwash negroes and integrate them into this burning house. Most people didn't understand what he meant at the time but the meaning of that aphorism is basically; African Americans integrated into a system which is killing them. But what is so diabolical about it is that they were tricked into fighting for integration non-violently. It is only with the passage of time and studying the results of integration which make this point observable. MLK started the PPC campaign which was primarily focused on getting "black" Americans their restitution and he was assassinated on April 4, 1968, the same month he was supposed to go occupy Washington DC.

The Boule have been involved in both the organising and commissioning of the operatives that performed the assassinations of both Malcom X and Martin Luther King; as well as many other acts of despicable treachery against progressive "African" leaders and communities in both the

USA and the Diaspora. According to William E Pepper author of *Orders to Kill - The Truth Behind the Murder of Martin Luther King, Jr* published in 1995 by Warner Books: "Under direction from the white house, Army chief of staff General Harold K Johnson and Assistant Chief of Staff for Intelligence General William P Yarborough, with the help of other intelligence assets within the United States Gvt , assembled a sophisticated apparatus designed and used to infiltrate Black Militant orgsanitions and Dr. Kings own non-violent protest organiation, to develop anti-King propaganda and provide around the clock surveillance of Dr King himself." (COINTELPRO) "Information provided by two former Special Forces NCO's the activation and deployment of US Army Special Forces personnel, including snipers, from the Reserve's 20th Special Forces Group (Airborne) to form a seret "Alpha" Team on the night of MLK's assassination. Their mission was to deploy from Camp Shelby to Memphis on a covert operation posing as civilians. It was understood that the two snipers would "shoot to kill" Dr. Martin Luther King and Reverend Andrew Young." The majority of the leaders of the Civil Rights era were Boule. It was the Reverend Billy Kyles (Boule) who led MLK to the balcony that night and thru a telecasted freudian slip admitted that he moved away from Dr. King to allow the assassin to get a clear shot. Jesse Jackson also accompanied MLK on the balcony that night. The assassination of Martin Luther King, Jr. was actually a covert operation under COINTELPRO involving the Boule and washington DC. When you move up the ladder to special operation "hierarchical degrees" of a Jesse Jackson or Billy Kyles involving the assassinations of public figures, you must go through a higher degree of security and secrecy; and another higher degree of secret initiation; word is Jesse Jackson was promised the presidency for his participation by DC. Malcolm X was another "renegade" who was assassinated by the FBI under COINTELPRO with the assisstance of the NOI. It isn't clear what the degrees are for the Boule initiation rituals even at the lowest levels.

A study of the patterns of colonization exposes how the Civil Rights Act was used to disenfranchise the indiginious aboriginal population of America by Washington DC and a their final death nil. What made MLK upset was the Homestead Acts and the that they were "integrating" with no compensation. According to him: "At the very same time that America refused to give the negro any land thru an act of congress our gov't was giving away millions of acres of land in the west n midwest which meant that it was willing to undergird it's white peasants from europe with an economic floor but not only did they give the land they built land grant colleges with gov't money to teach em how to farm; not only that they provided county agents to further their expertise in farming; not only that they provided low interest rates in order that they could mechanize their farms; not only that today many of these people are recieving millions of dollars in federal subsidies not to farm n they are the very people telling the black man that he ought to lift himself by his own bootstraps; this is what we are faced with, n this is the realty now when we come to washington in this campaign; we're coming to get our check..."

The Homestead Acts of 1862; 1866; 1909 were "laws of the lands" which allowed Europeans to come to America by millions beginning in the 1790's. Under these Homestead Acts the indiginious aboriginal population were coerced or kidnapped into being utilized as indentured servants to enrich their former American colonies. The Homestead Acts plan to accomodate "negroes" was for them to be given the opportunity to buy 40 acre lots after working the land for 3 years which rarely materialized. Federal programs like the Pre-emption Act of 1830, Mineral Leasing Act and

many similar state programs were used to confiscate land belonging to the indigenous aboriginal population and given exclusively to the "white" class. Beginning with the Emancipation Proclamation in 1865 over 250 million acres of land were given away to the "white" class with 643 acres going to each family. Ever since the Homestead Acts immigrants have been allowed to migrate to America by Washington DC to to disenfranchise the indigenous aboriginal population, the true Americans, from their own land. In Europe only the very rich owned land but these Acts gave them the opportunity to come to the US pick out territory for 10 bucks. Washington DC also gave enormous amounts of land to railroad companies. What is ironic is the use of the Statue of Liberty, which depicts a "black" woman, to greet European immigrants coming to further disenfranchise the indigenous aboriginal population.

The Berlin conference of July 3, 1881 was where Europe carved up Africa for themselves; denationalized the indigenous aboriginal population; and planned its exploitation. The Native Land Acts used to disenfranchise the indigenous aboriginal South African, under the system of Apartheid are equivalent to the US Homestead Acts. The colonization patterns of South Africa reveals what a mistake the Civil Rights Movement and "integration" of "African-Americans" into the US infrastructure was for them. At the Convention of Madrid in 1882 the Madrid System of internationally recognized trademarks, the "white" powered infrastructure began using trademarks to disenfranchise indigenous aboriginal people. In 1890, Cecil B. Rhodes became Prime Minister of the Cape Colony. He introduced the Glen Grey Act to push black people from their lands and make way for industrial development. The growing number of enfranchised black people in the Cape Colony led Cecil B. Rhodes to raise the traditional Cape Qualified Franchise requirements in 1892. By simultaneously limiting the amount of land black Africans were legally allowed to hold while tripling the property qualifications required to vote, Rhodes succeeded in disenfranchising the black population. In addition, Rhodes was an early architect of The Black Land Act of June 1913, which would limit the areas of the country that the indigenous aboriginal Africans were allowed to less than 10%. The apartheid system in Africa rose simultaneously with a series of Jim Crow Laws. The Black Land Act of 1913 formerly known as Native Land Act of June 1913 is identical to the Homestead Acts which were used to marginalize the indigenous population of the Americas. It was aimed at regulating the acquisition of land by indigenous aboriginal Africans. The 1913 act allowed for territorial segregation of indigenous aboriginal Africans and made it illegal to work with whites as sharecroppers which allowed for 80% of these lands to be cleared of native Africans and sold to white Afrikaners at cheap rates. The indigenous aboriginal Africans were sharecroppers until the Native Land Acts of 1913 removed them to reserves and forced them into industrial servant labouring positions for white Afrikaners.

The Development Trust and Land Act of 1936, formerly known as the Native Trust and Land Act of 1936 was based on the recommendations of the Beaumont Commission. Its purpose was to make provisions for the acquisition and occupation of land by natives and other persons. It resulted in the enlargement of Native African reserves by 13%. The Afrikaner party established in 1948 created an all white government as an institution of the church which lawfully granted land to male heads of the household by law systematically by then removing black males by jail, death, war, the government could acquire rights to abandoned land under colour of law. The South African Population Registration Act of 1950 is the same as the North American Equal Employment Opportunity Act of 1972. The patterns of colonization of the Apartheid system in Africa followed

the the American system in that it deprived the indiginious aboriginal populations most of their land. Hitlers Mein Kampf praised Americas institutional racism and modeled the Nazi party after aspects of it. The tides turned with the Black Communities Development Act 1984 when native africans refused to integrate into or work for the Apartheid system. That is the major difference between the patterns of colonization of South Africa and North America. Due to the fact that the South Africans didn't integrate into the apartheid system they're able to get their land back. The system of Apartheid was repealed on June 30th 1991 with the Abolition of Racially Based Land Measures Act. The Civil Rights Era coerced the indiginious aboriginal population into integrating into the system which originally disenfranchised them without compensation. Even the South African revolution was not successssful because by leaving the infrastructure in control of their former oppressors, Nelson Mandela and the head of the ANP betrayed the ANC. Today SA make up 80% of the population but the latest land audit shows they possess only 4% of all farms and agricultural holdings by individual land holders. The fact is the SA "white" infrastructure is asking for compensation for stolen land like when France demanded reparations from Haiti for lost "human" property but when it's time for black compensation it's different. Utilizing their COINTELPRO tactics globally, Washington D.C./CIA assassinated every black nationalist on the planet n replaced them with kakistocracies led by their neo-colonialist puppets.

Martin Luther King Jr could have been the first Boule president if he kept playing by the rules of Washington DC but President Barrack Obama recieved that honour. Jesse Jackson was part of the Boule deception which helped African President Barrack Obama get elected. During his term President Obama passed the Rights of Indiginios People and the false Native American tribes were awarded a billion dollars in early sept 2015. Over 645 tribes won trials against the US Department of Justice awarding 940 million. The US feared that under his administration the population mislabeled "African-American" would discover their true history; bloodline; heritage and be forced to grant them reparations and land. Therefore Washington DC silently declared a deadline of December 31, 2014 for them to make land and identity claims. The fear of millions of "African-Americans" waking up to the true identities and stating I'm not black i want my land and restitution. There are over 700 million acres of confiscated lands being held in held in trust for indiginious aboriginal Americans mislabeled "African-Americans".

After the assassination of MLK the Boule used Jesse Jackson to brainwash the "African-American" masses. Jesse Jackson would go on to help popularize the term "African-American" and with this action help to "Africanize" the aboriginal indiginious population right off their land. The Boule members know that this is a false term meant to confuse the true indiginious aboriginals of America. He knew they were originally referred to as Indians because he worked with Martin Luther King. The term "African-American" has only existed for the last 25 years prior to that the "American-Negro" was labeled; 1492 indian; 1832 negro; 1965 black; 1900 negro; 1950 colored; 1970 Afro-American; 1988 african american; 2020 foreigner? After the passage of the Civil Rights Act, Jesse Jackson utilized his organizations to extort corporations for violating :AfricanAmerican" rights. He was also connected to drug activities and started the Rainbow Coalition with Bill Clinton. The policy choices both democrats and republicans have made since the Civil Rights Era replaced social welfare policies with punitive measures in "African-American" communities. The Jewish financial elite are behind the Boule and prop them up as phoney black leadership class in positions of influence and wealth. Their role is to protect

their sponsors and perpetuate their hegemony. Genuine leaders like MLK and Malcolm X who forgot their place on the Washington DC plantation are eliminated. The George Soros Jewish funded Black Lives Matter Movement works the same way as the NAACP and is a continuation of Washington DC controlling African Americans thru a liberal agenda. Sixty years after the revelation of COINTELPRO, the FBI is still engaging in similar tactics, particularly with reports that the Bureau has tracked and monitored

Black Lives Matter protesters. Washington DC has been using its intelligence apparatus since the inception of COINTELPRO to control the indigenous aboriginal American population thru social movements. The Boule assists in these social manipulations as with the Black Panthers which was controlled opposition.

MLK was actually marching for the rights of indigenous aboriginal Americans mislabeled Indians by their colonizers. MLK knew they were exiled on their own land and that wealth in America is primarily determined by family lineage. After the death of MLK President Johnson called in a special favor to congress and pushed thru the secret legislation which became the Rights of Indians, Public Law 90-284 April 11, 1968. This law was about discriminatory acts committed against the indigenous American aboriginals; Chap 102 refers to them as aboriginals; Title II Rights of Indians.. After being denationalized by the American colonies "African Americans" became private property but were still considered to be Indians in public capacity. After the "Independence" of the colonies from Britain in 1783 the Virginia Co changed its name to the United States of America. The Va Co owns most of what we now call USA and any lands up to 100 miles offshore including Bermuda and most of the Caribbean except Haiti. The VA Co has rights to 50% of all gold and silver mined on its land plus a percentage of minerals and other materials found. The lands of the company were originally granted to the American colonies under a deed of trust. The American colonies broke every treaty they made with the indigenous aboriginal population. The land is under lease to the Va Co therefore they can't claim ownership of the land. They can only pass on perpetual use of land to their heirs and sell the perpetual use of it but can never own it. Ownership was retained by the British crown who established the VA Co colonies to cultivate tobacco with the British Moors. The indigenous aboriginal Americans are the original principal land owners even if the city or state took their land they're still owed and can receive royalty checks.

Haiti thought it defeated capitalistic slavery on 1804 but an evolved version has returned to its shores in 2010. The American colonies originally only profited from the denationalization and enslavement, of the indigenous aboriginal autochthonous individual, who were considered private property during chattel slavery. After the Civil War the US government was so upset with losing their slaves and former "property" without compensation, that they developed a system for Washington DC to profit off of all their "citizens". The Emancipation Proclamation didn't actually free the POW/slaves because it wasn't a manumission. The indigenous aboriginal American population supposed to declare their nationality after the Civil War when Prez Lincoln opened up 13th amend 21 sections and nullified 14th. Once President Lincoln was assassinated, The Freedman's Bureau, which had created Freedman's Bank got their gold stolen. Frederick Douglass tried to save Freedman's Bank after the assassination of President Lincoln April 14, 1865. It's difficult to create a political powerbase without an economic one. The indigenous aboriginal population was betrayed by Washington DC and the President Andrew Johnson Compromise with

the South after Lincoln's assassination. The indigenous aboriginal autochthonous population reclassified as negro lost his birthright under the 13th amendment which just transferred them from private to public property of the U.S. government. Never fully ridding the government of the institution of slavery laid the foundation for the Washington DC in place today. The chartered federal company entitled US ie US inc. commercial agency originally designated as Wash DC incorporated as a for profit commercial enterprise in the legis act of Feb 21 1871 41st Congress. With the assassination of President Abraham Lincoln, veto of the freedmen's bureau bill and secret compromise of 1877 effectively neutralized any gains the indigenous aboriginal population had made and continued their marginalization by the American government.

The true patterns of colonization is not taught to "African Americans" under the Westernized model of education. In North America it was in reverse, the American colonies were trying to clear the land of the "black" indigenous aboriginal population. All of the European explorers who first came to the Americas were shocked to find it populated by what they described as Moors or Ethiopians. For instance the Dutch West India Company, a trading and colonizing company, chartered by the States-General of the Dutch republic in 1621 and organized in 1623 followed the pattern of colonization set by Christopher Colon. The Dutch West India Company were among the first European nations to establish colonies in the Americas. After 1674 it engaged primarily in the African slave trade utilizing colonies it still possessed in Guiana, Negroland which was established thru a partnership between them, England, Denmark in North Guiana Africa in 1729. They Dutch found out captured Indians they tried to enslave kept escaping. It's very hard to enslave a man on his own land, so they began sending captured "Indians" to Negroland in Africa and then resettling them in the Americas in unfamiliar territory. Many of the so called Africans that were brought to the Americas from Negroland Guiana, Africa were actually descendents of the American aboriginals of that were brought by the Dutch to Negroland, Africa in the 1700's.

The year 1492 just marks the beginning of the horrific, evil, genocidal persecution of indigenous Americans. When Christopher Columbus landed in Haiti he performed ceremonies to take possession of the lands for the Catholic Church under Papal Bull Dum Diversas. Papal Bull Dum Diversas was the spiritual blessing the Christian inquisitors and Christian invaders got from the Church which made it ok for them to rape, kill, behead, slaughter, murder and spread diseases among the indigenous men, women, children and babies of the people of the Caribbean and Americas and enslaved them for labor and indentured servitude under the Doctrine of Discovery. Columbus was shocked to find natives who reminded him of "ethiopians" when he arrived on the island of Ayiti. The inhabitants of the island of Hispaniola was populated with black skinned nappy haired nubians according to Columbus's book. In fact the Americas were populated with "black" people and every European explorer who "discovered" the Americas clearly notes that fact in their entries. It wasn't until the reconstruction of American history was the true identity of indigenous natives hidden for a purpose. Christopher Colon became the first man known in history to send the first POW's/slaves across the Atlantic from Haiti to Portugal. The American colonies would emulate this pattern and use the Doctrine of Discovery to subjugate, marginalize, indoctrinate and integrate the indigenous aboriginal autochthonous population without recompense. One of the best kept secrets of the corporate US state Department is that African Americans are not from Africa but actually descend from the indigenous aboriginal autochthonous Americans

found here by the American colonies. Now that Washington DC has fully colonized the true sovereign Americans they're using their full imperialistic might on Haiti.

In 1910 senator Nelson Aldrich Rockefeller, Abraham Andrew, Frank Vanderlip, Henry P Davison, Charles Norton, Benjamin Strong junior, Paul Warburg held a secret meeting to draft legislation for the establishment of the Federal Reserve. This secret meeting took place on Jekyll Island off the coast of Georgia, at an exclusive boys club for American financiers and politicians. The parties represented at this secret rendezvous (Morgans, Rockerfellers, Kuhn, Loeb&Company, Rothschilds, Warbugs) accounted for approximately 1/4 of the wealth of the entire world at that time. Paul Warburg, who was instrumental in the creation of the Council of Foreign Relations, was also instrumental in the formation of this banking cartel. Senator Nelson Aldrich Rockefeller was chairman of the National Monetary Commission which was a special committee created for the purpose of making recommendations to congress for proposed legislation to reform banking.

A concentration of wealth referred to as the "money trust" was also a major concern as the large bank in New York on Wall Street was in the hands of a few. At the time banks had broken their promise to guard their depositors assets. There were runs on banks occurring all over the country and banks couldn't give the people their money back. Paul Warburg led this secret cabal on this covert mission to successfully draft legislation for the National Monetary Commission for the creation of a banking system which would benefit them. Their efforts is what led to the establishment of a banking cartel thru the Federal Reserve. The term cartel doesn't only apply to narcotic organizations like the Medellin; they're simply a group of independently owned businesses which come together for the purpose of reducing or eliminating competition between themselves to enhance their profit margin or to secure their positions in the market.

The Bank of England formed in 1694 was the first Central Bank and from that point forward all of the governments of Europe had one. The kings and princes of Europe learned from hard experience that there was a limit to raising the taxes of their subjects for their escapades before they had a revolt on their hands. The limit people were willing to pay in taxes was about 40-43% before raiding castle moats. The same way America failed to live up to the mandates of it's Constitution, with the Federal Reserve Act, it also failed in it's original resolution not to have a central bank like those in Europe. The establishment of the privately owned Federal Reserve system on December 23, 1913 with the Federal Reserve Act was one of the greatest silent Coup d'états and crimes ever committed by a government against it's citizens in history. With this single act the banking cartel basically went into partnership with the government. The government/congress benefits because it recieves easy instant access to any amount of money it wants from the FED without the taxpayer being involved directly in the loop. They're able to tax the American people any amount they wish through a complex form of inflation. The fact that the people don't realize that they're being taxed makes it easy to maintain power. It is this ability of government to acquire money from the FED without direct taxation of the people that makes washington DC so corrupt.

The board of directors and chairman of the Federal Reserve System are appointed by the President. In 1921 the CFLR is founded, by Paul Warburg, to direct washington DC foreign policy. He also helped draft the Act which created the FED and served as it's first governor. One of the purposes of Warburg's Federal Reserve System was to keep new competitive banks from growing and becoming large like the one on Wall Street. It was designed to keep control of the "money trust"

in New York and reverse the trend of private capital formation. The Federal Reserve System functions outside of U.S. Law and as a private central bank. It's isn't an agency of the federal government in any shape or form but a corporation that is chartered by Congress. Like all corporations it has stocks and certificates which are held by the banks within the Federal Reserve System. The only thing of substance that the charter allows smaller banks to vote for are the interest rates within their regions. Real currency is based on gold or silver reserves resulting in a market that's hard to manipulate thru expansion or contraction of the money supply from which the banks are covered by congress. In 1920 the US treasury was raided by the FED which caused the Great Depression and bankrupted the US corp. Since it's creation in 1913 the Federal Reserve System has presided over the crashes of 1921 and 1929, the Great Depression of 1929-1939, recessions in the years 1953, 1957, 1969, 1975, 1981, and the stock market Black Monday in 1987. The Great Depression was a severe economic depression which began in the US and spread globally from 1929 to the mid 1930's. On Black Tuesday the worldwide GDP fell by 15% resulting in the deepest longest economic downturn in US history. American society began coming appart with over 1/3 of the labor force unemployed and people had no faith in the economy or political system.

USMC Major General Smedley Butler was a two time Medal of Honor recipient and the highest decorated Marine Corps officer ever. He wrote the book War Is A Racket when it became obvious to him that his military service was used to pave the way for corporate interests to get what they wanted. "I spent 33 years and four months in active military service and during that period I spent most of my time as a high class muscle man for Big Business, for Wall Street and the bankers. In short, I was a racketeer, a gangster for capitalism. I helped make Mexico and especially Tampico safe for American oil interests in 1914. I helped make Haiti and Cuba a decent place for the National City Bank boys to collect revenues in. I helped in the raping of half a dozen Central American republics for the benefit of Wall Street. I helped purify Nicaragua for the International Banking House of Brown Brothers in 1902-1912. I brought light to the Dominican Republic for the American sugar interests in 1916. I helped make Honduras right for the American fruit companies in 1903. In China in 1927 I helped see to it that Standard Oil went on its way unmolested. Looking back on it, I might have given Al Capone a few hints. The best he could do was to operate his racket in three districts. I operated on three continents." In 1932 US veterans held the Bonus March, in which they occuppied Washington DC requesting the government pay them a bonus due to them for WWI. Gen Butler supported the protesting veterans and the request for their bonus pay. Gen Smedley Butler supported Franklin D Roosevelt election campaign due to his socialist platform.

President Franklin D Roosevelt was elected in 1933 and served until 1945. The American capitalists hated President Roosevelt because he was elected on a socialist platform. The idea that the government would create jobs and social programs for all racial groups fractured "Americans" along racial and political lines. In 1934 a special investigative committee came to Gen Butler linking his name to a veterans organization associated with a plot to overthrow President Roosevelt. The McCormack-Dickstein Committee was a Special Committee on UnAmerican Activities on Nazi propaganda which was established to investigate acts of fascist sympathizers in the US during the early years of the Roosevelt presidency. That is when General Smedley D. Butler exposed The

Business Plot: a well financed Wall St plot to organize the American Legion to March on Washington DC, seize the White House, overthrow the president and install the famous military hero as dictator. They wanted to use this private army to seize power and install General Smedley Butler as leader of a fascist regime like Italy and Germany. Both Mussolini and Hitler were private individuals who seized power thru the overthrow of the government by false movements.

Gen Butler was contacted by Gerald MacGuire who was utilized as the pointman for the capitalists. The American Liberty League was created as front organization for the "Business Plot". They knew Gen Butler could raise and lead an army of 500,000 men because he was popular among veterans and they idolized him. They wanted him to rouse up WWI veterans who were upset due to the bonus they were promised. The journalist Paul French was hired by Gen Butler to document the events. They met with Macguire several times to discuss the plot and the fascists capitalistic system his financial backers wanted to institute. Major Wall St. corporations like Firestone, Birdseye, Colgate, General Motors, General Foods, Heinz, and US Steel were implicated in the "Business Plot". The media ridiculed the allegations and called it "Fake News" and the capitalists individually denied existence of "The Business Plot". The final report submitted by the McCormack-Dickstein Committee confirmed most of Gen Butler's testimony but never called the capitalists he named in the "Business Plot" to testify. Gen Butler accused the committee of deliberately editing out the names of capitalists out of his testimony. Some of the members of the class who were linked to the plot were Du Pont; JP Morgan; Paul Warburg. The capititalistic class and their corporations had committed treason against America but President Roosevelt didn't prosecute anyone named in the "Business Plot" and instead used Gen Butler's revelation to negotiate the passage of the New Deal. The Hamburg American Line was a shipping company accused of providing free passage to Germany to American journalists willing to write favorable articles about Hitlers rise to power and bringing Nazi spies and pro fascists sympathiers into America. The company was managed by Prescott Bush at the executive level and was part of a web of Nazi business interests that were all seized in 1942 under the Trading With the Enemies Act by the US congress.

The Emergency Banking Act of March 9, 1933 dissolved the US Federal government. Joint Resolution HJR 192 suspended the gold standard and abrogated the gold clause dissolving the sovereign authority of the US Republic. With the constitutional republican form of government dissolved, a new form of government known as Democracy was adopted . With this act the US hypothecated all of the present and future properties, assets and labor of their "subjects", the 14th amendment US citizen to the Board of Governors of the Federal Reserve, in which the trustees(stockholders) hold legal title. The Federal Reserve (creditor) agreed to extend the corporate US government all the credit fiat currency it needed. The US corporation(debtor) had to assign the private property of their US citizens as collateral against the unpayable Federal debt. Prior to this most Americans owned allodial titles to their property, free and clean of any liens or mortgages. They also pledged the unincorporated federal territories, national parks forest, birth certificate and nonprofit organization as collatteral against the federal debt. All has already been transferred as payment to the international bankers and Federal Reserve. This was done because since washington DC has been operating under Color of Law on American land since they were colonies, they utilized the FED to profit off of all their property. The Federal Reserve Banking

Cartel became the sovereign authority and all the US citizens went from private to public property; legally dead; the birth certificate utilized as a death certificate with all their assets and debts in probate. This is analogous to when the American colonies denationalized the indigenous population in order to utilize them as chattel property. They went from private citizens to public property and their birth certificate denotes property and is actually a death certificate; "black" people were the first to be considered legally dead and their assets held in probate by Washington DC. The US citizen(franchisee) was registered as a beneficiary of the trust via his/her birth certificate. The entire straw man concept and how U.S. citizens are traded as stocks and commodity is essentially based on them never declaring the legal and monetary value of their birth certificates and the fraud of the corporate US serving as the legal beneficiary.

The utilization of money by the FED to exploit the American people their wealth, assets and labor is just a continuation of the exploitation of the indigenous population and land by an upper class which benefited from it the most. After having siphoned off an enormous amount of wealth since the Civil War; they now siphon it from the American people thru the Federal Reserve Banking Cartel. The US inc is which is located in Washington DC is actually a de facto for profit corporation masquerading as a government with 30,000 subsidiaries. The 1940 Buck Act authorized any department of the federal government to create a federal area for imposition of "public salary tax". It also took congress, which normally only has jurisdiction over the Washington DC area, and extended its' overlay across the continental US utilizing these federal areas. A federal area is any area designated by any agency, department, or established of the federal government, this includes the Social Security Areas designated by the Social Security Administration, Social Security Number, any public housing area that has federal funding, a home that has a federal bank loan, a road that has federal funding, and almost anything that the federal government touches thru any type of aid. (Springfield v Kenny). Washington DC lacks the sovereign capacity to operate in Haiti with impunity the way it does. William Grider author of Secrets of the Temple states in his book that the FED has always acted against the public interest and proves that it was designed to do that from the very beginning: "At the time the conventional wisdom in Congress was that the government institution would finally harness the money trust, disarm its powers and establish broad democratic control over money and credit. The results were nearly the opposite. The money reforms enacted in 1913 in fact helped to preserve the status quo, to stabilize the old order. Money center bankers would not only gain dominance over the new central bank but would also enjoy new insulation against instability and their own decline. Once the Fed was in operation the steady diffusion of financial power halted. Wall Street maintained its dominant position and even enhanced it."

The Washington DC Banking Cartel and the elite secret societies behind them are covertly working to undermine US citizens and readying them for the day that they will wrench away their few remaining freedoms. The soulless corporate nation which began as American colonies has never changed but disguised itself from the populace after their failure to rid themselves of it. Colonization of the planet continues as the wealth of the many continues to be siphoned off by the 1% to be further utilized to enslave humanity to the whims of their will. The accumulation of this wealth has surpassed material gain and is utilized to purchase power in building their new world order. They are spending it to acquire control over the power centers of society by buying control over politicians, political parties, television networks, cable networks, newspapers, magazines,

publishing houses, wire services, motion picture studios, universities, labor unions, church organizations, trade associations, tax-exempt foundations, multi-national corporations, boy scouts, girl scouts etc. etc... The DC Banking Cartel is accomplishing this consolidation of power into the hands of the few with fiat currency! Washington DC are the leaders of a "free world" being operated by corporate governance with independent agencies which operate covertly regardless of the wish of the people. It's a machine utilized to profit off of people as property in a myriad of ways as possible. With a clandestine apparatus exploiting, watching, listening and spying on citizens; which answer to the will of bankers and elite class only; threatened by a potentially rebellious populace which they're unaccountable to as the sovereign volition of man is compromised.

Constitutional Crisis

The Ottawa Initiative on Haiti was a conference hosted by Canada that took place on January 31 to February 1 2003, at Meech Lake, Quebec (a federal government resort near Ottawa) to decide the future of Haiti's government, though no Haitian government officials were invited. The conference was attended by Canadian, French, U.S. and Latin American officials. This is appropriate to the Berlin Conference of 1881 where European nations gathered in order to carve the wealth of Africa up for themselves. The US is no longer operating in a sovereign capacity under the Constitutional Republic yet with the assistance of Canada and France under the Ottawa Initiative have been amending the 1987 Constitution of Haiti in order to steal the Natural Resources of Haiti. The world renowned Haitian scientist Dr. Daniel Mathurin, was the first person to write, speak and educate the Haitian people about Haiti's natural resources. There is evidence that the United States found oil in Haiti decades ago and due to the geopolitical circumstances and big business interests of that era made the decision to keep Haitian oil in reserve for when Middle Eastern oil had dried up. These deposits are declared strategic reserves of the United States of America which is illegal because Haiti is a cooperative nation and its resources are owned by the people. The Va Co owns most of what we now call USA and any lands up to 100 miles offshore including Bermuda and most of the Caribbean except Haiti. The US which operates under the Doctrine of Discovery has claimed Haiti's natural resources for itself under the Monroe Doctrine. Haiti's oil deposits valued at 200 billion were discovered by world renowned Haitian scientist Dr. Daniel Mathurin and are declared U.S. strategic reserves. It is a violation of International Law; Sovereignty of Nations; the Haitian Constitution; and UN charter art 2 point 1 for US to claim Haiti's Natural Resources for itself. The US occupation of Haiti is hidden behind a humanitarian invasion of MINUSTAH, DynCorps Int, NGO's, Duvalierists and UN in order to destroy Haiti and steal its Natural Resources. The US is subject to customary international law and to the Principles of the Nuremberg Charter.

Washington DC is responsible for the establishment of a kakistocracy in Haiti and have been working to undermine the sovereign independence of Haiti since its inception in violation of the Geneva Convention, Magna Carta, the Nuremberg Charter, The UN Declaration of the Rights of the Child, the UN Universal Declaration of Human Rights, Tort Law, Gross Negligence. For every right there is a remedy, where there is no remedy, there is no right. **The nature of the reparation**

to be made for the breach of UNSCR 940; UNSCR 1542; UNSCR 1892 and international obligations in conformity with Article 36(2) of the Statute of that Court:

A. UNSCR 940 "Uphold Democracy" code name Dragon's Blood was actually a clandestine incursion by Washington DC for the utilization of Haiti as a drug transshipment point. What makes this matter even worse is that Washington DC policy kept Haiti in a state of poverty while they made billions therefore Haiti calls for; the immediate end to their 26 year occupation and immediate withdrawal of DynCorp Int/US; payment of 250 billion dollars to Haiti by Washington DC for this use.

B. The covert use of HAARP by DynCorp Int and U.S. Southern Command SOUTHCOM during Complex Command and Control Emergency Relief Drills on January 11 2010 which caused the 7.2 earthquake resulting in 300,000 deaths and leaving millions homeless in Haiti. Even the remote possibility of the clandestine use of HAARP as a Weapon of Mass Destruction by the US on unsuspecting populations needs to be investigated and regulated by the UN.

C. Immediate Injunctive Relief on the Government of Haiti, President Moise and his administration for the illegal use and misappropriation of Petrocaribe funds. President Moise illegally used Petrocaribe money to start-up his export business Agritrans S.A. and purchase a banana plantation for smuggling drugs. Ex president Michel Martely gave 27 million of Petrocaribe funds and a land grant of 1,000 acres to Jovenel Moise for Agritrans S.A.,. The Clintons brought the Tet Kale Party to power in Haiti through fraudulent elections in order to maintain a Narco-State placed during operation "Uphold Democracy".

D. The prosecution of UN Special Envoy to Haiti William J Clinton for the misappropriation of 14 billion in IHRC funds. The UN is responsible for the return of these missing funds to Haiti under the Doctrine of Superior. Therefore 50 billion dollars in restitution to the government of the Republic of Haiti by Washington DC/UN for all the damages it has caused to Haiti since the earthquake of 2010.

E. The presence of cholera in Haiti is due to the US/UN occupation which allowed DynCorp Int to contract Nepalese soldiers, who spread the epidemic. This follows their pattern of destruction in Haiti since the beginning of their occupation. For this violation and the resulting casualties Haiti demands 1 billion in reparations from DynCorp Int.

F. A Human Rights Commission to investigate atrocities committed by the Washington DC backed government/Duvalier regime against the Fanmi-Lavalas Party during their 26 year occupation.

G. The immediate end to the Washington DC/UN occupation of Haiti and an Independent Haiti Reconstruction Commission led by the author of this document, USMC Vet Marc Pierre, and funded by the UN which will work to help Haiti recover from Jan 12, 2010 and establish a true stable government of the people of.

This declaration is effective immediately

This declaration shall be valid for a period of 50 months and shall be understood to be tacitly renewed for like periods, unless withdrawn not less than 6 months before the expiry of any such period by notice given to the Secretary General of the United Nations.
